COMMITTEE SUBSTITUTE

An Act relating to the Oklahoma Workforce Commission;
making an appropriation; identifying source;
establishing an amount; providing purpose; and
declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the Oklahoma
Workforce Commission from any monies not otherwise appropriated from
the Workforce Coordination Revolving Fund, established in Section
255.4 of Title 62 of the Oklahoma Statutes, the sum of Six Hundred
Thirty-six Thousand Eight Hundred Two Dollars (\$636,802.00) or so
much thereof as may be necessary for administrative costs of the
Oklahoma Workforce Commission.

SECTION 2. It being immediately necessary for the preservation
of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
