19	255.4), is amended to read as follows:
20	Section 255.4. A. There is hereby created in the State
21	Treasury a revolving fund for the Oklahoma Department of Commerce to
22	be designated the "Workforce Coordination Revolving Fund". The fund
23	shall be a continuing fund, not subject to fiscal year limitations,
24	and shall consist of all monies directed for deposit by law.
