15 AMENDMENT NO. 1. Page 1, strike the title, enacting clause and
16 entire bill and insert

17 "An Act relating to schools; creating Alyssa's Law;
18 providing short title; requiring school districts to
19 implement certain alert system by certain school
20 year; establishing system requirements; stating
legislative intent that certain funds be used for
implementation; providing for codification; providing
an effective date; and declaring an emergency.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 SECTION 1. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 5-149.4 of Title 70, unless
3 there is created a duplication in numbering, reads as follows:

4 A. This act shall be known and may be cited as "Alyssa's Law".

5 B. Beginning with the 2024-2025 school year, each school
6 district in this state shall implement a hardwired or mobile panic
7 alert system. The system shall:

8 1. Connect emergency service technologies to ensure real-time
9 coordination among multiple first responder agencies; and

10 2. Integrate with public safety answering point infrastructure
11 to transmit 9-1-1 calls and mobile activations.

12 C. The State Department of Education shall publish a list of
13 approved hardwired and mobile panic alert systems. At a minimum, an
14 approved school security alert and response system shall:

15 1. Automatically alert designated school personnel when an
16 emergency response is initiated on-site by smartphone application,
17 phone call, text message, or other technology;

18 2. Provide emergency responders with floor plans, caller
19 location, and other information to assist emergency responders
20 during a 9-1-1 call; and

21 3. Integrate designated school personnel with emergency
22 responders to provide real-time situational updates during an
23 emergency.

1 D. It is the intent of the Legislature that the State Board of
2 Education shall use funds appropriated for the support of public
3 school activities to implement the provisions of this section.

4 SECTION 2. This act shall become effective July 1, 2024.

5 SECTION 3. It being immediately necessary for the preservation
6 of the public peace, health, or safety, an emergency is hereby
7 declared to exist, by reason whereof this act shall take effect and
8 be in full force from and after its passage and approval.”

9 2. Provide emergency responders with floor plans, caller

13 responders to provide real-time situational updates during an
14 emergency.

15 SECTION 5. AMENDATORY Section 2, Chapter 281, O.S.L.
16 2023 (70 O.S. Supp. 2023, Section 5-148.2), is amended to read as
17 follows:

18 Section 5-148.2 A. There is hereby created in the State
19 Treasury a revolving fund for the State Department of Education to
20 be designated the "School Security Revolving Fund". The fund shall
21 be a continuing fund, not subject to fiscal year limitations, and
22 shall consist of all monies received by the State Department of
23 Education from:

24

1 1. Reimbursements, grants, or other monies received from other
2 state agencies and entities for school security;

3 2. Reimbursements, grants, or other monies received from the
4 United States government obligated to school security projects;

5 3. Gifts, donations, and bequests; and

6 4. Monies appropriated or apportioned by the Legislature.

7 B. All monies accruing to the credit of the School Security
8 Revolving Fund are hereby appropriated and may be budgeted and
9 expended by the State Department of Education for the purposes of:

10 1. Establishing and maintaining a School Resource Officer
11 Program; and

12 2. Providing physical security enhancements for schools
13 including, but not limited to, school resource officers, cameras,
14 gates, lighting, locks, doors, windows, security geofencing, ~~and~~
15 ballistic storm shelters, and mobile panic alert systems.

16 Monies in the School Security Revolving Fund shall supplement
17 and not supplant existing school security funding.

18 C. Expenditures from the School Security Revolving Fund shall
19 be made upon warrants issued by the State Treasurer against claims
20 filed as prescribed by law with the Director of the Office of
21 Management and Enterprise Services for approval and payment.

22 Expenditures from the School Security Revolving Fund shall not
23 exceed Fifty Million Dollars (\$50,000,000.00) in any fiscal year and
24

1 shall be divided equally among every public school district in the
2 state.

3 SECTION 6. This act shall become effective July 1, 2024.

4 SECTION 7. It being immediately necessary for the preservation
5 of the public peace, health or safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
