10 COMMITTEE SUBSTITUTE

11 An Act relating to the Oklahoma Capitol Improvement  
12 Authority; providing for allocation of funds from the  
13 Legacy Capital Financing Fund; authorizing  
14 utilization of certain amount for the purpose of  
15 benefitting the Oklahoma State Bureau of  
16 Investigation; requiring certain recapitalization  
17 payments; authorizing certain distributions;  
18 authorizing and limiting utilization of memoranda of  
19 understanding; providing for codification; providing  
20 an effective date; and declaring an emergency.

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. NEW LAW A new section of law to be codified  
23 in the Oklahoma Statutes as Section 187A-11 of Title 73, unless  
24 there is created a duplication in numbering, reads as follows:

A. In addition to any other authorization provided by law, the  
Oklahoma Capitol Improvement Authority is authorized to utilize  
available funds from the Legacy Capital Financing Fund created by

1 Section 187B of Title 73 of the Oklahoma Statutes, in the amount of  
2 Twenty-seven Million Five Hundred Thousand Dollars (\$27,500,000.00)  
3 for the benefit of the Oklahoma State Bureau of Investigation to  
4 construct, refurbish, or expand the Oklahoma State Bureau of  
5 Investigation headquarters and related facilities.

6 B. LCF Recapitalization Payments shall be made related to the  
7 distribution of proceeds provided in subsection A of this section,  
8 in accordance with the provisions of the Legacy Capital Financing  
9 Act.

10 C. The Authority may distribute funds authorized pursuant to  
11 subsection A of this section in one or more tranches.

12 D. The Authority may enter memoranda of understanding with  
13 agencies, departments, and subdivisions of the state as needed, to  
14 facilitate the provisions of this act, provided that such memoranda  
15 of understanding do not constitute a legal obligation of the State  
16 of Oklahoma or impede the administration of the provisions of the  
17 Legacy Capital Financing Act.

18 SECTION 2. This act shall become effective July 1, 2024.

19 SECTION 3. It being immediately necessary for the preservation  
20 of the public peace, health or safety, an emergency is hereby  
21
