9 An Act relating to the Oklahoma Open Records Act;
10 amending 51 O.S. 2021, Sections 24A.3, as last
11 amended by Section 11, Chapter 271, O.S.L. 2023,
12 24A.5, as amended by Section 5, Chapter 332, O.S.L.
13 2023, and 24A.17 (51 O.S. Supp. 2023, Sections 24A.3
14 and 24A.5), which relate to public records; reducing
15 the list of things defined as non-records; increasing
16 the types of confidential records; prescribing a
17 deadline to notify of intent to file suit for denied
18 record access; and providing an effective date.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. AMENDATORY 51 O.S. 2021, Section 24A.3, as
21 last amended by Section 11, Chapter 271, O.S.L. 2023 (51 O.S. Supp.
22 2023, Section 24A.3), is amended to read as follows:

23 Section 24A.3 As used in the Oklahoma Open Records Act:

24 1. "Record" means all documents including, but not limited to,
any book, paper, photograph, microfilm, data files created by or
used with computer software, computer tape, disk, record, sound
recording, film recording, video record or other material regardless

1 of physical form or characteristic, created by, received by, under
2 the authority of, or coming into the custody, control or possession
3 of public officials, public bodies or their representatives in
4 connection with the transaction of public business, the expenditure
5 of public funds or the administering of public property. Record
6 does not mean:

- 7 a. computer software, or
- 8 b. nongovernment personal effects,i
- 9 ~~c. unless public disclosure is required by other laws or~~
10 ~~regulations, vehicle movement records of the Oklahoma~~
11 ~~Transportation Authority obtained in connection with~~
12 ~~the Authority's electronic toll collection system,~~

9 2. "Public body" shall include, but not be limited to, any
10 office, department, board, bureau, commission, agency, trusteeship,
11 authority, council, committee, trust or any entity created by a
12 trust, county, city, village, town, township, district, school
13 district, fair board, court, executive office, advisory group, task
14 force, study group or any subdivision thereof, supported in whole or
15 in part by public funds or entrusted with the expenditure of public
16 funds or administering or operating public property, and all
17 committees, or subcommittees thereof. Except for the records
18 required by Section 24A.4 of this title, public body does not mean
19 judges, justices, the Council on Judicial Complaints, the
20 Legislature or legislators. Public body shall not include an
21 organization that is exempt from federal income tax under Section
22 501(c) (3) of the Internal Revenue Code of 1986, as amended, and
23 whose sole beneficiary is a college or university, or an affiliated
24 entity of the college or university, that is a member of The

1 Oklahoma State System of Higher Education. Such organization shall
2 not receive direct appropriations from the Oklahoma Legislature.
3 The following persons shall not be eligible to serve as a voting
4 member of the governing board of the organization:

5 a. a member, officer, or employee of the Oklahoma State
6 Regents for Higher Education,

7 b. a member of the board of regents or other governing
8 board of the college or university that is the sole
9 beneficiary of the organization, or

10 c. an officer or employee of the college or university
11 that is the sole beneficiary of the organization;

12 3. "Public office" means the physical location where public
13 bodies conduct business or keep records;

14 4. "Public official" means any official or employee of any
15 public body as defined herein; and

16 5. "Law enforcement agency" means any public body charged with
17 enforcing state or local criminal laws and initiating criminal
18 prosecutions including, but not limited to, police departments,
19 county sheriffs, the Department of Public Safety, the Oklahoma State
20 Bureau of Narcotics and Dangerous Drugs Control, the Alcoholic
21 Beverage Laws Enforcement Commission, and the Oklahoma State Bureau
22 of Investigation.

1 SECTION 2. AMENDATORY 51 O.S. 2021, Section 24A.5, as
2 amended by Section 5, Chapter 332, O.S.L. 2023 (51 O.S. Supp. 2023,
3 Section 24A.5), is amended to read as follows:

4 Section 24A.5 All records of public bodies and public officials
5 shall be open to any person for inspection, copying, or mechanical
6 reproduction during regular business hours; provided:

7 1. The Oklahoma Open Records Act, Sections 24A.1 through 24A.30
8 of this title, does not apply to records specifically required by
9 law to be kept confidential including:

- 10 a. records protected by a state evidentiary privilege
11 such as the attorney-client privilege, the work
12 product immunity from discovery and the identity of
13 informer privileges,
- 14 b. records of what transpired during meetings of a public
15 body lawfully closed to the public such as executive
16 sessions authorized under the Oklahoma Open Meeting
17 Act,
- 18 c. personal information within driver records as defined
19 by the Driver's Privacy Protection Act, 18 United
20 States Code, Sections 2721 through 2725,
- 21 d. information in the files of the Board of Medicolegal
22 Investigations obtained pursuant to Sections 940 and
23 941 of Title 63 of the Oklahoma Statutes that may be
24

- 1 hearsay, preliminary unsubstantiated investigation-
2 related findings, or confidential medical information,
3 e. any test forms, question banks and answer keys
4 developed for state licensure examinations, but
5 specifically excluding test preparation materials or
6 study guides, or
7 f. last names, addresses, social security numbers or tax
8 identification numbers, and proof of identification
9 submitted to the Oklahoma Lottery Commission by
10 persons claiming a lottery prize;
11 g. unless public disclosure is required by other laws or
12 regulations, vehicle movement records of the Oklahoma
13 Transportation Authority obtained in connection with
14 the Authority's electronic toll collection system,
15 h. personal financial information, credit reports, or
16 other financial data obtained by or submitted to a
17 public body for the purpose of evaluating credit
18 worthiness, obtaining a license, permit, or for the
19 purpose of becoming qualified to contract with a
20 public body,
21 i. any digital audio/video recordings of the toll
22 collection and safeguarding activities of the Oklahoma
23 Transportation Authority,
24

1 j. any personal information provided by a guest at any
2 facility owned or operated by the Oklahoma Tourism and
3 Recreation Department to obtain any service at the
4 facility or by a purchaser of a product sold by or

1 applicant's personal address, personal phone number,
2 personal electronic mail address, any government-
3 issued identification numbers, or other contact
4 information; provided, however, lists of persons
5 licensed, the existence of a license of a person, or a
6 business or commercial address, or other business or
7 commercial information disclosable under state law
8 submitted with an application for licensure shall be
9 public record, unless the business or commercial
10 address is the same as the applicant's personal
11 address, except when the applicant permits in writing
12 the disclosure of the address, or

13 n. an investigative file obtained during an investigation
14 conducted by the State Department of Health into
15 violations of the Long-Term Care Administrator Act
16 under Title 63 of the Oklahoma Statutes,

17 o. documents, evidence, materials, records, reports,
18 complaints or other information in the possession or
19 control of the Attorney General or Insurance
20 Department pertaining to an evaluation, examination,
21 investigation or review made pursuant to the
22 provisions of the Patient's Right to Pharmacy Choice
23 Act, the Pharmacy Audit Integrity Act or Sections 357
24 through 360 of Title 59 of the Oklahoma Statutes;

1 2. All Social Security numbers included in a record may be
2 confidential regardless of the person's status as a public employee
3 or private individual and may be redacted or deleted prior to
4 release of the record by the public body;

5 3. Any reasonably segregable portion of a record containing
6 exempt material shall be provided after deletion of the exempt
7 portions; provided however, the Department of Public Safety shall
8 not be required to assemble for the requesting person specific
9 information, in any format, from driving records relating to any
10 person whose name and date of birth or whose driver license number
11 is not furnished by the requesting person.

12 The Oklahoma State Bureau of Investigation shall not be required
13 to assemble for the requesting person any criminal history records
14 relating to persons whose names, dates of birth, and other
15 identifying information required by the Oklahoma State Bureau of
16 Investigation pursuant to administrative rule are not furnished by
17 the requesting person;

18 4. Any request for a record which contains individual records
19 of persons, and the cost of copying, reproducing or certifying each
20 individual record is otherwise prescribed by state law, the cost may
21 be assessed for each individual record, or portion thereof requested
22 as prescribed by state law. Otherwise, a public body may charge a
23 fee only for recovery of the reasonable, direct costs of record
24 copying, or mechanical reproduction. Notwithstanding any state or

1 local provision to the contrary, in no instance shall the record
2 copying fee exceed twenty-five cents (\$0.25) per page for records
3 having the dimensions of eight and one-half (8 1/2) by fourteen (14)
4 inches or smaller, or a maximum of One Dollar (\$1.00) per copied
5 page for a certified copy. However, if the request:

- 6 a. is solely for commercial purpose, or
- 7 b. would clearly cause excessive disruption of the
8 essential functions of the public body,

9 then the public body may charge a reasonable fee to recover the
10 direct cost of record search and copying; however, publication in a
11 newspaper or broadcast by news media for news purposes shall not
12 constitute a resale or use of a record for trade or commercial
13 purpose and charges for providing copies of electronic data to the
14 news media for a news purpose shall not exceed the direct cost of
15 making the copy. The fee charged by the Department of Public Safety
16 for a copy in a computerized format of a record of the Department
17 shall not exceed the direct cost of making the copy unless the fee
18 for the record is otherwise set by law.

19 Any public body establishing fees under this act shall post a
20 written schedule of the fees at its principal office and with the
21 county clerk.

22 In no case shall a search fee be charged when the release of
23 records is in the public interest, including, but not limited to,
24 release to the news media, scholars, authors and taxpayers seeking

1 to determine whether those entrusted with the affairs of the
2 government are honestly, faithfully, and competently performing
3 their duties as public servants.

4 The fees shall not be used for the purpose of discouraging
5 requests for information or as obstacles to disclosure of requested
6 information;

7 5. The land description tract index of all recorded instruments
8 concerning real property required to be kept by the county clerk of
9 any county shall be available for inspection or copying in
10 accordance with the provisions of the Oklahoma Open Records Act;
11 provided, however, the index shall not be copied or mechanically
12 reproduced for the purpose of sale of the information;

13 6. A public body must provide prompt, reasonable access to its
14 records but may establish reasonable procedures which protect the
15 integrity and organization of its records and to prevent excessive
16 disruptions of its essential functions. A delay in providing access
17 to records shall be limited solely to the time required for
18 preparing the requested documents and the avoidance of excessive
19 disruptions of the public body's essential functions. In no event
20 may production of a current request for records be unreasonably
21 delayed until after completion of a prior records request that will
22 take substantially longer than the current request. Any public body
23 which makes the requested records available on the Internet shall

24

1 meet the obligation of providing prompt, reasonable access to its
2 records as required by this paragraph; and

3 7. A public body shall designate certain persons who are
4 authorized to release records of the public body for inspection,
5 copying, or mechanical reproduction. At least one person shall be
6 available at all times to release records during the regular
7 business hours of the public body.

8 SECTION 3. AMENDATORY 51 O.S. 2021, Section 24A.17, is
9 amended to read as follows:

10 Section 24A.17 A. Any public official who willfully violates
11 any provision of the Oklahoma Open Records Act, upon conviction,
12 shall be guilty of a misdemeanor, and shall be punished by a fine
13 not exceeding Five Hundred Dollars (\$500.00) or by imprisonment in
14 the county jail for a period not exceeding one (1) year, or by both
15 such fine and imprisonment.

16 B. Any person who requests and is denied access to records of a
17 public body or public official:

18 1. May bring a civil suit for declarative or injunctive relief,
19 or both, but such civil suit shall be limited to records requested
20 and denied prior to filing of the civil suit; and

21 2. If successful, shall be entitled to reasonable attorney
22 fees.

23 C. Prior to bringing a civil suit under subsection B, any
24 person seeking declaratory or injunctive relief, or both, must

1 notify the public body or public official of his or her intent to
2 bring a civil suit to obtain relief in writing ten (10) business
3 days prior to filing for such relief.

4 ~~C.~~ D. If the public body or public official successfully
5 defends a civil suit and the court finds that the suit was clearly
6 frivolous, the public body or public official shall be entitled to
7 reasonable attorney fees.

8 ~~D.~~ E. A public body or public official shall not be civilly
9 liable for damages for providing access to records as allowed under
10 the Oklahoma Open Records Act.

11 SECTION 4. This act shall become effective November 1, 2024.
