6 AS INTRODUCED

7 An Act relating to oil and gas; requiring disclosure
8 with respect to content of certain motor fuels;
9 prescribing requirements related to signage;
10 providing for codification; and providing an
11 effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 347-1 of Title 52, unless there
15 is created a duplication in numbering, reads as follows:

16 Section 347-1 A. No person shall sell or offer for sale motor
17 fuel from a motor fuel pump supplied by a storage tank into which
18 motor fuel that contains a mixture of at least one percent (1%) by
19 volume of ethanol or methanol has been delivered within the sixty-
20 day period preceding the date of sale or offer of sale unless the
21 person prominently displays on the pump from which the mixture is
22 sold a label that complies with subsection B of this section.

23 B. A label as required in subsection A of this section shall:
24

1 1. Be displayed on each face of the motor fuel pump on which
2 the price of the motor fuel mixture sold from the pump is displayed;

3 2. State "Contains Ethanol" or "Contains Methanol", as
4 applicable;

5 3. Appear in contrasting colors with block letters at least
6 one-half (1/2) inch high and one-fourth (1/4) inch wide; and

7 4. Be displayed in a clear, conspicuous, and prominent manner,
8 visible to customers using either side of the pump.

9 C. If a motor fuel pump is supplied by a storage tank into
10 which motor fuel containing at least ten percent (10%) ethanol by
11 volume or at least five percent (5%) methanol by volume is delivered
12 in the sixty-day period preceding the date of the sale or offer of
13 sale, the sign as required in subsection A of this section shall
14 also state the percentage of ethanol or methanol by volume, to the
15 nearest whole percent, of the motor fuel having the highest
16 percentage of ethanol or methanol delivered into that storage tank
17 during that period.

18 D. On request by a motor fuel user, a person selling or
19 offering for sale motor fuel from a motor fuel pump shall reveal:

20 1. The percentage of ethanol contained in the motor fuel being
21 sold. If the motor fuel contains fifteen percent (15%) ethanol, a
22 pump label is required which meets federal E15 labeling requirements
23 as finalized by the United States Environmental Protection Agency on
24 August 24, 2011;

1 2. The percentage of methanol contained in the motor fuel being
2 sold; and

3 3. If the motor fuel contains methanol, the types and
4 percentages of associated cosolvents contained in the motor fuel
5 being sold.

6 E. The provisions of this section shall not prohibit the
7 posting of any other alcohol or additive information. Other alcohol
8 or additive information and any relevant posting shall be subject to
9 regulation by the Corporation Commission.

10 F. The Corporation Commission shall promulgate rules as
11 necessary to implement the provisions of this section.

12 SECTION 2. This act shall become effective November 1, 2023.
