11 An Act relating to school security; making an
12 appropriation; establishing an amount; identifying a
13 funding source; providing purpose; providing for
14 noncodification; providing an effective date; and
15 declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. NEW LAW A new section of law not to be
18 codified in the Oklahoma Statutes reads as follows:

19 There is hereby appropriated to the School Security Revolving
20 Fund, created by Enrolled House Bill No. 2903 of the 1st Session of
21 the 59th Oklahoma Legislature, from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2022, the sum of One Hundred Fifty
24 Million Dollars (\$150,000,000.00) or so much thereof as may be

1 necessary to cover costs associated with implementing the provisions
2 of Enrolled House Bill No. 2903 of the 1st Session of the 59th
3 Oklahoma Legislature.

4 SECTION 2. This act shall become effective July 1, 2023.

5 SECTION 3. It being immediately necessary for the preservation
6 of the public peace, health or safety, an emergency is hereby
7 declared to exist, by reason whereof this act shall take effect and
8 be in full force from and after its passage and approval.
