10 COMMITTEE SUBSTITUTE

11 An Act relating to the Office of Management and
12 Enterprise Services; making an appropriation;
13 prescribing expenditures; providing an effective
14 date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Office of
17 Management and Enterprise Services from any monies not otherwise
18 appropriated from the Oklahoma Capital Assets Maintenance and
19 Protection Fund of the State Treasury, the sum of Fifty-six Million
20 Two Hundred Fifty Thousand Dollars (\$56,250,000.00) or so much
21 thereof as may be necessary to perform the duties imposed upon the
22 Office of Management and Enterprise Services by law.

23 SECTION 2. The funds appropriated pursuant to Section 1 of this
24 act shall be expended pursuant to a plan submitted by the Office of

1 Management and Enterprise Services not later than May 31, 2024, to
2 the Chair of the Appropriations Committee of the Oklahoma State
3 Senate and the Chair of the Appropriations and Budget Committee of
4 the Oklahoma House of Representatives.

5 SECTION 3. This act shall become effective July 1, 2024.

6 SECTION 4. It being immediately necessary for the preservation
7 of the public peace, health or safety, an emergency is hereby
8 declared to exist, by reason whereof this act shall take effect and
9 be in full force from and after its passage and approval.
