11 An Act relating to the classification of felony  
12 offenses; creating the Oklahoma Sentencing  
13 Modernization Act of 2024; establishing a  
14 classification system for felony criminal offenses;  
15 stating specific classifications; providing list of  
16 felony criminal offenses for each class; providing  
17 punishment provisions for each class of felony  
18 offenses; authorizing the inclusion of time-served  
19 requirements on jury instructions for criminal  
20 trials; requiring inclusion of percentage amounts;  
21 providing for codification; and providing an  
22 effective date.

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24 SECTION 1. NEW LAW A new section of law to be codified  
in the Oklahoma Statutes as Section 20A of Title 21, unless there is  
created a duplication in numbering, reads as follows:

A. This act shall be known and may be cited as the "Oklahoma  
Sentencing Modernization Act of 2024".

1 B. There is hereby established a classification system for all  
2 felony criminal offenses provided for in the Oklahoma Statutes that  
3 places the offenses into classes on the basis of the severity of the  
4 offense and other factors of the commission of the crime. All  
5 felonies provided for by the Oklahoma Statutes shall be classified  
6 in the following manner:

7 1. "Class Y" is reserved for the crime of murder in the first  
8 degree as defined by Section 701.7 of Title 21 of the Oklahoma  
9 Statutes; and

10 2. "Class A1", "Class A2", "Class A3", "Class B1", "Class B2",  
11 "Class B3", "Class B4", "Class B5", "Class B6", "Class C1", "Class  
12 C2", "Class D1", "Class D2", and "Class D3" are reserved for all  
13 other violent and nonviolent felony offenses.

14 SECTION 2. NEW LAW A new section of law to be codified  
15 in the Oklahoma Statutes as Section 20B of Title 21, unless there is  
16 created a duplication in numbering, reads as follows:

17 A. Upon the effective date of this act, Class Y shall include  
18 the following criminal offenses:

19 1. Murder in the first degree as provided for in subsection A  
20 of Section 701.7 of Title 21 of the Oklahoma Statutes;

21 2. Murder in the first degree during the commission of a crime,  
22 as provided for in subsection B of Section 701.7 of Title 21 of the  
23 Oklahoma Statutes;

24

1           3. Murder in the first degree when the death of a child results  
2 from willful or malicious injuring, torturing, maiming, or using  
3 unreasonable force, as provided for in subsection C of Section 701.7  
4 of Title 21 of the Oklahoma Statutes;

5           4. Murder in the first degree when the person solicits another  
6 to cause the death of another human being in furtherance of  
7 unlawfully manufacturing, distributing, or dispensing a controlled  
8 dangerous substance, as provided for in subsection D of Section  
9 701.7 of Title 21 of the Oklahoma Statutes;

10          5. Murder in the first degree when the person intentionally  
11 causes the death of a law enforcement officer, as provided for in  
12 subsection E of Section 701.7 of Title 21 of the Oklahoma Statutes;  
13 and

14          6. Murder in the first degree when a person kills another  
15 person or causes the death of another human being in the commission  
16 of an act of terrorism, as provided for in subsection C of Section  
17 1268.2 of Title 21 of the Oklahoma Statutes.

18          B. Any person convicted of a Class Y criminal offense set forth  
19 in this section shall be punished in accordance with the  
20 corresponding penalties provided for in the Oklahoma Statutes.

21          SECTION 3.        NEW LAW        A new section of law to be codified  
22 in the Oklahoma Statutes as Section 20C of Title 21, unless there is  
23 created a duplication in numbering, reads as follows:

24

1       A. Upon the effective date of this act, Class A1 shall include  
2 the following criminal offenses:

3       1. Domestic abuse committed against a pregnant woman with  
4 knowledge of the pregnancy and a miscarriage occurs or injury to the  
5 unborn child, as provided for in subsection E of Section 644 of  
6 Title 21 of the Oklahoma Statutes;

7       2. Administering poison with intent to kill, as provided for in  
8 Section 651 of Title 21 of the Oklahoma Statutes;

9       3. Second degree murder, as provided for in paragraph 1 of  
10 Section 701.8 of Title 21 of the Oklahoma Statutes;

11       4. Second degree murder by a person engaged in the commission  
12 of a felony, as provided for in paragraph 2 of Section 701.8 of  
13 Title 21 of the Oklahoma Statutes;

14       5. Kidnapping for the purpose of extorting money, as provided  
15 for in subsection A of Section 745 of Title 21 of the Oklahoma  
16 Statutes;

17       6. Sexual abuse of a child under twelve (12) years of age, as  
18 provided for in subsection F of Section 843.5 of Title 21 of the  
19 Oklahoma Statutes;

20       7. Sexual exploitation of a child under twelve (12) years of  
21 age, as provided for in subsection I of Section 843.5 of Title 21 of  
22 the Oklahoma Statutes;

23       8. Sexual abuse of a child under fourteen (14) years of age  
24 subsequent to a previous conviction of sexual abuse of a child under

1 fourteen (14) years of age, as provided for in subsection K of  
2 Section 843.5 of Title 21 of the Oklahoma Statutes;

3 9. Soliciting or aiding a minor to perform an obscene act, as  
4 provided for in paragraph 1 of subsection B of Section 1021 of Title  
5 21 of the Oklahoma Statutes;

6 10. Showing, exhibiting, loaning, or distributing to a minor  
7 child obscene material or child pornography for purposes of inducing  
8 the minor to participate in an obscene act, as provided for in  
9 paragraph 2 of subsection B of Section 1021 of Title 21 of the  
10 Oklahoma Statutes;

11 11. Murder, maiming, robbery, rape, or arson committed in the  
12 course of a riot, as provided for in paragraph 1 of Section 1312 of  
13 Title 21 of the Oklahoma Statutes;

14 12. Burglary by the aid or use of any explosive, as provided  
15 for in Section 1441 of Title 21 of the Oklahoma Statutes;

16 13. Place, manufacture, possess, display, or threaten to use  
17 any explosive or incendiary device and personal injury results, as  
18 provided for in Section 1767.1 of Title 21 of the Oklahoma Statutes;

19 14. Aggravated manufacturing a controlled dangerous substance,  
20 as provided for in paragraph 3 of subsection G of Section 2-401 of  
21 Title 63 of the Oklahoma Statutes; and

22 15. Using any explosive or blasting agent to kill, injure, or  
23 intimidate any person or to damage any real or personal property and  
24

1 personal injury results, as provided for in subsection B of Section  
2 124.8 of Title 63 of the Oklahoma Statutes.

3 B. Any person convicted of a Class A1 criminal offense set  
4 forth in this section shall be punished in accordance with the  
5 corresponding penalties provided for in the Oklahoma Statutes.

6 SECTION 4. NEW LAW A new section of law to be codified  
7 in the Oklahoma Statutes as Section 20D of Title 21, unless there is  
8 created a duplication in numbering, reads as follows:

9 A. Upon the effective date of this act, Class A2 shall include  
10 the following criminal offenses:

11 1. Accessory to murder in the first degree, as provided for in  
12 paragraph 5 of Section 175 of Title 21 of the Oklahoma Statutes;

13 2. Aggravated assault and battery upon a police officer,  
14 sheriff, deputy sheriff, highway patrolman, corrections personnel,  
15 or any state peace officer that results in maiming, as provided for  
16 in subsection B of Section 650 of Title 21 of the Oklahoma Statutes;

17 3. Solicitation for murder in the first degree, as provided for  
18 in Section 701.16 of Title 21 of the Oklahoma Statutes;

19 4. Manslaughter in the first degree, as provided for in Section  
20 711 of Title 21 of the Oklahoma Statutes;

21 5. Administration of poison, drug, or medicine by an  
22 intoxicated physician to another person that causes the death of  
23 such other person, as provided for in Section 712 of Title 21 of the  
24 Oklahoma Statutes;



1       6. Aiding, assisting, or participating in the receipt,  
2 possession, or exchange of money or thing of value from the  
3 kidnapped person, as provided for in subsection B of Section 745 of  
4 Title 21 of the Oklahoma Statutes;

5       7. Human trafficking for labor or commercial sex, as provided  
6 for in subsection C of Section 748 of Title 21 of the Oklahoma  
7 Statutes;

8       8. Female genital mutilation, as provided for in Section 760 of  
9 Title 21 of the Oklahoma Statutes;

10       9. Robbery in the first degree, as provided for in Section 798  
11 of Title 21 of the Oklahoma Statutes;

12       10. Conjoint robbery committed by two or more persons, as  
13 provided for in Section 800 of Title 21 of the Oklahoma Statutes;

14       11. Robbery or attempted robbery with a dangerous weapon or  
15 imitation firearm, as provided for in Section 801 of Title 21 of the  
16 Oklahoma Statutes;

17       12. Wiring or equipping vehicles or structures with explosive  
18 materials, things, or devices with intent to cause bodily injury or  
19 death to another person, as provided for in Section 849 of Title 21  
20 of the Oklahoma Statutes;

21       13. Aggravated possession of child pornography, as provided for  
22 in Section 1040.12a of Title 21 of the Oklahoma Statutes;

23       14. Rape by instrumentation, as provided for in Section 1111.1  
24 of Title 21 of the Oklahoma Statutes;

1       15. Rape in the first degree, as provided for in subsection A  
2 of Section 1114 of Title 21 of the Oklahoma Statutes;

3       16. Compelling a woman to marry another person against her will  
4 by force, menace, or duress, as provided for in Section 1117 of  
5 Title 21 of the Oklahoma Statutes;

6       17. Maliciously, wantonly, or negligently removing, injuring,  
7 or destroying any railroad or railroad equipment that results in the  
8 death of another human being, as provided for in Section 1752 of  
9 Title 21 of the Oklahoma Statutes;

10       18. Resisting or aiding in resisting the execution of process  
11 during a state of riot or insurrection, as provided for in Section  
12 107 of Title 22 of the Oklahoma Statutes;

13       19. Driving under the influence of alcohol or other  
14 intoxicating substance after a previous conviction of murder in the  
15 second degree or manslaughter in the first degree where a death was  
16 caused as a result of driving under the influence of alcohol or  
17 other intoxicating substance, as provided for in paragraph 5 of  
18 subsection C of Section 11-902 of Title 47 of the Oklahoma Statutes;

19       20. Manufacturing or attempting to manufacture any controlled  
20 dangerous substance or the possession of certain substances, as  
21 provided for in paragraph 2 of subsection G of Section 2-401 of  
22 Title 63 of the Oklahoma Statutes; and

23       21. Robbery or attempted robbery of controlled dangerous  
24 substances from a practitioner, manufacturer, distributor, or agent

1 thereof, as provided for in subsection B of Section 2-403 of Title  
2 63 of the Oklahoma Statutes.

3 B. Any person convicted of a Class A2 criminal offense set  
4 forth in this section shall be punished in accordance with the  
5 corresponding penalties provided for in the Oklahoma Statutes.

6 SECTION 5. NEW LAW A new section of law to be codified  
7 in the Oklahoma Statutes as Section 20E of Title 21, unless there is  
8 created a duplication in numbering, reads as follows:

9 A. Upon the effective date of this act, Class A3 shall include  
10 the following criminal offenses:

11 1. Domestic assault and battery with a deadly weapon, as  
12 provided for in paragraph 2 of subsection D of Section 644 of Title  
13 21 of the Oklahoma Statutes;

14 2. Second or subsequent conviction of domestic abuse against a  
15 pregnant woman with knowledge of the pregnancy, as provided for in  
16 subsection E of Section 644 of Title 21 of the Oklahoma Statutes;

17 3. Aggravated assault and battery upon a police officer,  
18 sheriff, deputy sheriff or highway patrolman, corrections personnel,  
19 or any state peace officer, as provided for in subsection A of  
20 Section 650 of Title 21 of the Oklahoma Statutes;

21 4. Shooting with the intent to kill, as provided for in  
22 subsection A of Section 652 of Title 21 of the Oklahoma Statutes;

23

- 1        5. Using a vehicle to facilitate the intentional discharge of a  
2 firearm, crossbow, or other weapon, as provided for in subsection B  
3 of Section 652 of Title 21 of the Oklahoma Statutes;
- 4        6. Assault and battery with a deadly weapon, as provided for in  
5 subsection C of Section 652 of Title 21 of the Oklahoma Statutes;
- 6        7. Maiming, as provided for in Section 752 of Title 21 of the  
7 Oklahoma Statutes;
- 8        8. Sexual abuse by a caretaker, as provided for in paragraph 2  
9 of subsection B of Section 843.1 of Title 21 of the Oklahoma  
10 Statutes;
- 11       9. Child abuse, as provided for in subsection A of Section  
12 843.5 of Title 21 of the Oklahoma Statutes;
- 13       10. Enabling child abuse, as provided for in subsection B of  
14 Section 843.5 of Title 21 of the Oklahoma Statutes;
- 15       11. Child sexual abuse, as provided for in subsection E of  
16 Section 843.5 of Title 21 of the Oklahoma Statutes;
- 17       12. Enabling child sexual abuse, as provided for in subsection  
18 G of Section 843.5 of Title 21 of the Oklahoma Statutes;
- 19       13. Child sexual exploitation, as provided for in subsection H  
20 of Section 843.5 of Title 21 of the Oklahoma Statutes;
- 21       14. Enabling child sexual exploitation, as provided for in  
22 subsection J of Section 843.5 of Title 21 of the Oklahoma Statutes;  
23  
24

1       15. Lewd or indecent proposals or acts to a child, as provided  
2 for in subsection A of Section 1123 of Title 21 of the Oklahoma  
3 Statutes;

4       16. Terrorism, as provided for in subsection B of Section  
5 1268.2 of Title 21 of the Oklahoma Statutes;

6       17. Conspiracy to commit terrorism, as provided for in  
7 subsection A of Section 1268.3 of Title 21 of the Oklahoma Statutes;

8       18. Any person above the age of eighteen (18) who, on campuses  
9 or public school grounds, advocates revolution, sabotage, force and  
10 violation, sedition, treason, or the overthrow of the United States  
11 government, as provided for in subsection B of Section 1327 of Title  
12 21 of the Oklahoma Statutes;

13       19. Arson in the first degree, as provided for in subsection A  
14 of Section 1401 of Title 21 of the Oklahoma Statutes;

15       20. Arson while manufacturing, attempting to manufacture, or  
16 endeavoring to manufacture a controlled dangerous substance, as  
17 provided for in subsection B of Section 1401 of Title 21 of the  
18 Oklahoma Statutes; and

19       21. Causing personal injury while committing an act of arson,  
20 as provided for in Section 1405 of Title 21 of the Oklahoma  
21 Statutes.

22       B. Any person convicted of a Class A3 criminal offense set  
23 forth in this section shall be punished in accordance with the  
24 corresponding penalties provided for in the Oklahoma Statutes.

1 SECTION 6. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 20F of Title 21, unless there is  
3 created a duplication in numbering, reads as follows:

4 A. Upon the effective date of this act, Class B1 shall include  
5 the following criminal offenses:

6 1. Accessory to murder in the second degree, as provided for in  
7 paragraph 5 of Section 175 of Title 21 of the Oklahoma Statutes;

8 2. Rescuing or attempting to rescue a prisoner charged or  
9 convicted of a felony, as provided for in paragraph 1 of Section 521  
10 of Title 21 of the Oklahoma Statutes;

11 3. Aiding suicide, as provided for in Section 813 of Title 21  
12 of the Oklahoma Statutes;

13 4. Aiding suicide by furnishing the person with deadly weapons  
14 or poisonous drugs, as provided for in Section 814 of Title 21 of  
15 the Oklahoma Statutes;

16 5. Mingling poison, controlled dangerous substances, or sharp  
17 objects harmful to human life with any food, drink, medicine, or  
18 water, as provided for in Section 832 of Title 21 of the Oklahoma  
19 Statutes;

20 6. Abuse, financial neglect, neglect, or exploitation by a  
21 caretaker, as provided for in paragraph 1 of subsection B of Section  
22 843.1 of Title 21 of the Oklahoma Statutes;

23 7. Exploitation of an elderly person or disabled adult, as  
24 provided for in Section 843.4 of Title 21 of the Oklahoma Statutes;

1 8. Engaging in child neglect, as provided for in subsection C  
2 of Section 843.5 of Title 21 of the Oklahoma Statutes;

3 9. Enabling child neglect, as provided for in subsection D of  
4 Section 843.5 of Title 21 of the Oklahoma Statutes;

5 10. Forcible sodomy, as provided for in subsection A of Section  
6 888 of Title 21 of the Oklahoma Statutes;

7 11. Sodomy by a person over eighteen (18) years of age upon a  
8 person under sixteen (16) years of age, as provided for in paragraph  
9 1 of subsection B of Section 888 of Title 21 of the Oklahoma  
10 Statutes;

11 12. Sodomy upon a person incapable through mental illness or  
12 unsoundness of mind to give legal consent, as provided for in  
13 paragraph 2 of subsection B of Section 888 of Title 21 of the  
14 Oklahoma Statutes;

15 13. Sodomy with any person by means of force, violence, or  
16 threats of force or violence, as provided for in paragraph 3 of  
17 subsection B of Section 888 of Title 21 of the Oklahoma Statutes;

18 14. Sodomy upon a person under the legal custody, supervision,  
19 or authority of a state agency, county, municipality, or political  
20 subdivision of the state, as provided for in paragraph 4 of  
21 subsection B of Section 888 of Title 21 of the Oklahoma Statutes;

22 15. Sodomy upon a person at least sixteen (16) years of age but  
23 less than twenty (20) years of age and who is a student of any  
24 public or private secondary school, junior high, high school, or

1 public vocational school with a person eighteen (18) years of age or  
2 older and who is employed by the same school system, as provided for  
3 in paragraph 5 of subsection B of Section 888 of Title 21 of the  
4 Oklahoma Statutes;

5 16. Sodomy upon a person who is unconscious, as provided for in  
6 paragraph 7 of subsection B of Section 888 of Title 21 of the  
7 Oklahoma Statutes;

8 17. Sodomy upon a person who is intoxicated by a narcotic or  
9 anesthetic agent administered by or with the privity of the accused,  
10 as provided for in paragraph 8 of subsection B of Section 888 of  
11 Title 21 of the Oklahoma Statutes;

12 18. Procuring or causing the participation of a minor in child  
13 pornography or possessing, procuring, manufacturing, selling, or  
14 distributing child pornography, as provided for in Section 1021.2 of  
15 Title 21 of the Oklahoma Statutes;

16 19. Permitting or consenting to the participation of a minor in  
17 child pornography by a parent, guardian, or individual having  
18 custody, as provided for in Section 1021.3 of Title 21 of the  
19 Oklahoma Statutes;

20 20. Buying, procuring, or possessing child pornography, as  
21 provided for in Section 1024.2 of Title 21 of the Oklahoma Statutes;

22 21. Child prostitution, as provided for in subsection B of  
23 Section 1029 of Title 21 of the Oklahoma Statutes;

24



1        22. Receiving or offering to agree to receive a child for  
2 purposes of prostitution, as provided for in paragraph 2 of  
3 subsection A of Section 1087 of Title 21 of the Oklahoma Statutes;

4        23. Transporting or aiding in the transport of a child for  
5 prostitution, as provided for in paragraph 3 of subsection A of  
6 Section 1087 of Title 21 of the Oklahoma Statutes;

7        24. Permitting the prostitution of a child in any house,  
8 building, room, other premises, or any conveyances under the control  
9 of a person, as provided for in paragraph 2 of subsection B of  
10 Section 1087 of Title 21 of the Oklahoma Statutes;

11       25. Causing, inducing, persuading, or encouraging a child by  
12 promise, threats, violence, or any device or scheme to engage in  
13 prostitution, as provided for in paragraph 1 of subsection A of  
14 Section 1088 of Title 21 of the Oklahoma Statutes;

15       26. Keeping, holding, detaining, restraining, or compelling a  
16 child to engage in prostitution, as provided for in paragraph 2 of  
17 subsection A of Section 1088 of Title 21 of the Oklahoma Statutes;

18       27. Keeping, holding, detaining, restraining, or compelling a  
19 child to engage in prostitution for purposes of compelling the child  
20 to pay, liquidate, or cancel any debts, dues, or obligations  
21 incurred by the child, as provided for in paragraph 3 of subsection  
22 A of Section 1088 of Title 21 of the Oklahoma Statutes;

23       28. Permitting the keeping, holding, detaining, or restraining  
24 of a child for prostitution in any house, building, room, other

1 premises, or any conveyances under the control of a person, as  
2 provided for in paragraph 2 of subsection B of Section 1088 of Title  
3 21 of the Oklahoma Statutes;

4 29. Advocating the revolution, sabotage, force and violation,  
5 sedition, treason, or overthrow of the government of the United  
6 States, as provided for in Section 1266 of Title 21 of the Oklahoma  
7 Statutes;

8 30. Commit, attempt to commit, or aid in the commission of any  
9 act intended to overthrow, destroy, or alter the government of the  
10 United States, as provided for in Section 1266.4 of Title 21 of the  
11 Oklahoma Statutes;

12 31. Biochemical terrorism, as provided for in subsection D of  
13 Section 1268.2 of Title 21 of the Oklahoma Statutes;

14 32. Biochemical assault when the person knows the substance is  
15 toxic, noxious, or lethal to humans, as provided for in subsection C  
16 of Section 1268.5 of Title 21 of the Oklahoma Statutes;

17 33. Second or subsequent conviction of using a firearm while  
18 committing a felony, as provided for in subsection A of Section 1287  
19 of Title 21 of the Oklahoma Statutes;

20 34. Discharging a firearm or other deadly weapon at or into a  
21 dwelling or building used for public or business purposes, as  
22 provided for in Section 1289.17A of Title 21 of the Oklahoma  
23 Statutes;

24

1       35. Directing, advising, encouraging, or soliciting other  
2 persons to commit acts of force or violence while participating in a  
3 riot, as provided for in paragraph 4 of Section 1312 of Title 21 of  
4 the Oklahoma Statutes;

5       36. Burglary in the first degree, as provided for in Section  
6 1431 of Title 21 of the Oklahoma Statutes;

7       37. Seizing or exercising control of any bus by force or  
8 violence or by threats of force or violence, as provided for in  
9 subsection A of Section 1903 of Title 21 of the Oklahoma Statutes;

10       38. Using a dangerous or deadly weapon while seizing or  
11 exercising control of a bus or when intimidating, threatening,  
12 assaulting, or battering a bus driver, as provided for in subsection  
13 C of Section 1903 of Title 21 of the Oklahoma Statutes;

14       39. Receiving, acquiring, and concealing proceeds derived from  
15 unlawful activities in an amount of more than Fifty Thousand Dollars  
16 (\$50,000.00), as provided for in paragraph 4 of subsection G of  
17 Section 2001 of Title 21 of the Oklahoma Statutes;

18       40. Participating in racketeering activities, as provided for  
19 in subsection A of Section 1403 of Title 22 of the Oklahoma  
20 Statutes;

21       41. Acquiring or maintaining any interest in or control of any  
22 enterprise or real property through racketeering activities, as  
23 provided for in subsection B of Section 1403 of Title 22 of the  
24 Oklahoma Statutes;

1 42. Using or investing any part of proceeds derived from  
2 racketeering activities, as provided for in subsection C of Section  
3 1403 of Title 22 of the Oklahoma Statutes;

4 43. Conspiring with others to commit unlawful racketeering  
5 activities, as provided for in subsection D of Section 1403 of Title  
6 22 of the Oklahoma Statutes;

7 44. Causing an accident resulting in great bodily injury while

17 felony, outlaw, or fugitive from justice, as provided for in  
18 subsection A of Section 440 of Title 21 of the Oklahoma Statutes;

19 4. Preventing or attempting to prevent any person from giving  
20 testimony or producing records or documents, as provided for in  
21 subsection A of Section 455 of Title 21 of the Oklahoma Statutes;

22 5. Threatening physical harm through force or fear or causing  
23 physical harm to any person who provided testimony in any civil or  
24

1 criminal trial or proceeding, as provided for in subsection B of  
2 Section 455 of Title 21 of the Oklahoma Statutes;

3 6. Causing an accident resulting in great bodily injury while  
4 eluding or attempting to elude an officer, as provided for in  
5 subsection C of Section 540A of Title 21 of the Oklahoma Statutes;

6 7. Fighting any duel, as provided for in Section 662 of Title  
7 21 of the Oklahoma Statutes;

8 8. Financial exploitation of an elderly or disabled adult with  
9 funds, assets, or property valued at One Hundred Thousand Dollars  
10 (\$100,000.00) or more, as provided for in paragraph 1 of subsection

12 9. Arson in the third degree by setting fire, burning, or using  
13 explosive devices to burn any property, as provided for in  
14 subsection A of Section 1403 of Title 21 of the Oklahoma Statutes;

16 flammable, explosive, or combustible material or substance in any  
17 building or property with the intent to set fire to or burn the  
18 same, as provided for in subsection B of Section 1404 of Title 21 of

21 provided for in Section 1708 of Title 21 of the Oklahoma Statutes;

1 13. Receiving, acquiring, or concealing proceeds or engaging in  
2 transactions involving proceeds of Ten Thousand Dollars (\$10,000.00)

5 Oklahoma Statutes;

6 14. Making a false affidavit, as provided for in Section 6-302  
7 of Title 47 of the Oklahoma Statutes;

8 15. Using or soliciting the use of services of a minor to  
9 distribute, dispense, transport, or cultivate a controlled dangerous  
10 substance, as provided for in subsection E of Section 2-401 of Title  
11 63 of the Oklahoma Statutes;

12 16. Transporting with intent to distribute or dispense,  
13 distributing, or possessing with intent to distribute a controlled  
14 dangerous substance within two thousand (2,000) feet of a public or  
15 private school, college or university, park, or child care facility,  
16 as provided for in subsection F of Section 2-401 of Title 63 of the  
17 Oklahoma Statutes;

18 17. Acquiring or obtaining possession of a controlled dangerous  
19 substance by a registrant through misrepresentation, fraud, forgery,  
20 deception, or subterfuge, as provided for in paragraph 3 of  
21 subsection A of Section 2-406 of Title 63 of the Oklahoma Statutes;

22 18. Employing, hiring, or using a minor to transport, carry,  
23 sell, give away, prepare for sale, or peddle any controlled

3 19. Employing, hiring, or using a minor to transport, carry,  
4 sell, give away, prepare for sale, or peddle any controlled  
5 dangerous substance subsequent to a previous conviction of the same,  
6 as provided for in subsection C of Section 2-419.1 of Title 63 of  
7 the Oklahoma Statutes;

8 20. Evading federal reporting requirements or other federal  
9 money laundering laws, as provided for in Section 2-503.1f of Title  
10 63 of the Oklahoma Statutes;

11 21. Owning, operating, or conducting a chop shop, as provided  
12 for in paragraph 1 of subsection A of Section 4253 of Title 63 of  
13 the Oklahoma Statutes;

14 22. Transporting any vessel, motor, or vessel or motor parts to  
15 or from a chop shop, as provided for in paragraph 2 of subsection A  
16 of Section 4253 of Title 63 of the Oklahoma Statutes;

17 23. Selling, transferring, purchasing, or receiving any vessel,  
18 motor, or vessel or motor parts to or from a chop shop, as provided  
19 for in paragraph 3 of subsection A of Section 4253 of Title 63 of  
20 the Oklahoma Statutes; and

21 24. Burglary in the second degree by breaking and entering into  
22 the dwelling house of another in which no human is present, as  
23 provided for in subsection A of Section 1435 of Title 21 of the  
24 Oklahoma Statutes.

1       B. Any person convicted of a Class C1 criminal offense set  
2 forth in this section shall be punished by imprisonment in the  
3 custody of the Department of Corrections for a term of not more than  
4 eight (8) years and shall serve at least twenty-five percent (25%)  
5 of the sentence imposed before release from custody including  
6 release to electronic monitoring pursuant to Section 510.9 of Title  
7 57 of the Oklahoma Statutes.

8       C. 1. Every person who, having been previously convicted of  
9 one or two Class C or Class D criminal offenses, commits a Class C1  
10 criminal offense shall, upon conviction, be punished by imprisonment  
11 in the custody of the Department of Corrections for a term of not  
12 less than two (2) years nor more than twelve (12) years and shall  
13 serve at least twenty-five percent (25%) of the sentence imposed  
14 before release from custody including release to electronic  
15 monitoring pursuant to Section 510.9 of Title 57 of the Oklahoma  
16 Statutes.

17       2. Every person who, having been previously convicted of three  
18 Class C or Class D criminal offenses, or one or more Class Y, Class  
19 A, or Class B criminal offenses, commits a Class C1 criminal offense  
20 shall, upon conviction, be punished by imprisonment in the custody  
21 of the Department of Corrections for a term of not less than two (2)  
22 years nor more than thirty (30) years and shall serve at least fifty  
23 percent (50%) of the sentence imposed before release from custody  
24

1 including release to electronic monitoring pursuant to Section 510.9  
2 of Title 57 of the Oklahoma Statutes.

3 D. 1. Unless specifically exempted pursuant to subsection E of  
4 this section, Section 51.1 of Title 21 of the Oklahoma Statutes  
5 shall not apply to Class C1 criminal offenses.

6 2. The criminal offenses listed in paragraphs 15 and 18 of  
7 subsection A of this section shall be exempt from the penalty  
8 provisions provided for in subsections B and C of this section.  
9 Persons convicted of the criminal offenses provided for in  
10 paragraphs 15 and 18 of subsection A of this section shall be  
11 punished in accordance with the corresponding penalties provided for  
12 in the Oklahoma Statutes including Section 51.1 of Title 21 of the  
13 Oklahoma Statutes.

14 3. The criminal offense listed in paragraph 19 of subsection A  
15 of this section shall be exempt from the penalty provision provided  
16 for in subsection B of this section. Persons convicted of the  
17 criminal offense provided for in paragraph 19 of subsection A of  
18 this section shall be punished in accordance with the corresponding  
19 penalties provided for in the Oklahoma Statutes including Section  
20 51.1 of Title 21 of the Oklahoma Statutes. The provisions of  
21 subsection C of this section still applies to the criminal offense  
22 listed in paragraph 19 of subsection A of this section.

23 E. All Class C1 criminal offenses shall be punishable by the  
24 corresponding fines as provided for in the Oklahoma Statutes.

1 SECTION 13. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 20M of Title 21, unless there is  
3 created a duplication in numbering, reads as follows:

4 A. Upon the effective date of this act, Class C2 shall include  
5 the following criminal offenses:

21 acts of violence that result in great bodily injury, as provided for  
22 in paragraph 1 of subsection B of Section 282 of Title 21 of the  
23 Oklahoma Statutes;

1       7. Forcefully or fraudulently preventing the Legislature from  
2 meeting or organizing, as provided for in Section 301 of Title 21 of  
3 the Oklahoma Statutes;

4       8. Forcefully or fraudulently compelling or attempting to  
5 compel the Legislature to adjourn or disperse, as provided for in  
6 Section 303 of Title 21 of the Oklahoma Statutes;

13 in order to influence the member in giving or withholding a vote, as

16 member of the Legislature, as provided for in Section 309 of Title  
17 21 of the Oklahoma Statutes;

18       12. Entering a fort, magazine, arsenal, armory, arsenal yard,  
19 or encampment and seizing or taking away arms, ammunition, military  
20 stores, or supplies belonging to the state, as provided for in

22       13. Carrying, causing to be carried, or publicly displaying any  
23 red flag or other emblem or banner indicating disloyalty to the

1 Government of the United States, as provided for in Section 374 of

12       27. Financial exploitation of an elderly or disabled adult with  
13 funds, assets, or property valued at One Hundred Thousand Dollars  
14 (\$100,000.00) or less, as provided for in paragraph 2 of subsection

16       28. Conducting gambling games, as provided for in Section 941  
17 of Title 21 of the Oklahoma Statutes;

11 seven (7) years and shall serve at least twenty percent (20%) of the  
12 sentence imposed before release from custody including release to  
13 electronic monitoring pursuant to Section 510.9 of Title 57 of the  
14 Oklahoma Statutes.

15 C. 1. Every person who, having been previously convicted of  
16 one or two Class C or Class D criminal offenses, commits a Class C2  
17 criminal offense shall, upon conviction, be punished by imprisonment  
18 in the custody of the Department of Corrections for a term of not  
19 less than two (2) years nor more than ten (10) years and shall serve  
20 at least twenty percent (20%) of the sentence imposed before release  
21 from custody including release to electronic monitoring pursuant to  
22 Section 510.9 of Title 57 of the Oklahoma Statutes.

23 2. Every person who, having been previously convicted of three  
24 Class C or Class D criminal offenses, or one or more Class Y, Class

1 A, or Class B criminal offenses, commits a Class C2 criminal offense  
2 shall, upon conviction, be punished by imprisonment in the custody  
3 of the Department of Corrections for a term of not less than two (2)  
4 years nor more than twelve (12) years and shall serve at least forty  
5 percent (40%) of the sentence imposed before release from custody  
6 including release to electronic monitoring pursuant to Section 510.9  
7 of Title 57 of the Oklahoma Statutes.

8 D. Unless specifically exempted pursuant to subsection E of  
9 this section, Section 51.1 of Title 21 of the Oklahoma Statutes  
10 shall not apply to Class C2 criminal offenses.

11 E. 1. The criminal offenses listed in paragraphs 1, 2, 52, 53,  
12 54, 55, 63, 65, 67, 68, 76, and 77 of subsection A of this section  
13 shall be exempt from the penalty provisions provided for in  
14 subsections B and C of this section. Persons convicted of the  
15 criminal offenses provided for in paragraphs 1, 2, 52, 53, 54, 55,  
16 63, 65, 67, 68, 76, and 77 of subsection A of this section shall be  
17 punished in accordance with the corresponding penalties provided for  
18 in the Oklahoma Statutes including Section 51.1 of Title 21 of the  
19 Oklahoma Statutes.

20 2. The criminal offense listed in paragraph 64 of subsection A  
21 of this section shall be exempt from the penalty provision provided  
22 for in subsection B of this section. Persons convicted of the  
23 criminal offense provided for in paragraph 64 of subsection A of  
24 this section shall be punished in accordance with the corresponding

1 penalties as provided for in the Oklahoma Statutes including Section  
2 51.1 of Title 21 of the Oklahoma Statutes. The provisions of  
3 Subsection C of this section still applies to the criminal offense  
4 listed in paragraph 64 of subsection A of this section.

5 F. All Class C2 criminal offenses shall be punishable by the  
6 corresponding fines as provided for in the Oklahoma Statutes.

6 in the custody of the Department of Corrections for a term of not  
7 less than one (1) year nor more than five (5) years and shall serve  
8 at least twenty percent (20%) of the sentence imposed before release  
9 from custody including release to electronic monitoring pursuant to  
10 Section 510.9 of Title 57 of the Oklahoma Statutes.

13 A, or Class B criminal offenses, commits a Class D2 criminal offense  
14 shall, upon conviction, be punished by imprisonment in the custody  
15 of the Department of Corrections for a term of not less than one (1)  
16 year nor more than seven (7) years and shall serve at least thirty  
17 percent (30%) of the sentence imposed before release from custody  
18 including release to electronic monitoring pursuant to Section 510.9  
19 of Title 57 of the Oklahoma Statutes.

20 D. Unless specifically exempted pursuant to subsection E of  
21 this section, Section 51.1 of Title 21 of the Oklahoma Statutes  
22 shall not apply to Class D2 criminal offenses.

23 E. 1. The criminal offenses listed in paragraphs 7, 10, 11,  
24 12, 13, 14, 15, 16, 17, 18, and 19 of subsection A of this section

1 shall be exempt from the penalty provisions provided for in  
2 subsections B and C of this section. Persons convicted of the  
3 criminal offenses provided for in paragraphs 7, 10, 11, 12, 13, 14,  
4 15, 16, 17, 18, and 19 of subsection A of this section shall be  
5 punished in accordance with the corresponding penalties provided for  
6 in the Oklahoma Statutes including Section 51.1 of Title 21 of the  
7 Oklahoma Statutes.

8 2. The criminal offense listed in paragraphs 2, 4, 5, and 6 of  
9 subsection A of this section shall be exempt from the penalty  
10 provisions provided for subsection B of this section. Persons  
11 convicted of the criminal offenses provided for in paragraphs 2, 4,  
12 5, and 6 of subsection A of this section shall be punished in  
13 accordance with the corresponding penalties provided for in the

18 F. All Class D2 criminal offenses shall be punishable by the

17 custody of the Department of Corrections for a term of not more than  
18 two (2) years and shall serve at least ten percent (10%) of the  
19 sentence imposed before release from custody including release to  
20 electronic monitoring pursuant to Section 510.9 of Title 57 of the  
21 Oklahoma Statutes.

22       C. 1. Every person who, having been previously convicted of  
23 one or two Class C or Class D criminal offenses, commits a Class D3  
24 criminal offense shall, upon conviction, be punished by imprisonment



1 in the custody of the Department of Corrections for a term of not  
2 less than one (1) year nor more than four (4) years and shall serve  
3 at least ten percent (10%) of the sentence imposed before release  
4 from custody including release to electronic monitoring pursuant to  
5 Section 510.9 of Title 57 of the Oklahoma Statutes.

6 2. Every person who, having been previously convicted of three  
7 Class C or Class D criminal offenses, or one or more Class Y, Class  
8 A, or Class B criminal offenses, commits a Class D3 criminal offense  
9 shall, upon conviction, be punished by imprisonment in the custody  
10 of the Department of Corrections for a term of not less than one (1)  
11 year nor more than five (5) years and shall serve at least twenty  
12 percent (20%) of the sentence imposed before release from custody  
13 including release to electronic monitoring pursuant to Section 510.9  
14 of Title 57 of the Oklahoma Statutes.

15 D. Unless specifically exempted pursuant to subsection E of  
16 this section, Section 51.1 of Title 21 of the Oklahoma Statutes  
17 shall not apply to Class D3 criminal offenses.

18 E. The criminal offenses listed in paragraphs 69, 124, 127, and  
19 177 of subsection A of this section shall be exempt from the penalty  
20 provisions provided for in subsections B and C of this section.

21 Persons convicted of the criminal offenses provided for in  
22 paragraphs 69, 124, 127, and 177 of subsection A of this section  
23 shall be punished in accordance with the corresponding penalties  
24

1 provided for in the Oklahoma Statutes including Section 51.1 of  
2 Title 21 of the Oklahoma Statutes.

3 F. All Class D3 criminal offenses shall be punishable by the  
4 corresponding fines as provided for in the Oklahoma Statutes.

5 SECTION 17. NEW LAW A new section of law to be codified  
6 in the Oklahoma Statutes as Section 20Q of Title 21, unless there is  
7 created a duplication in numbering, reads as follows:

8 Upon the effective date of this act, the minimum time-served  
9 requirements on sentences mandated by the provisions of this act,  
10 may be included in the instructions to the jury during a criminal  
11 trial. If the minimum time-served requirements on sentences are  
12 included in the instructions to the jury in a criminal trial, the  
13 minimum time-served requirements shall be in the form of a  
14 percentage.

15 SECTION 18. This act shall become effective January 1, 2026.
