- 19. Abuse of a vulnerable adult as defined in Section 10-103 of Title 43A of the Oklahoma Statutes;
- Aggravated trafficking as provided for in subsection C of Section 2-415 of Title 63 of the Oklahoma Statutes;
- Aggravated assault and battery upon any person defending another person from assault and battery; or
- 22. Human trafficking as provided for in Section 748 of this title; or
- 23. Assault, battery, or assault and battery upon an intimate partner or a family or household member with a sharp, dangerous, or deadly weapon as provided for in subsection D of Section 644 of this title,

shall be required to serve not less than eighty-five percent (85%) of any sentence of imprisonment imposed by the judicial system prior to becoming eligible for consideration for parole. Persons convicted of these offenses shall not be eligible for earned credits or any other type of credits which have the effect of reducing the
