16	Section 30.8. A. An animal shelter operator or commercial pet
17	breeder who is not in violation of the Commercial Pet Breeders and
18	Animal Shelter Licensing Act or any rule adopted under the
19	Commercial Pet Breeders and Animal Shelter Licensing Act may renew
20	the license of the person by:
21	1. Submitting a renewal application to the Oklahoma Department
22	of Agriculture, Food, and Forestry on the form prescribed by the
23	Department;

Complying with any other renewal requirements adopted by the
 Department; and

3. Paying the required fee.

B. Any person who fails to apply for a renewal in a manner
prescribed by the Department, and whose license has expired, may not
engage in activities that require a license until the license has
been renewed.

8 C. Not later than sixty (60) <u>ninety (90)</u> days before the 9 expiration of the license, the Department shall send written notice 10 of the impending license expiration to the animal shelter operator 11 or commercial pet breeder at the last-known address according to the 12 records of the Department.

13 <u>D. The Department shall provide an online license renewal and</u>
14 payment option by January 1, 2026.
