15 entire bill and insert

17 O.S. 2021, Section 15.3, which relates to assignment
18 of parking for certain officials; modifying
19 assignments of parking spaces; designating parking
20 spaces for large vehicle inspection station;
21 clarifying duties of lot maintenance; updating
22 statutory language; updating statutory reference; and
23 providing an effective date.

24 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 73 O.S. 2021, Section 15.3, is
amended to read as follows:

Section 15.3. Except as provided in ~~subsection~~ subsections C
and D of this section, the President Pro Tempore of the ~~Oklahoma~~

1 ~~State~~ Senate and the Speaker of the ~~Oklahoma~~ House of
2 Representatives are empowered to designate the parking assignments
3 and issue window stickers or other means of identification of
4 elected and appointed officers and employees whose offices are in
5 the State Capitol Building in the parking areas described in ~~this~~
6 ~~act~~ this section and Sections 11-1009 and 11-1010 of Title 47 of the
7 Oklahoma Statutes.

8 A. Except as provided in ~~subsection~~ subsections C and D of this
9 section, officers and employees shall not park in any space in the
10 following described areas except as specified by the President Pro
11 Tempore:

12 1. The parking area traversed by the semicircular drive to the
13 west entrance of the State Capitol Building. This area shall have
14 specifically assigned parking places for state officers, including
15 the Governor, Lieutenant Governor, the President Pro Tempore of the
16 Senate, ~~the Speaker of the House of Representatives,~~ the Attorney
17 General, the State Treasurer, the State Auditor and Inspector, the
18 ~~Justices~~ Chief Justice of the Supreme Court, ~~the Judges of the Court~~
19 ~~of Criminal Appeals,~~ ~~the Judges of the Court of Appeals~~ the
20 Secretary of the State Election Board, and any other elected or
21 appointed state officer or employee so designated by the President
22 Pro Tempore;

23 2. ~~The area beginning at the intersection of Northeast Twenty-~~
24 ~~third Street and the east curb of the west drive of Lincoln~~

1 ~~Boulevard (the southbound lanes of Lincoln Boulevard), thence east~~
2 ~~along Northeast Twenty-third Street to a point in line with the~~
3 ~~easternmost curb of that parking area lying west of the State~~
4 ~~Capitol Building, thence south to the northernmost curb of the~~
5 ~~parking area traversed by the semicircular drive on the west side of~~

15 signage related to the inspection station of large vehicles along
16 Lincoln Boulevard (northbound and southbound lanes) and at the
17 gatehouses for both the Senate and the House of Representatives.

19 Pro Tempore pursuant to subsection A of this section, assigned by
20 the Speaker of the House of Representatives pursuant to subsection B
21 of this section, or designated by the Governor pursuant to
22 subsection C of this section in the parking area ~~described in~~
23 ~~subsections C and D of this section that are unassigned~~ south of the
24 Capitol Plaza and the parking area that lies east of the State

1 Capitol Building on the east side of Lincoln Boulevard shall be
2 reserved for visitors.

3 F. It shall be the duty of the Office of Management and
4 Enterprise Services to maintain all streets, roads, and state-owned
5 parking lots within the boundaries of the State Capitol Park,
6 including striping and painting of parking spots, or otherwise
7 providing signage as assigned or designated by the President Pro
8 Tempore of the Senate, Speaker of the House of Representatives, or
9 Governor pursuant to this section. The Office of Management and
10 Enterprise Services is authorized to expend any money appropriated
11 for the construction and maintenance of such streets, roads, and
12 parking lots.

13 SECTION 2. This act shall become effective November 1, 2025.”

4 Lincoln Boulevard (northbound and southbound lanes) and at the

6 E. All unassigned parking spaces in the south parking area
7 ~~described in subsections C and D of this section that are unassigned~~
8 and the parking area that lies east of the State Capitol Building on
9 the east side of Lincoln Boulevard shall be reserved for visitors.

10 F. It shall be the duty of the Office of Enterprise and
11 Management Services to maintain all streets, roads, and state-owned
12 parking lots within the boundaries of the "State Capitol Park". The
13 Office of Enterprise and Management Services is authorized to expend
14 any money appropriated for the construction and maintenance of these
15 streets, roads, and parking lots.
