16 AMENDMENT NO. 1. Strike the title, enacting clause, and entire bill  
17 and insert:

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 26 O.S. 2021, Section 3-101, as  
3 amended by Section 2, Chapter 329, O.S.L. 2023 (26 O.S. Supp. 2024,  
4 Section 3-101), is amended to read as follows:

5 Section 3-101. A. No election required to be conducted by any  
6 county election board shall be scheduled for a day other than  
7 Tuesday.

8 B. Except as otherwise provided by law, no regular or special  
9 election ~~to fill an elective office~~ for any purpose shall be held by  
10 any county, school district, technology center school district,  
11 municipality, fire protection district, or other political  
12 subdivision authorized to call elections except as follows:

13 1. The second Tuesday of February in any year;

14 2. The first Tuesday of April in any year;

15 3. ~~The date of any regularly scheduled statewide state or~~  
16 ~~federal election in an even-numbered year;~~

17 4. The ~~second~~ third Tuesday of ~~September~~ June in an ~~odd-~~

23 scheduled for the next business day.

1        D. For a special election called by the Governor as authorized  
2 by law, the Governor shall be limited to the dates stated in  
3 subsection B of this section. Provided, however, if a vacancy has  
4 occurred in the office of a United States Representative, State  
5 Senator, or State Representative, or in the event of a declared  
6 national or state emergency that requires a special election, the  
7 Governor may also call a special election as authorized by law on  
8 the following dates:

- 9        1. The second Tuesday of January in any year;
- 10       2. The first Tuesday of March in any year;
- 11       3. The first Tuesday of May in an odd-numbered year;
- 12       4. The second Tuesday of July in an odd-numbered year;

- 15       7. The second Tuesday of December in any year.

16       E. Notwithstanding any other provision of law or any provision

7 municipality, including any municipality governed by charter, rural  
8 fire protection district, or any other entity seeking to hold a  
9 special election for the purpose of filling a vacancy shall schedule  
10 a candidate filing period of three (3) days to begin not more than  
11 twenty (20) days following the date the resolution calling the  
12 election is required to be filed with the secretary of the county  
13 election board.

14 G. The provisions of this section shall apply to elections held  
15 after January 1, 2026.

16 SECTION 2. This act shall become effective November 1, 2025."

23 election board.

G. The provisions of this section shall apply to elections held after January 1, 2026.

SECTION 4. This act shall become effective November 1, 2025.
