13 AMENDMENT NO. 1. Strike the stricken title, enacting clause, and  
14 entire bill and insert:  
15  
16 "An Act relating to construction by political  
17 subdivisions; amending 61 O.S. 2021, Section 108,  
18 which relates to written statements under oath to  
19 accompany bids; and removing requirement for certain  
20 statements to be disclosed under oath; and declaring  
an emergency.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:  
23  
24 SECTION 1. AMENDATORY 61 O.S. 2021, Section 108, is  
amended to read as follows:  
Section 108. Each bidder shall accompany the bid with a written  
statement ~~under oath~~ disclosing the following information:

1        1. The nature of any partnership, joint venture or other  
2 business relationships then in effect or which existed within one  
3 (1) year prior to the date of such statement with the architect,  
4 engineer or other party to the project;

5        2. Any such business relationship then in effect or which  
6 existed within one (1) year prior to the date of such statement  
7 between any officer or director of the bidding company and any  
8 officer or director of the architectural or engineering firm or  
9 other party to the project; and

10       3. The names of all persons having any such business  
11 relationships and the positions they hold with their respective  
12 companies or firms. If none of the business relationships  
13 hereinabove mentioned exist, then a statement to that effect.

14       SECTION 2. It being immediately necessary for the preservation  
15 of the public peace, health or safety, an emergency is hereby  
16 declared to exist, by reason whereof this act shall take effect and  
17 be in full force from and after its passage and approval."

10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 3. AMENDATORY 61 O.S. 2021, Section 108, is  
12 amended to read as follows:

13 Section 108. Each bidder shall accompany the bid with a written  
14 statement ~~under oath~~ disclosing the following information:

15 1. The nature of any partnership, joint venture or other  
16 business relationships then in effect or which existed within one  
17 (1) year prior to the date of such statement with the architect,  
18 engineer or other party to the project;

19 2. Any such business relationship then in effect or which  
20 existed within one (1) year prior to the date of such statement  
21 between any officer or director of the bidding company and any  
22 officer or director of the architectural or engineering firm or  
23 other party to the project; and

3. The names of all persons having any such business relationships and the positions they hold with their respective companies or firms. If none of the business relationships hereinabove mentioned exist, then a statement to that effect.

SECTION 4. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
