8 An Act relating to motor vehicles; creating the  
9 Oklahoma Wrecker Services Division; requiring  
10 Division acquire certain employees to carry out its  
11 objectives; transferring certain powers, duties and  
12 responsibilities from the Corporation Commission and  
13 the Department of Public Safety to the Department of  
14 Labor by certain date; requiring the Department of  
15 Labor succeed any contractual rights or  
16 responsibilities; providing for the transfer of  
17 certain rules; requiring certain notice; transferring  
18 rulemaking authority; authorizing the transfer of  
19 personnel; providing details for personnel transfer;  
20 requiring certain coordination for transfer; creating  
21 the Oklahoma Wrecker and Towing Services Board;  
22 providing for membership of the Board; providing for  
23 initial staggered membership; providing for  
24 appointment of members; requiring Board members  
maintain certain occupations for eligibility;  
requiring certain notice and resignation if certain  
conditions are met; providing for selection of chair;  
authorizing chair to set meetings; requiring quorum  
for actions of the Board; providing quorum  
requirements; requiring the Department of Labor  
provide certain support and venue; authorizing Board  
to promulgate rules; listing powers and duties of the  
Board; prohibiting Board compensation; providing for  
certain reimbursement; providing for removal without  
cause; requiring Board act in accordance with certain  
laws; creating the Oklahoma Wrecker and Towing  
Services Revolving Fund; stating type of fund;  
authorizing expenditures; amending 47 O.S. 2021,  
Section 156.1, as last amended by Section 55, Chapter  
452, O.S.L. 2024 (47 O.S. Supp. 2025, Section 156.1),

1 which relates to private use of state-owned motor  
2 vehicles; removing certain exception; amending 47  
3 O.S. 2021, Section 904, which relates to payment of  
4 cost of removal and storage; modifying responsible  
5 agency; amending 47 O.S. 2021, Section 951, which  
6 relates to definitions; modifying definitions;  
7 amending 47 O.S. 2021, Section 952, which relates to  
8 rulemaking authority; modifying responsible agency;  
9 requiring certain rules be enforced until new rules  
10 are in place; authorizing the promulgation of certain  
11 rules; requiring filing and updating of all rotation  
12 logs; requiring Department of Public Safety to  
13 promulgate certain rules; amending 47 O.S. 2021,  
14 Section 953, which relates to license fees and  
15 renewals; modifying responsible agency; modifying the  
16 deposit of funds; creating certain annual fee;  
17 directing deposit of collected fee; amending 47 O.S.  
18 2021, Section 953.1, which relates to maximum fees  
19 and charges; modifying responsible agency; removing  
20 various rates and fees; removing certain weekly rate  
21 and fee adjustment requirement; removing certain fee  
22 mark-up allowance; requiring wreckers to provide  
23 certain list; requiring certain letterhead for list;  
24 requiring certain updates; disallowing exceedance of  
certain prices; allowing only for certain charges;  
listing allowable rates; disallowing the use of  
certain equipment and personnel; requiring certain  
fees be reasonable; requiring fuel surcharge be based  
upon certain prices; allowing certain adjustment of  
fuel surcharge; disallowing certain deviation;  
authorizing collection of certain charges; requiring  
the posting of certain prices at place of business;  
requiring certain investigation for complaints;  
requiring certain contempt proceedings be held;  
authorizing certain removal from rotation log;  
requiring Department of Public Safety make certain  
communication; requiring Department of Public Safety  
make certain statement; requiring certain opportunity  
for appeal and resubmission of rates; requiring  
certain rates remain in effect until modified;  
requiring Department of Public Safety promulgate  
certain rules; requiring review of price list after  
opening complaint; authorizing certain review;  
dividing the state into certain geographic areas;  
requiring certain validity determination; requiring  
return of certain amount of collected monies;  
requiring bringing of charges after certain

1 complaints are made; requiring certain appeal  
2 process; describing appeal process; authorizing the  
3 Department of Labor to issue certain corrective  
4 action plan; authorizing the Department of Labor to  
5 deny, cancel, suspend, or revoke certain licenses;  
6 amending 47 O.S. 2021, Section 953.2, as amended by  
7 Section 1, Chapter 316, O.S.L. 2023 (47 O.S. Supp.  
8 2025, Section 953.2), which relates to fees charged  
9 for storage and release; modifying responsible  
10 agency; modifying definition; removing certain set  
11 rates; amending 47 O.S. 2021, Section 954, which  
12 relates to enforcement; modifying responsible  
13 agencies; amending 47 O.S. 2021, Section 954A, which  
14 relates to abandoned motor vehicles; modifying  
15 responsible entity; updating language on licensed  
16 operators; amending 47 O.S. 2021, Section 955, as  
17 amended by Section 12, Chapter 228, O.S.L. 2022 (47  
18 O.S. Supp. 2025, Section 955), which relates to  
19 towing vehicle from roadway; modifying responsible  
20 agency; amending 47 O.S. 2021, Section 956, which  
21 relates to gifts prohibited; modifying responsible  
22 agency; amending 47 O.S. 2021, Sections 966, 967, and  
23 968 which relates to the Nonconsensual Towing Act of  
24 2011; modifying responsible agency; providing for  
codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified  
in the Oklahoma Statutes as Section 3-111 of Title 47, unless there  
is created a duplication in numbering, reads as follows:

A. The Oklahoma Wrecker Services Division, a division of the  
Department of Labor, is hereby created, which shall consist of such  
divisions, sections, committees, offices and positions as may be  
established by the Department of Labor or by law. The Division  
shall employ a Division Director and a team of three employees to

1 investigate consumer complaints related to overcharging for  
2 nonconsensual towing, recovery, storage fees, and violations of the  
3 rules promulgated by the Oklahoma Wrecker and Towing Services Board.  
4 Division employees shall act as analysts, administrative assistants,  
5 administrative technicians, and investigators.

6 B. 1. The applicable powers, duties, and responsibilities  
7 exercised by the Transportation Division of the Oklahoma Corporation  
8 Commission relating to wrecker and towing services shall be fully  
9 transferred to the Department of Labor on November 1, 2026. All  
10 records, property, equipment, assets, monies, financial interests,  
11 liabilities, matters pending, and funds of the Commission related to  
12 wrecker and towing services shall be transferred to the Department  
13 of Labor.

14 2. With the exception of initial inspections of wrecker and  
15 towing facilities and equipment and rotation log requirements  
16 performed by the Department of Public Safety, the applicable powers,  
17 duties, and responsibilities for regulating the wrecker and towing  
18 industry in this state exercised by the Department of Public Safety  
19 shall be fully transferred to the Department of Labor on November 1,  
20 2026. All records, property, equipment, assets, monies, financial  
21 interests, liabilities, matters pending, and funds of the Department  
22 of Public Safety related to wrecker and towing services shall be  
23 transferred to the Department of Labor.

1 C. The Department of Labor shall succeed to any contractual  
2 rights or responsibilities incurred by the Commission pertaining to  
3 wrecker and towing services.

4 D. The administrative rules related to wrecker and towing  
5 services previously promulgated by the Corporation Commission shall  
6 be transferred to and become a part of the administrative rules of  
7 the Department of Labor upon the effective date of this act. The  
8 Office of Administrative Rules in the Office of the Secretary of  
9 State shall provide adequate notice in "The Oklahoma Register" of  
10 the transferred rules and shall place the transferred rules under  
11 the Administrative Code section of the Department of Labor. On the  
12 effective date of this act, any amendment, repeal, or addition to  
13 the transferred rules shall be under the rulemaking authority of the  
14 Department of Labor.

15 E. Aside from rules promulgated by the Department of Public  
16 Safety pertaining to rotation logs and inspections of wrecker and  
17 towing facilities and equipment, the administrative rules previously  
18 promulgated by the Department of Public Safety shall be transferred  
19 to and become a part of the administrative rules of the Department  
20 of Labor upon the effective date of this act. The Office of  
21 Administrative Rules in the Office of the Secretary of State shall  
22 provide adequate notice in "The Oklahoma Register" of the  
23 transferred rules and shall place the transferred rules under the  
24 Administrative Code section of the Department of Labor. On the

1 effective date of this act, any amendment, repeal, or addition to  
2 the transferred rules shall be under the rulemaking authority of the  
3 Department of Labor.

4 F. The Department of Labor, the Corporation Commission, and the  
5 Department of Public Safety may enter into an agreement for the  
6 transfer of personnel, if any, from the Commission and Department of  
7 Public Safety to the Department of Labor. However, in no instance  
8 shall more than four employees receive transfers. No employee shall  
9 be transferred to the Department of Labor except on the freely given  
10 written consent of the employee. Any employees who are transferred  
11 to the Department of Labor shall not be required to accept a lesser  
12 grade or salary than presently received. All employees shall retain  
13 leave, sick, and annual time earned, and any retirement and  
14 longevity benefits which have accrued during their tenure with the  
15 Corporation Commission or the Department of Public Safety. The  
16 transfer of any personnel between the state agencies shall be  
17 coordinated with the Office of Management and Enterprise Services.

18 G. The Office of Management and Enterprise Services shall  
19 coordinate the transfer of records, property, equipment, assets,  
20 funds, allotments, purchase orders, liabilities, outstanding  
21 financial obligations, or encumbrances provided for in this section.

22 SECTION 2. NEW LAW A new section of law to be codified  
23 in the Oklahoma Statutes as Section 951.1 of Title 47, unless there  
24 is created a duplication in numbering, reads as follows:

1           A. There is hereby created, pursuant to the Oklahoma Sunset Law  
2 until January 1, 2032, the Oklahoma Wrecker and Towing Services  
3 Board which shall be the regulatory authority to the Oklahoma  
4 Wrecker Services Division created in Section 1 of this act. The  
5 Board shall be independent and shall consist of nine (9) members who  
6 shall initially serve staggered terms of membership with the Board.  
7 The initial staggered terms of membership of the Board shall be as  
8 follows:

9           1. One member, who is in an industry unrelated to any other  
10 member of the Board, appointed by the Governor from the state at  
11 large whose membership shall expire June 30, 2028;

12           2. One member, who is in an industry unrelated to any other  
13 member of the Board, appointed by Governor from the state at large  
14 whose membership shall expire June 30, 2029;

15           3. One member holding a license or licensed by the Department  
16 of Labor to engage in nonconsensual towing who operates in a county  
17 with a population of one hundred thousand (100,000) or more,  
18 according to the latest Federal Decennial Census, shall be appointed  
19 by the President Pro Tempore of the Oklahoma State Senate and whose  
20 membership shall expire June 30, 2030;

21           4. One member holding a license or licensed by the Department  
22 of Labor to engage in nonconsensual towing who operates in a county  
23 with a population of less than one hundred thousand (100,000),  
24 according to the latest Federal Decennial Census, shall be appointed

1 by the Speaker of the House of Representatives and whose membership  
2 shall expire June 30, 2028;

3 5. One member from the Oklahoma Trucking Association shall be  
4 appointed by the Speaker of the Oklahoma House of Representatives  
5 and whose membership shall expire June 30, 2029;

6 6. One member from law enforcement shall be appointed by the  
7 Governor and whose membership shall expire June 30, 2030;

8 7. One member holding a license or licensed by the Department  
9 of Labor to engage in nonconsensual towing shall be appointed by the  
10 Governor and whose membership shall expire June 30, 2028;

11 8. One member from the commercial insurance industry shall be  
12 appointed by the Speaker Pro Tempore of the Oklahoma State Senate  
13 and whose membership shall expire June 30, 2029; and

14 9. One member from the Oklahoma Department of Transportation  
15 shall be appointed by the Governor and whose membership shall expire  
16 June 30, 2030.

17 Thereafter, persons appointed pursuant to paragraphs 1 through 9  
18 of this subsection shall be appointed for terms of three (3) years  
19 beginning July 1. Any vacancy shall be filled by the appointing  
20 authority for the remainder of the unexpired term.

21 B. Members appointed pursuant to paragraphs 3 through 9 of  
22 subsection A of this section shall remain engaged in the business or  
23 industry described in subsection A of this section. Members so  
24 appointed who no longer satisfy the requirements for his or her

1 Board position pursuant to subsection A of this section shall  
2 provide notification of his or her change of status to his or her  
3 appointing authority and to the chair of the Oklahoma Wrecker and  
4 Towing Services Board and shall resign from the Board within thirty  
5 (30) days of the date upon which the member no longer satisfies the  
6 requirements of the appointment.

7 C. The members shall determine by majority vote of the quorum  
8 of the Board who shall serve as chair. The chair shall be elected  
9 annually, with the right to succeed himself or herself, from the  
10 membership of the Board.

11 D. The Board shall meet at such times that the chair deems  
12 necessary, but no meeting shall be held outside the State of  
13 Oklahoma. All actions of the Board shall be by a quorum. Five  
14 members of the Board shall constitute a quorum for the purpose of  
15 transacting business. The Department of Labor shall provide  
16 administrative support and a meeting venue for the Board.

17 E. Nothing in this act shall be construed to authorize the  
18 Board to regulate consensual towing services, voluntary roadside  
19 assistance, or privately negotiated towing contracts. The Board  
20 shall promulgate rules under the authority of the Oklahoma  
21 Department of Labor to carry out its intent and shall regulate the  
22 wrecker and towing industry in this state, including:

23 1. Establishing reasonable tow rates for nonconsensual tows for  
24 any rates not tied to the federal per diem rate. "Reasonable tow

1 rates" means rates that are directly related to the actual cost of  
2 providing the nonconsensual tow, include a modest and customary  
3 margin, and do not exceed the maximum rates approved by the Board.  
4 These rates may only be adjusted every three (3) years by the Board;

5 2. Establishing reasonable licensing, insurance, and equipment  
6 requirements for any person engaging in towing and related services;

7 3. Establishing reasonable tow truck safety requirements for  
8 any wrecker or wrecker vehicle as defined in Section 951 of Title 47  
9 of the Oklahoma Statutes;

10 4. Establishing a procedure to accept and investigate  
11 complaints from a consumer who claims that he or she has been  
12 overcharged for fees related to nonconsensual towing, recovery, or  
13 storage;

14 5. Determining and sanctioning excessive or unnecessary fees  
15 charged to consumers related to nonconsensual towing, recovery, or  
16 storage;

17 6. Requiring all entities permitted, licensed, or regulated by  
18 the Board to provide all documents in response to information  
19 requests by the Board pursuant to the investigation of consumer  
20 complaints or Board complaints against the permittee or licensee;

21 7. Requiring all entities permitted, licensed, or regulated by  
22 the Board to provide itemized billing for fees related to towing,  
23 storage, or vehicle immobilization services that explains how the  
24 charges were calculated;

1 8. Requiring all entities permitted, licensed, or regulated by  
2 the Board to maintain a copy of the current maximum rate schedule or  
3 fee schedule established by the Board posted in a conspicuous place  
4 and readily accessible to the public;

5 9. Requiring all entities permitted, licensed, or regulated by  
6 the Board to allow the owner or agent of the owner of a motor  
7 vehicle removed pursuant to Section 951 et seq. of Title 47 of the  
8 Oklahoma Statutes to use any other entity permitted, licensed, or  
9 regulated by the Board when reclaiming the motor vehicle from  
10 storage;

11 10. Requiring all entities permitted, licensed, or regulated by  
12 the Board to post a sign notifying customers of the procedure to  
13 obtain a vehicle from storage and the consumer complaint process  
14 pursuant to Section 953.1 of Title 47 of the Oklahoma Statutes. The  
15 sign shall be in a conspicuous and central location in the public  
16 area and shall be a minimum of sixteen inches by twenty inches (16"  
17 x 20") in size. The Board may assess a fine of between Fifty  
18 Dollars (\$50.00) and Two Hundred Fifty Dollars (\$250.00) for failure  
19 to comply with the provisions of this paragraph;

20 11. Utilizing Oklahoma Wrecker Services Division investigators  
21 to investigate consumer complaints related to overcharging for  
22 nonconsensual towing, recovery, storage fees, and violations of the  
23 rules promulgated by the Board;

1 12. Promulgation of rules and the authority of the Oklahoma  
2 Department of Labor setting standards for initial inspections of  
3 wrecker and towing facilities performed by the Department of Public  
4 Safety and standards and procedures for any additional inspections  
5 required by the Board; and

6 13. Submit promulgated rules to the Oklahoma Department of  
7 Labor for approval.

8 F. Members of the Board shall serve without compensation, but  
9 shall be reimbursed through the Department of Labor for expenses  
10 incurred in the performance of his or her duties in accordance with  
11 the provisions of the State Travel Reimbursement Act.

12 G. Each member shall serve at the pleasure of his or her  
13 appointing authority and may be removed or replaced without cause.

14 H. The Board shall act in accordance with the provisions of the  
15 Oklahoma Open Records Act, the Oklahoma Open Meeting Act, and the  
16 Administrative Procedures Act.

17 SECTION 3. NEW LAW A new section of law to be codified  
18 in the Oklahoma Statutes as Section 1003 of Title 40, unless there  
19 is created a duplication in numbering, reads as follows:

20 There is hereby created in the State Treasury a revolving fund  
21 for the Department of Labor, to be designated the "Oklahoma Wrecker  
22 and Towing Services Revolving Fund". The fund shall be a continuing  
23 fund not subject to fiscal year limitations. All monies accruing to  
24 the credit of the fund are hereby appropriated and shall be budgeted

1 and expended by the Department of Labor for the purpose of  
2 administering the Oklahoma Wrecker Services Division. Expenditures  
3 from the fund shall be made upon warrants issued by the State  
4 Treasurer against claims filed as prescribed by law with the  
5 Director of the Office of Management and Enterprise Services for  
6 approval and payment.

7 SECTION 4. AMENDATORY 47 O.S. 2021, Section 156.1, as  
8 last amended by Section 55, Chapter 452, O.S.L. 2024 (47 O.S. Supp.  
9 2025, Section 156.1), is amended to read as follows:

10 Section 156.1. A. It shall be unlawful for any state official,  
11 officer or employee, except any essential employees approved by the  
12 Governor and those officers or employees authorized in subsection B  
13 of this section, to ride to or from the place of residence of the  
14 employee in a state-owned or state-leased automobile, truck or  
15 pickup, except in the performance of the official duty of the  
16 employee, or to use or permit the use of any such automobile, truck,  
17 ambulance or pickup for other personal or private purposes. Any  
18 person convicted of violating the provisions of this section shall  
19 be guilty of a misdemeanor and shall be punished by a fine of not  
20 more than One Hundred Dollars (\$100.00) or by imprisonment in the  
21 county jail for a period to not exceed thirty (30) days, or by both  
22 said fine and imprisonment, and in addition thereto, shall be  
23 discharged from state employment.

1           B. 1. Any state employee, other than the individuals provided  
2 for in paragraph 2 of this subsection and any employee of the  
3 Department of Public Safety who is a wrecker inspector ~~or auditor~~ of  
4 the Wrecker Services Division as provided for in paragraph 3 of this  
5 subsection, who receives emergency telephone calls regularly at the  
6 residence of the employee when the employee is not on duty and is  
7 regularly called upon to use a vehicle after normal work hours in  
8 response to such emergency calls, may be permitted to use a vehicle  
9 belonging to the state to provide transportation between the  
10 residence of the employee and the assigned place of employment,  
11 provided such distance does not exceed seventy-five (75) miles in  
12 any round trip or is within the county where the assigned place of  
13 employment is located. Provided further, an employee may be  
14 permitted to use a state-owned or state-leased vehicle to provide  
15 temporary transportation between a specific work location other than  
16 the assigned place of employment and the residence of the employee,  
17 if such use shall result in a monetary saving to the agency, and  
18 such authorization shall not be subject to the distance or area  
19 restrictions provided for in this paragraph. Authorization for  
20 temporary use of a state-owned or state-leased vehicle for a  
21 specific project shall be in writing stating the justification for  
22 this use and the saving expected to result. Such authorization  
23 shall be valid for not to exceed sixty (60) days. Any state entity  
24 other than law enforcement that avails itself of this provision

1 shall keep a monthly record of all participating employees, the  
2 number of emergency calls received and the number of times that a  
3 state vehicle was used in the performance of such emergency calls.

4 2. Any employee of the Department of Public Safety, Oklahoma  
5 Department of Corrections, Office of the Attorney General, Oklahoma  
6 State Bureau of Narcotics and Dangerous Drugs Control, Oklahoma  
7 State Bureau of Investigation, Alcoholic Beverage Laws Enforcement  
8 Commission, Oklahoma Horse Racing Commission, Oklahoma Department of  
9 Agriculture, Food, and Forestry, Office of the Inspector General  
10 within the Department of Human Services or Office of the State Fire  
11 Marshal, who is a law enforcement officer or criminalist, Public  
12 Information officer, Special Investigator or Assistant Director of  
13 the Oklahoma State Bureau of Investigation, the Executive Director  
14 of CLEET, CLEET-certified Investigator for a state board or any  
15 employee of a district attorney who is a law enforcement officer,  
16 may be permitted to use a state-owned or state-leased vehicle to  
17 provide transportation between the residence of the employee and the  
18 assigned place of employment and between the residence and any  
19 location other than the assigned place of employment to which the  
20 employee travels in the performance of the official duty of the  
21 employee.

22 3. Any employee of the Department of Public Safety who is a  
23 wrecker inspector ~~or auditor~~ of the Wrecker Services Division, or a  
24 noncommissioned pilot may be permitted, as determined by the

1 Commissioner, to use a state-owned or state-leased vehicle to  
2 provide transportation between the residence of the employee and the  
3 assigned place of employment and between the residence and any  
4 location other than the assigned place of employment to which the  
5 employee travels in the performance of the official duty of the  
6 employee.

7 4. The Director, department heads and other essential employees  
8 of the Department of Wildlife Conservation, as authorized by the  
9 Wildlife Conservation Commission, may be permitted to use a state-  
10 owned or state-leased vehicle to provide transportation between the  
11 residence of the employee and the assigned place of employment and  
12 between the residence and any location other than the assigned place  
13 of employment to which the employee travels in the performance of  
14 the official duty of the employee.

15 5. The Director, department heads, emergency responders and  
16 other essential employees of the Department of Corrections, as  
17 authorized by the Director, may be permitted to use a state-owned or  
18 state-leased vehicle to provide transportation between the residence  
19 of the employee and the assigned place of employment and between the  
20 residence and any location other than the assigned place of  
21 employment to which the employee travels in the performance of the  
22 official duty of the employee.

23 6. Designated Examiner Auditors, Designated Examiner  
24 Supervisors, Commercial Driver License Examiners, Commercial Driver

1 License Auditors, Commercial Driver License Supervisors, and Driver  
2 License Supervisors, as an employee of Service Oklahoma may be  
3 permitted, as determined by the Director of Service Oklahoma, to use  
4 a state-owned or state-leased vehicle to provide transportation  
5 between the residence of the employee and the assigned place of  
6 employment and between the residence and any location other than the  
7 assigned place.

8 7. The Attorney General, division heads, emergency responders,  
9 agents, assistant attorneys general, and other essential employees  
10 of the Office of the Attorney General, as authorized by the Attorney  
11 General, may be permitted to use a state-owned or state-leased  
12 vehicle to provide transportation between the residence of the  
13 employee and the assigned place of employment and between the  
14 residence and any location other than the assigned place of  
15 employment to which the employee travels in the performance of the  
16 official duty of the employee.

17 C. The principal administrator of the state agency with which  
18 the employee is employed shall so designate the status of the  
19 employee in writing or provide a copy of the temporary authorization  
20 to the Governor, the President Pro Tempore of the Senate and the  
21 Speaker of the House of Representatives. Such employee status  
22 report shall also be provided to the State Fleet Manager of the  
23 Division of Fleet Management if the motor vehicle for emergency use  
24 is provided by said Division.

1 SECTION 5. AMENDATORY 47 O.S. 2021, Section 904, is

14 5. Time and date the form is completed; and

15 6. Signatures of the driver of the wrecker vehicle and of the  
16 owner, legal possessor or authorized agent of the real property.

17 ~~The Department or the Commission~~ The Board may require  
18 additional information on the Tow Request and Authorization Form.  
19 The driver license number or state-issued identification card number  
20 of the real property owner, legal possessor or authorized agent  
21 shall not be disclosed by the Department ~~or the Commission~~ of Labor  
22 to any entity inquiring about services performed without a court  
23 order or without written consent from the property owner, legal  
24 possessor or authorized agent.

1 E. The real property owner, legal possessor or authorized agent  
2 and the wrecker vehicle driver shall jointly, and each in the  
3 presence of the other, inventory personal property found within or  
4 upon the vehicle and each shall accordingly sign a statement on the  
5 form reflecting this requirement has been fulfilled. In the event  
6 an inventory cannot be completed, the reasons therefor shall be  
7 clearly stated on the form.

8 F. A copy of the completed Tow Request and Authorization Form  
9 shall be retained by the signatories and the licensed Class AA  
10 wrecker service shall maintain the wrecker vehicle driver's copy for  
11 not less than one (1) year, or longer if required by the Department  
12 ~~or the Commission~~ of Labor. The licensed Class AA wrecker service  
13 shall forthwith send the completed original Tow Request and  
14 Authorization Form to the Department of Labor and the remaining copy  
15 of the completed form to the local police department of the  
16 municipality in which the real property is located, or the sheriff's  
17 office of the county from which the vehicle was towed, if the real  
18 property is located outside of an incorporated municipality. A  
19 facsimile copy of the Tow Request and Authorization Form shall be  
20 considered the original form if a printed or digital confirmation of  
21 the facsimile transmission is available.

22 G. Within three (3) business days of the time indicated on the  
23 form, the licensed Class AA wrecker service shall request ~~the~~  
24 Service Oklahoma Tax Commission or other appropriate ~~motor license~~

1 ~~agent~~ licensed operator to furnish the name and address of the  
2 current owner of and any lienholder upon the vehicle. ~~The Tax~~  
3 ~~Commission~~ Service Oklahoma or an appropriate ~~motor license agent~~  
4 licensed operator shall respond in person or by certified mail to  
5 the licensed Class AA wrecker service within five (5) business days  
6 from the receipt of the request for information. ~~The Department and~~  
7 ~~the~~ Service Oklahoma ~~Tax Commission~~ shall render assistance to  
8 ascertain ownership, if needed. The licensed Class AA wrecker  
9 service shall, within seven (7) days from receipt of the requested  
10 information from ~~the~~ Service Oklahoma ~~Tax Commission~~ or other ~~motor~~  
11 ~~license agent~~ licensed operator, send a notice of the location of  
12 the vehicle by certified mail, or if by Department of Labor  
13 notification, the Department of Labor may notify by first-class  
14 mail, postage prepaid, at the addresses furnished, to the owner and  
15 any lienholder of the vehicle. The owner or lienholder may regain  
16 possession of the vehicle in accordance with rules of the Department  
17 of Labor upon payment of the licensed Class AA wrecker services,  
18 costs of certified mailing and the reasonable cost of towing and  
19 storage of the vehicle. If the licensed Class AA wrecker service  
20 has not complied with the notification procedures required by this  
21 subsection, the owner or lienholder shall not be required to pay for  
22 storage of the vehicle.

23 H. No licensed Class AA wrecker service or operator of a  
24 licensed Class AA wrecker service shall tow or cause to be towed a

1 vehicle pursuant to this section until the form furnished by the  
2 Department of Labor has been appropriately completed by the parties  
3 as required by rules of the Department of Labor.

4 SECTION 13. AMENDATORY 47 O.S. 2021, Section 955, as  
5 amended by Section 12, Chapter 228, O.S.L. 2022 (47 O.S. Supp. 2025,  
6 Section 955), is amended to read as follows:

7 Section 955. A. Any officer of the Department of Public Safety  
8 or any other political subdivision of this state is hereby  
9 authorized to cause to be towed any vehicle found upon public roads,  
10 highways, streets, turnpikes, private parking lots accessible to the  
11 public, other public places or upon any private road, street, alley  
12 or lane which provides access to one or more single-family or  
13 multifamily dwellings when:

14 1. A report has been made that the vehicle has been stolen or  
15 taken without the consent of its owner;

16 2. The officer has reason to believe the vehicle has been  
17 abandoned as defined in Sections 901 and 902 of this title;

18 3. The person driving or in control of the vehicle is arrested  
19 for an alleged offense for which the officer is required by law to  
20 take the person arrested or summoned before a proper magistrate  
21 without unnecessary delay;

22 4. At the scene of an accident, if the owner or driver is not  
23 in a position to take charge of the vehicle and direct or request  
24 its proper removal;

1           5. The officer has probable cause that the person operating the  
2 vehicle has not been granted driving privileges or that the driving  
3 privileges of the person are currently suspended, revoked, canceled,  
4 denied, or disqualified;

5           6. The officer has probable cause that the vehicle has been  
6 used in the commission of a felony offense and the officer has  
7 obtained a search warrant authorizing the search and seizure of the  
8 vehicle;

9           7. The officer has probable cause that the vehicle is not  
10 insured as required by the Compulsory Insurance Law of this state;

11 ~~or~~

12           8. The vehicle is involved in a fatal motor vehicle collision  
13 and is needed for evidentiary purposes; or

14           9. A vehicle is left unattended upon any street, sidewalk,  
15 alley or thoroughfare and constitutes a hazard or obstruction to the  
16 normal movement of public transit along a rail fixed guideway. An  
17 unattended vehicle shall be deemed to constitute an obstruction if  
18 any portion of the vehicle remains in that lane utilized for the  
19 rail fixed guideway as designated by traffic lane markings or if any  
20 portion of the vehicle is outside of the designated parking location  
21 and protrudes into the lane of traffic utilized for the rail fixed  
22 guideway. For purposes of this paragraph, the head of a political  
23 subdivision's transportation division may authorize employees to  
24 cause to be towed any vehicle which constitutes a hazard or

1 obstruction to the normal movement of public transit along a rail  
2 fixed guideway.

3 No vehicle shall be released after impoundment unless the owner  
4 provides to the storing facility proof of valid insurance or an  
5 affidavit of nonuse on the roadway, or in the event of a release  
6 request from an insurer or the representative of the insurer who has  
7 accepted liability for the vehicle, no such proof of insurance or  
8 affidavit of nonuse on the roadway shall be required.

9 B. A licensed wrecker operator is not liable for damage to a  
10 vehicle, vessel, or cargo that obstructs the normal movement of  
11 traffic or creates a hazard to traffic and is removed in compliance  
12 with the request of a law enforcement officer, unless there is  
13 failure to exercise reasonable care in the performance of the act or  
14 for conduct that is willful or malicious.

15 C. Each officer of the Department shall use the services of the  
16 licensed wrecker operator whose location is nearest to the vehicle  
17 to be towed in all instances in subsection A of this section. The  
18 requests for services may be alternated or rotated among all  
19 licensed wrecker operators who are located within a reasonable  
20 radius of each other. In like manner, the officer shall advise any  
21 person requesting information as to the availability of a wrecker or  
22 towing service, the name of the nearest licensed wrecker operator,  
23 giving equal consideration to all licensed wrecker operators located  
24 within a reasonable radius of each other. In cities with a

1 population of less than fifty thousand (50,000) ~~population~~, all  
2 licensed wrecker operators located near or in the city limits of  
3 such cities shall be considered as being equal distance and shall be  
4 called on an equal basis as nearly as possible. In counties  
5 bordering other states, if the officer deems safety and time  
6 considerations warrant, the officer may call a wrecker or towing  
7 service that is not on the rotation log.

8 D. Any officer of the Department who has been requested by a  
9 person in need of wrecker or towing service to call a specific  
10 wrecker or towing service for such person, and who calls a different  
11 wrecker or towing service other than the one requested, without the  
12 consent of the person, except where hazardous conditions exist,  
13 shall be subject to progressive discipline issued by the Department  
14 except in instances where a vehicle is removed from the roadway  
15 under the authority of paragraphs 3, 4 and 6 of subsection A of this  
16 section.

17 E. Operators conducting a tow under this section shall release  
18 all personal property within the vehicle to an insurer or  
19 representative of the insurer who has accepted liability for the  
20 vehicle, or to the registered owner or the owner's personal  
21 representative as designated by the registered owner on a form  
22 approved by the Department of Labor. The registered owner or  
23 representative of the registered owner shall provide proof of  
24 identity in accordance with the ~~Department's~~ Department of Labor's

1 rules related to establishing identity. Upon the release of  
2 personal property to an insurer or representative of the insurer,  
3 wrecker operators shall be exempt from all liability and shall be  
4 held harmless for any losses or claims of loss. Personal property  
5 shall include everything in a vehicle except the vehicle, the  
6 attached or installed equipment, vehicle keys or devices to start  
7 and unlock the vehicle, and the spare tire and tools to change the  
8 tire. Interlock devices may be removed pursuant to Section 11-902a  
9 of this title. If release of personal property occurs during normal  
10 business hours as prescribed by the ~~Corporation Commission~~  
11 Department of Labor, it shall be at no cost to the registered owner  
12 or the owner prior to the repossession. After-hour fees may be  
13 assessed as prescribed by ~~this Chapter or by the Corporation~~  
14 ~~Commission~~ the Department of Labor, when the release of property is  
15 made after the prescribed normal business hours.

16 F. The operator of a wrecker or towing service may request a  
17 person offering proof of ownership of personal property and any  
18 interlock device to execute a form provided by the operator  
19 exempting the operator from liability for such release.

20 SECTION 14. AMENDATORY 47 O.S. 2021, Section 956, is  
21 amended to read as follows:

22 Section 956. A. No operator, employee, or contractor of a  
23 wrecker or towing service or of a person or business that derives  
24 any business or income from a wrecker or towing service shall offer,

1 and no officer or employee of the ~~Corporation Commission,~~ Department  
2 of Labor or the Department of Public Safety or any political  
3 subdivision of the state shall accept, directly or indirectly, any  
4 compensation, gift, loan, favor or service given for the purpose of  
5 influencing the officer or employee in the discharge of official  
6 duties of the person.

7 B. Except as provided in subsection C of this section, no  
8 employee of the Department of Labor, officer of the ~~Commission,~~  
9 Department of Public Safety or any law enforcement officer of any  
10 political subdivision of the state shall have any interest,  
11 financial or otherwise, in a wrecker or towing service, or with a  
12 person or in a business that derives business or income from a  
13 wrecker or towing service, nor shall a wrecker or towing service or  
14 a person or business that derives any business or income from a  
15 wrecker or towing service employ such officer or employee.

16 C. An employee of the Department of Labor, officer of the  
17 ~~Commission,~~ Department of Public Safety, or a law enforcement  
18 officer of any political subdivision may have an interest, financial  
19 or otherwise, in or may be employed by a wrecker or towing service  
20 when the sole purpose and only business of the wrecker or towing  
21 service is to perform repossessions of vehicles which are subject to  
22 lien and are being repossessed by the lien holder of record.

23 SECTION 15. AMENDATORY 47 O.S. 2021, Section 966, is  
24 amended to read as follows:

1 Section 966. A. This act shall be known and may be cited as  
2 the "Nonconsensual Towing Act of 2011".

3 B. The provisions of this act shall apply to every wrecker  
4 operating within the State of Oklahoma removing and storing vehicles  
5 from Oklahoma roads and highways or private property as a result of  
6 a nonconsensual tow.

7 C. ~~The Corporation Commission, by Commission order,~~ Department  
8 of Labor, through the Oklahoma Wrecker and Towing Services Board,  
9 shall have the power and authority necessary:

10 1. To establish wrecker rates for the transportation and  
11 storage of motor vehicles removed due to a nonconsensual tow from  
12 Oklahoma roads and highways or private property for any rates not  
13 tied to the federal per diem rate;

14 2. To supervise and enforce such rates; and

15 3. To mediate and adjudicate complaints that may arise from  
16 charges assessed as a result of such vehicle removal.

17 D. Rates as specified in ~~Sections 953.1 and 953.2 of Title 47~~  
18 ~~of the Oklahoma Statutes~~ by the Oklahoma Corporation Commission  
19 shall remain in effect for twelve (12) months following the  
20 effective date of this act and until rates are established by order  
21 ~~of the Commission~~ the Board.

22 E. Rates established by the ~~Commission~~ Board shall be fair and  
23 reasonable.

1 F. The ~~Commission~~ Board may assess fines or other penalties to  
2 any wrecker or towing service for failure to comply with prescribed  
3 rates as established by the ~~Commission~~ Board, failure to pay a  
4 levied assessment or comply with any applicable ~~order of the~~  
5 ~~Commission~~ rule of the Board. Repeat violations by a wrecker or  
6 towing service are cause for revocation of its license issued by the  
7 Department of ~~Public Safety~~ Labor.

8 G. The Department of Public Safety shall cooperate with the  
9 ~~Commission~~ Department of Labor to implement this act and may enter  
10 into agreements to facilitate this act.

11 SECTION 16. AMENDATORY 47 O.S. 2021, Section 967, is  
12 amended to read as follows:

13 Section 967. A. The ~~Corporation Commission~~ Department of Labor  
14 is hereby authorized to assess a fee upon each wrecker or towing  
15 service licensed by the Department of ~~Public Safety~~ Labor and placed  
16 upon an official rotation log, as specified in Section 952 of ~~Title~~  
17 ~~47 of the Oklahoma Statutes~~ this title, to perform nonconsensual  
18 tows.

19 B. Each wrecker or towing service shall pay the assessment,  
20 levied pursuant to this section, on an annual basis.

21 C. The assessment shall be predicated upon the number of  
22 wrecker or towing vehicles utilized by the wrecker or towing service

1 D. Commencing with assessments made after June 30, 2017,

15 the amount of the budgetary limits and indirect costs for related  
16 support functions established by the Legislature for any fiscal

18 superseded by action of the Legislature.

19 SECTION 17. AMENDATORY 47 O.S. 2021, Section 968, is  
20 amended to read as follows:

21 Section 968. The ~~Corporation Commission~~ Department of Labor is  
22 authorized to appoint unclassified employees to perform the duties  
23 and responsibilities associated with the Nonconsensual Towing Act of  
24 2011.

1 SECTION 18. This act shall become effective January 1, 2027.
