PROPOSED COMMITTEE SUBSTITUTE

An Act relating to general appropriations for the expenses of various agencies, authorities, boards, bureaus, commissions, funds, and programs of the state's legislative, executive, and judicial branches; making appropriations, stating amounts, identifying sources, and providing expenditure purposes, mandates, and limitations to the State Board of Education, Teachers' Retirement System Dedicated Revenue Revolving Fund, the Oklahoma Board of Private Vocational Schools, the Commissioners of the Land Office, the Health Care Workforce Training Commission, the Office of Educational Quality and Accountability, the Oklahoma Arts Council, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Department of Libraries, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the School of Science and Mathematics, the State Board of Career and Technology Education, the Statewide Charter School Board Revolving Fund, the Oklahoma Tax Commission, the Ethics Commission, the Ethics Commission Electronic Filing System Replacement Fund, the Political Subdivisions Enforcement Fund, Office of the Governor, the Legislative Service Bureau, the Lieutenant Governor, the Department of Emergency Management, the Oklahoma House of Representatives, the Office of Management and Enterprise Services, the

20 Concerns, the Office of Juvenile Affairs, the  
21 Oklahoma Corporation Commission, the Department of  
22 Agriculture, Food, and Forestry, the Oklahoma  
23 Department of Commerce, the Rural Economic Action  
24 Plan Fund, the Department of Environmental Quality,  
the Department of Labor, the Department of Mines, the  
J.M. Davis Memorial Commission, the Oklahoma  
Conservation Commission, the Oklahoma Tourism and  
Recreation Department, the Oklahoma Historical  
Society, the Oklahoma Water Resources Board, the  
Oklahoma State University Veterinary Medical  
Authority, the Oklahoma Workforce Commission, the  
Alcoholic Beverage Laws Enforcement Commission, the  
Board of Medicolegal Investigations, the Council on  
Law Enforcement Education and Training, the  
Department of Corrections, the Department of Public  
Safety, the Oklahoma State Bureau of Investigation,  
the Oklahoma State Bureau of Narcotics and Dangerous  
Drugs Control, the Office of the Attorney General,  
the Domestic Violence and Sexual Assault Services  
Revolving Fund, the Oklahoma Sheriff's Office Funding  
Assistance Revolving Fund, the Council on Judicial  
Complaints, the District Attorneys Council, the  
Oklahoma Indigent Defense System, the Pardon and  
Parole Board, the Court of Criminal Appeals, the  
district courts, the Supreme Court, Ad Valorem  
Reimbursement Fund, the Special Cash Fund, the Legacy  
Capital Finance Fund, the Progressing Rural Economic

Prosperity Fund, and the Oklahoma Emission Reduction Technology Downstream Incentive Revolving Fund; authorizing and directing certain expenditures, redesignation, and transfers of funds; clarifying execution under certain conditions; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2026, the sum of One Billion Six Hundred Fifty-one Million Four Hundred Sixty Thousand Four Hundred Thirteen Dollars (\$1,651,460,413.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund, created in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of One Billion Two Hundred Sixty-two Million Seven Hundred Thirty-five Thousand Three Hundred Fifty-three Dollars (\$1,262,735,353.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2026, from the Common

1 Education Technology Revolving Fund of the State Treasury, the sum  
2 of Forty-seven Million Dollars (\$47,000,000.00) or so much thereof  
3 as may be necessary for the financial support of public schools.

4 SECTION 4. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 Mineral Leasing Fund of the State Treasury for the fiscal year  
7 ending June 30, 2026, the sum of Four Million Nine Hundred Forty  
8 Thousand Dollars (\$4,940,000.00) or so much thereof as may be  
9 necessary for the financial support of public schools.

10 SECTION 5. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Mineral Leasing Fund of the State Treasury for the fiscal year  
13 ending June 30, 2024, the sum of Three Hundred Forty-four Thousand  
14 Five Hundred Thirty-one Dollars (\$344,531.00) or so much thereof as  
15 may be necessary for the financial support of public schools.

16 SECTION 6. There is hereby appropriated to the State Board of  
17 Education from any monies not otherwise appropriated from the  
18 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
19 fiscal year ending June 30, 2026, the sum of Twenty-seven Million  
20 Seven Hundred Eighty-seven Thousand Five Hundred Dollars  
21 (\$27,787,500.00) or so much thereof as may be necessary for the  
22 financial support of public schools.

23 SECTION 7. There is hereby appropriated to the State Board of  
24 Education from any monies not otherwise appropriated from the

1 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
2 fiscal year ending June 30, 2024, the sum of One Million Four  
3 Hundred Sixty-two Thousand Five Hundred Dollars (\$1,462,500.00) or  
4 so much thereof as may be necessary for the financial support of  
5 public schools.

6 SECTION 8. There is hereby appropriated to the State Board of  
7 Education from any monies not otherwise appropriated from the  
8 General Revenue Fund of the State Treasury for the fiscal year  
9 ending June 30, 2026, the sum of One Hundred Twenty-five Million One  
10 Hundred Eighty-nine Thousand Twenty-six Dollars (\$125,189,026.00) or  
11 so much thereof as may be necessary for the financial support of  
12 public school activities.

13 SECTION 9. There is hereby appropriated to the State Board of  
14 Education from any monies not otherwise appropriated from the  
15 General Revenue Fund of the State Treasury for the fiscal year  
16 ending June 30, 2026, the sum of Four Hundred Ten Million Eight  
17 Hundred Fifty-one Thousand One Hundred Fifty-nine Dollars  
18 (\$410,851,159.00) or so much thereof as may be necessary for the  
19 Certified Employee Health Benefit Allowance.

20 SECTION 10. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 General Revenue Fund of the State Treasury for the fiscal year  
23 ending June 30, 2026, the sum of Two Hundred Forty-seven Million  
24 Seven Hundred Twenty-three Thousand Four Hundred Eighteen Dollars

1 (\$247,723,418.00) or so much thereof as may be necessary for the  
2 Support Personnel Health Benefit Allowance.

3 SECTION 11. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2026, the sum of Eighteen Million One Hundred Forty-  
7 five Thousand Three Hundred Sixty-six Dollars (\$18,145,366.00) or so  
8 much thereof as may be necessary for the administration and support  
9 functions of the State Department of Education.

10 SECTION 12. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 General Revenue Fund of the State Treasury for the fiscal year  
13 ending June 30, 2026, the sum of Forty-five Million One Hundred  
14 Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may  
15 be necessary for the purchase of textbooks and instructional  
16 materials.

17 SECTION 13. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
20 fiscal year ending June 30, 2026, the sum of Three Million Eighty-  
21 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much  
22 thereof as may be necessary for transfer to the School Consolidation  
23 Assistance Fund.

1       SECTION 14. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
4 fiscal year ending June 30, 2024, the sum of One Hundred Sixty-two  
5 Thousand Five Hundred Dollars (\$162,500.00) or so much thereof as  
6 may be necessary for transfer to the School Consolidation Assistance  
7 Fund. The State Board of Education is hereby authorized to transfer  
8 such amount to the Teachers' Retirement System of Oklahoma.

9       SECTION 15. There is hereby appropriated to the State Board of  
10 Education from any monies not otherwise appropriated from the  
11 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
12 fiscal year ending June 30, 2026, the sum of Three Million Eighty-  
13 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much  
14 thereof as may be necessary for transfer to the Teachers' Retirement  
15 System Dedicated Revenue Revolving Fund. The State Board of  
16 Education is hereby authorized to transfer such amount to the  
17 Teachers' Retirement System of Oklahoma.

18       SECTION 16. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
21 fiscal year ending June 30, 2024, the sum of One Hundred Sixty-two  
22 Thousand Five Hundred Dollars (\$162,500.00) or so much thereof as  
23 may be necessary for transfer to the Teachers' Retirement System  
24 Dedicated Revenue Revolving Fund.



1       SECTION 17. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2026, the sum of Two Million Six Hundred Fifty  
5 Thousand Dollars (\$2,650,000.00) for the purpose of compensating  
6 teachers as defined by Section 1-116 of Title 70 of the Oklahoma  
7 Statutes.

8       SECTION 18. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 General Revenue Fund of the State Treasury for the fiscal year  
11 ending June 30, 2026, the sum of One Hundred Twenty-five Million  
12 Dollars (\$125,000,000.00) to be distributed as redbud school grants  
13 as provided in Section 3-104 of Title 70 of the Oklahoma Statutes.

14       SECTION 19. There is hereby appropriated to the State Board of  
15 Education from any monies not otherwise appropriated from the  
16 General Revenue Fund of the State Treasury for the fiscal year  
17 ending June 30, 2026, the sum of Six Million Five Hundred Thousand  
18 Dollars (\$6,500,000.00) to be transferred to the Public School Paid  
19 Maternity Leave Revolving Fund (294) pursuant to the provisions of  
20 Section 6-104.8 of Title 70 of the Oklahoma Statutes.

21       SECTION 20. For the fiscal year ending June 30, 2026, the State  
22 Board of Education is hereby authorized to transfer from the  
23 Teachers' Retirement System Dedicated Revenue Revolving Fund to the  
24 Teachers' Retirement System of Oklahoma, the sum of Four Hundred

1 Thirty-three Million Nine Hundred Thirty-five Thousand Two Hundred  
2 Thirty-two Dollars (\$433,935,232.00).

3 SECTION 21. There is hereby appropriated to the Oklahoma Board  
4 of Private Vocational Schools from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2026, the sum of Two Hundred Fifty  
7 Thousand Dollars (\$250,000.00) or so much thereof as may be  
8 necessary to perform the duties imposed upon the Board by law.

9 SECTION 22. There is hereby appropriated to the Commissioners  
10 of the Land Office from any monies not otherwise appropriated from  
11 the Commissioners of the Land Office Fund of the State Treasury for  
12 the fiscal year ending June 30, 2026, the sum of Six Million Seven  
13 Hundred Three Thousand Four Hundred Twenty-one Dollars  
14 (\$6,703,421.00) or so much thereof as may be necessary to perform  
15 the duties imposed upon the Office by law.

16 SECTION 23. There is hereby appropriated to the Health Care  
17 Workforce Training Commission from any monies not otherwise  
18 appropriated from the General Revenue Fund of the State Treasury for  
19 the fiscal year ending June 30, 2026, the sum of Ten Million Four  
20 Hundred Seventy-six Thousand Seven Hundred Fourteen Dollars  
21 (\$10,476,714.00) or so much thereof as may be necessary to perform  
22 the duties imposed upon the Commission by law. Of the funds  
23 appropriated in this section, the sum of Two Million Three Hundred  
24 Twenty Thousand Dollars (\$2,320,000.00) shall be used to carry out

1 the provisions of Section 3308.1 of Title 70 of the Oklahoma  
2 Statutes.

3 SECTION 24. There is hereby appropriated to the Office of  
4 Educational Quality and Accountability from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2026, the sum of Three Million Six  
7 Hundred Ninety-seven Thousand Two Hundred Nine Dollars  
8 (\$3,697,209.00) or so much thereof as may be necessary to perform  
9 the duties imposed upon the Office by law. Of those funds  
10 appropriated, the sum of Sixty Thousand Dollars (\$60,000.00) shall  
11 be deposited in the Teaching Certification Scholarship Revolving  
12 Fund, created pursuant to Section 6-187C of Title 70 of the Oklahoma  
13 Statutes. Of those funds appropriated, the sum of One Hundred  
14 Eighty Thousand Dollars (\$180,000.00) shall be deposited in the  
15 Education Leadership Oklahoma Revolving Fund, created pursuant to  
16 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

17 SECTION 25. There is hereby appropriated to the Oklahoma Arts  
18 Council from any monies not otherwise appropriated from the General  
19 Revenue Fund of the State Treasury for the fiscal year ending June  
20 30, 2026, the sum of Four Million Three Hundred Eight Thousand One  
21 Hundred Eighty Dollars (\$4,308,180.00) or so much thereof as may be  
22 necessary to perform the duties imposed upon the Council by law.

23 SECTION 26. There is hereby appropriated to the Oklahoma Center  
24 for the Advancement of Science and Technology from any monies not

1 otherwise appropriated from the General Revenue Fund of the State  
2 Treasury for the fiscal year ending June 30, 2026, the sum of  
3 Seventeen Million Three Hundred Forty-six Thousand Five Hundred  
4 Forty-two Dollars (\$17,346,542.00) or so much thereof as may be  
5 necessary to perform the duties imposed upon the Center by law. Of  
6 those funds appropriated, the sum of Eight Million Two Hundred  
7 Fifty-six Thousand Two Hundred Twenty-eight Dollars (\$8,256,228.00)  
8 shall be deposited in the Research Support Revolving Fund, created  
9 pursuant to Section 5060.11 of Title 74 of the Oklahoma Statutes,  
10 provided that Three Million Dollars (\$3,000,000.00) shall be  
11 dedicated to applied research and development for industry  
12 innovation. Of those funds appropriated, Five Hundred Thousand  
13 Dollars (\$500,000.00) shall be dedicated to the Research and  
14 Development Attraction Program, created pursuant to Section 5003.10g  
15 of Title 74 of the Oklahoma Statutes. Of those funds appropriated,  
16 the sum of Two Million Seven Hundred Thirty-five Thousand Six  
17 Hundred Twenty-three Dollars (\$2,735,623.00) shall be deposited in  
18 the Seed-Capital Revolving Fund, created pursuant to Section 5060.21  
19 of Title 74 of the Oklahoma Statutes.

20 SECTION 27. There is hereby appropriated to the Oklahoma  
21 Department of Libraries from any monies not otherwise appropriated  
22 from the General Revenue Fund of the State Treasury for the fiscal  
23 year ending June 30, 2026, the sum of Five Million Seven Hundred  
24 Twenty-eight Thousand Three Hundred Fifty-eight Dollars

1 (\$5,728,358.00) or so much thereof as may be necessary to perform  
2 the duties imposed upon the Department by law.

3 SECTION 28. There is hereby appropriated to the Oklahoma  
4 Educational Television Authority from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2026, the sum of Two Million Nine  
7 Hundred Fifty-four Thousand Four Dollars (\$2,954,004.00) or so much  
8 thereof as may be necessary to perform the duties imposed upon the  
9 Authority by law.

10 SECTION 29. There is hereby appropriated to the Oklahoma State  
11 Regents of Higher Education from any monies not otherwise  
12 appropriated from the General Revenue Fund of the State Treasury for  
13 the fiscal year ending June 30, 2026, the sum of Eight Hundred  
14 Seventy-two Million Four Hundred Thirty-five Thousand Twenty-seven  
15 Dollars (\$872,435,027.00) or so much thereof as may be necessary for  
16 allocation by the Oklahoma State Regents for Higher Education  
17 pursuant to the provisions of Article XIII-A of the Oklahoma  
18 Constitution for the education and general operating budgets of the  
19 institutions and for other programs, construction, renovations, or  
20 repairs administered by the Oklahoma State Regents for Higher  
21 Education. Of those funds appropriated, the sum of Three Million  
22 One Hundred Forty-nine Thousand Eight Hundred Ninety-seven Dollars  
23 (\$3,149,897.00) shall be transferred to the Oklahoma Tuition  
24 Equalization Grant Trust Fund to implement the provisions of the

1 Oklahoma Tuition Equalization Grant Act, and the sum of Twelve  
2 Million Five Hundred Thousand Dollars (\$12,500,000.00) shall be  
3 transferred to the Oklahoma National Guard Educational Assistance  
4 Revolving Fund, created in Section 3232 of Title 70 of the Oklahoma  
5 Statutes.

6 SECTION 30. The Office of Management and Enterprise Services is  
7 authorized to transfer to the Oklahoma State Regents of Higher  
8 Education during the fiscal year ending July 1, 2026, an amount of  
9 Seventy Million Dollars (\$70,000,000.00) designated for the support  
10 of the Oklahoma Higher Learning Access Program.

11 SECTION 31. There is hereby appropriated to the Oklahoma State  
12 Regents of Higher Education from any monies not otherwise  
13 appropriated from the General Revenue Fund of the State Treasury for  
14 the fiscal year ending June 30, 2026, the sum of Seven Hundred Forty  
15 Thousand Three Hundred Ten Dollars (\$740,310.00) for the benefit of  
16 the Oklahoma Higher Learning Access Program.

17 SECTION 32. The Oklahoma State Regents for Higher Education are  
18 hereby authorized to expend during the fiscal year ending June 30,  
19 2026, the sum of Forty-seven Million Dollars (\$47,000,000.00) from  
20 the Higher Education Capital Revolving Fund of the State Treasury  
21 for allocation by the Oklahoma State Regents for Higher Education  
22 pursuant to the provisions of Article XIII-A of the Oklahoma  
23 Constitution for the education and general operating budgets of the  
24 institutions for other programs, construction, renovations, or

1 repairs administered by the Oklahoma State Regents for Higher  
2 Education.

3 SECTION 33. The Oklahoma State Regents for Higher Education are  
4 hereby authorized to expend during the fiscal year ending June 30,  
5 2026, the sum of Forty-seven Million Dollars (\$47,000,000.00) from  
6 the Oklahoma Student Aid Revolving Fund of the State Treasury for  
7 allocation by the Oklahoma State Regents for Higher Education  
8 pursuant to the provisions of Article XIII-A of the Oklahoma  
9 Constitution for the education and general operating budgets of the  
10 institutions for other programs, construction, renovations, or  
11 repairs administered by the Oklahoma State Regents for Higher  
12 Education.

13 SECTION 34. There is hereby appropriated to the Oklahoma State  
14 Regents for Higher Education from any monies not otherwise  
15 appropriated from the Oklahoma Education Lottery Trust Fund of the  
16 State Treasury for the fiscal year ending June 30, 2026, the sum of  
17 Twenty-four Million Three Hundred Ninety-one Thousand Two Hundred  
18 Fifty Dollars (\$24,391,250.00) pursuant to Section 713 of Title 3A  
19 of the Oklahoma Statutes for allocation by the Oklahoma State  
20 Regents for Higher Education pursuant to the provisions of Article  
21 XIII-A of the Oklahoma Constitution for construction, renovations,  
22 or repairs administered by the Oklahoma State Regents for Higher  
23 Education or for any other purpose authorized by Section 713 of  
24 Title 3A of the Oklahoma Statutes.

1       SECTION 35. There is hereby appropriated to the Oklahoma State  
2 Regents for Higher Education from any monies not otherwise  
3 appropriated from the Oklahoma Education Lottery Trust Fund of the  
4 State Treasury for the fiscal year ending June 30, 2024, the sum of  
5 One Million Two Hundred Eighty-three Thousand Seven Hundred Fifty  
6 Dollars (\$1,283,750.00) pursuant to Section 713 of Title 3A of the  
7 Oklahoma Statutes for allocation by the Oklahoma State Regents for  
8 Higher Education pursuant to the provisions of Article XIII-A of the  
9 Oklahoma Constitution for construction, renovations, or repairs  
10 administered by the Oklahoma State Regents for Higher Education or  
11 for any other purpose authorized by Section 713 of Title 3A of the  
12 Oklahoma Statutes.

13       SECTION 36. There is hereby appropriated to the Oklahoma State  
14 Regents for Higher Education from any monies not otherwise  
15 appropriated from the General Revenue Fund of the State Treasury for  
16 the fiscal year ending June 30, 2026, the sum of Eighteen Million  
17 Eight Hundred Twenty-two Thousand Six Hundred Fifteen Dollars  
18 (\$18,822,615.00) for expenditures for concurrent enrollment pursuant  
19 to Section 628.13 of Title 70 of the Oklahoma Statutes.

20       SECTION 37. There is hereby appropriated to the Oklahoma State  
21 Regents for Higher Education from any monies not otherwise  
22 appropriated from the General Revenue Fund of the State Treasury for  
23 the fiscal year ending June 30, 2024, the sum of Four Million Two  
24 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars



1 (\$4,232,974.00) for the general operating budget of the  
2 administrative offices of the Oklahoma State Regents for Higher  
3 Education.

14 Council for duties to support victim-witness services.

15 SECTION 138. There is hereby appropriated to the Oklahoma  
16 Indigent Defense System from any monies not otherwise appropriated  
17 from the General Revenue Fund of the State Treasury for the fiscal  
18 year ending June 30, 2026, the sum of Twenty-six Million Four  
19 Hundred Seventy Thousand One Hundred Twenty-five Dollars  
20 (\$26,470,125.00) or so much thereof as may be necessary to perform  
21 the duties imposed upon the System by law.

22 SECTION 139. There is hereby appropriated to the Pardon and  
23 Parole Board from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2026, the sum of Two Million Six Hundred Four  
2 Thousand Four Hundred Forty-six Dollars (\$2,604,446.00) or so much  
3 thereof as may be necessary to perform the duties imposed upon the  
4 Board by law.

5 SECTION 140. There is hereby appropriated to the Court of  
6 Criminal Appeals from any monies not otherwise appropriated from the  
7 General Revenue Fund of the State Treasury for the fiscal year  
8 ending June 30, 2026, the sum of Four Million Six Hundred Eighty-six  
9 Thousand Seven Hundred Seventy-five Dollars (\$4,686,775.00) or so  
10 much thereof as may be necessary to perform the duties imposed upon  
11 the Court of Criminal Appeals by law.

12 SECTION 141. The Supreme Court is hereby authorized to expend  
13 during the fiscal year ending June 30, 2026, from the State Judicial  
14 Revolving Fund of the State Treasury, the sum of Fifteen Million  
15 Five Hundred Thirty-seven Thousand Three Hundred Fourteen  
16 (\$15,537,314.00) or so much thereof as may be necessary for the  
17 financial support of the district courts.

18 SECTION 142. There is hereby appropriated to the Supreme Court  
19 from any monies not otherwise appropriated from the General Revenue  
20 Fund of the State Treasury for the fiscal year ending June 30, 2026,  
21 the sum of Seventy-one Million Four Hundred Twenty-two Thousand Nine  
22 Hundred Eighty-three Dollars (\$71,422,983.00) or so much thereof as  
23 may be necessary to perform the duties imposed upon the district  
24 courts by law.

1       SECTION 143. There is hereby appropriated to the Supreme Court  
2 from any monies not otherwise appropriated from the General Revenue  
3 Fund of the State Treasury for the fiscal year ending June 30, 2024,  
4 the sum of Sixteen Million Ninety-three Thousand Thirty-seven  
5 Dollars (\$16,093,037.00) or so much thereof as may be necessary to  
6 perform the duties imposed upon the Supreme Court or Court of Civil  
7 Appeals by law.

8       SECTION 144. There is hereby appropriated to the Supreme Court  
9 from any monies not otherwise appropriated from the General Revenue  
10 Fund of the State Treasury for the fiscal year ending June 30, 2025,  
11 the sum of Twelve Million Seven Hundred Sixty-five Thousand Seven  
12 Hundred Fifty-two Dollars (\$12,765,752.00) or so much thereof as may  
13 be necessary to perform the duties imposed upon the Supreme Court or  
14 Court of Civil Appeals by law. Of the funds appropriated herein,  
15 the Supreme Court is authorized to transfer up to Ten Million Five  
16 Hundred Thousand Dollars (\$10,500,000.00) to the Family  
17 Representation and Advocacy Program Revolving Fund, created by  
18 Section 802 of Title 10 of the Oklahoma Statutes, to implement the  
19 provisions of the Family Representation and Advocacy Act.

15 the purpose of reimbursing counties for school districts that claim  
16 a loss of revenue due to a tax exemption granted pursuant to the  
17 provisions of Section 6B of Article X of the Oklahoma Constitution.

18 SECTION 147. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the

22 Fifty-three Thousand One Hundred Thirteen Dollars (\$11,453,113.00)  
23 or so much thereof as may be necessary for the Certified Employee  
24 Health Benefit Allowance.

1       SECTION 148. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2023, the sum of Ten Million Five Hundred Fifty-nine  
5 Thousand Four Hundred Forty-one Dollars (\$10,559,441.00) or so much  
6 thereof as may be necessary for the Support Personnel Health Benefit  
7 Allowance.

8       SECTION 149. There is hereby appropriated to the Department of  
9 Mental Health and Substance Abuse Services from any monies not  
10 otherwise appropriated from the General Revenue Fund of the State  
11 Treasury for the fiscal year ending June 30, 2024, the sum of  
12 Twenty-seven Million Four Hundred Four Thousand Seven Hundred Fifty-  
13 eight Dollars (\$27,404,758.00) for the payment of agency payroll.

14       SECTION 150. REDESIGNATION From the funds appropriated to the  
15 Department of Mental Health and Substance Abuse Services in Enrolled  
16 Senate Bill No. 1125 of the 2nd Session of the 59th Oklahoma  
17 Legislature, the sum of Four Million One Hundred Thousand Dollars  
18 (\$4,100,000.00), notwithstanding the limitation provided in Section  
19 3 of Enrolled House Bill No. 2929 of the 2nd Session of the 59th  
20 Oklahoma Legislature, shall be redesignated and available to the  
21 Department of Mental Health and Substance Abuse Services for the  
22 payment of agency payroll.

23       SECTION 151. There is hereby appropriated to the Special Cash

16 Rural Economic Prosperity Fund, created in Section 256 of Title 62  
17 of the Oklahoma Statutes, from any monies not otherwise appropriated  
18 from the General Revenue Fund of the State Treasury for the fiscal  
19 year ending June 30, 2023, the sum of Fifty-eight Million Dollars  
20 (\$58,000,000.00) for availability of appropriation.

21       SECTION 159. There is hereby appropriated to the Department of  
22 Commerce from any monies not otherwise appropriated from the General  
23 Revenue Fund of the State Treasury for the fiscal year ending June  
24 30, 2026, the sum of Three Million Dollars (\$3,000,000.00) to

1 facilitate and support ongoing efforts in workforce development,  
2 enhance manufacturing and supply chain capabilities, and support the  
3 expansion of research and development, and commercialization  
4 activities in this state.

5 SECTION 160. There is hereby appropriated to the Military  
6 Department of the State of Oklahoma from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2026, the sum of Twenty-one Million  
9 Dollars (\$21,000,000.00) or so much thereof as may be necessary to  
10 enhance and improve military bases and facilities in Oklahoma. The  
11 Military Department is authorized to transfer monies appropriated in  
12 this section to the BIND - Schools Fund created in Enrolled House  
13 Bill No. 2516 of the 1st Regular Session of the 60th Oklahoma  
14 Legislature and the BIND - Technology Fund created in Enrolled House  
15 Bill No. 2518 of the 1st Regular Session of the 60th Oklahoma  
16 Legislature, provided the total of such transfers shall not exceed  
17 the amount appropriated in this section.

18 SECTION 161. TRANSFER There is hereby transferred from the  
19 Oklahoma Emission Reduction Technology Upstream and Midstream  
20 Incentive Revolving Fund, created in Subsection A of Section 55010  
21 of Title 68 of the Oklahoma Statutes the sum of Twenty Million  
22 Dollars (\$20,000,000.00), to the Oklahoma Emission Reduction  
23 Technology Downstream Incentive Revolving Fund created in subsection  
24



1 B of Section 55010 of Title 68 of the Oklahoma Statutes, to be  
2 utilized in accordance with law.

3 SECTION 162. Appropriations, authorizations, and distributions  
4 directed in this act to or from a revolving fund of the State  
5 Treasury enacted during the 1st Session of the 60th Oklahoma  
6 Legislature shall be executable upon the latter of the effective  
7 date for such applicable section of this act or upon date of such  
8 fund's creation.

9 SECTION 163. Sections 1 through 144, 157, 159, and 160 of this  
10 act shall become effective July 1, 2025.
