2	authorized to transfer to the ROA-25 Revolving Fund created pursuant
3	to Enrolled House Bill No. 2781 of the 1st Regular Session of the
4	60th Oklahoma Legislature, from the monies appropriated to the
5	Oklahoma Department of Commerce by Section 1 of Senate Bill 1179 of
6	the 1st Session of the 59th Oklahoma Legislature the sum of Seventy-
7	five Million Dollars (\$75,000,000.00) to be budgeted and expended in
8	accordance with law.
