8 PROPOSED OVERSIGHT COMMITTEE SUBSTITUTE

9 An Act relating to counties and county officers;
10 amending 19 O.S. 2021, Section 180.62, as amended by
11 Section 3, Chapter 394, O.S.L. 2024 (19 O.S. Supp.
12 2025, Section 180.62), which relates to basic
13 salaries of county officers; modifying the base
14 salary of county commissioners; and providing an
15 effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 19 O.S. 2021, Section
18 180.62, as amended by Section 3, Chapter 394, O.S.L. 2024 (19
19 O.S. Supp. 2025, Section 180.62), is amended to read as
20 follows:

21 Section 180.62 A. The basic salaries of county officers
22 upon which all salaries and future increases or decreases
23 thereof shall not be less than Nineteen Thousand Dollars
24 (\$19,000.00) per annum nor shall they exceed Forty-nine
Thousand Five Hundred Dollars (\$49,500.00) per annum,

1 provided the basic salary for the sheriff and county
2 commissioners, which shall be no less than other salaries for
3 county officers controlled by this section, shall not be less
4 than Forty-four Thousand Dollars (\$44,000.00) per annum nor
5 shall it exceed Seventy-four Thousand Five Hundred Dollars
6 (\$74,500.00) per annum.

7 B. The board of county commissioners, or if the county has
8 elected to come under the County Budget Act, the budget board
9 members of the county, shall set the salaries for all elected county
10 officials within the limits allowed by law.

11 C. The annual salaries fixed by this act shall be paid either
12 monthly or twice a month, by order of the board of county
13 commissioners, for each month or fraction thereof the incumbent
14 lawfully occupies and holds title to such office.

15 SECTION 2. This act shall become effective November 1, 2026.
