PROPOSED OVERSIGHT COMMITTEE SUBSTITUTE

An Act relating to voter registration; amending 26 O.S. 2021, Section 4-120, as last amended by Section 2, Chapter 357, O.S.L. 2023 (26 O.S. Supp. 2024, Section 4-120), which relates to cancellation of voter registrations; requiring cancellation of voter registration under certain circumstance; authorizing the Secretary of the State Election Board to conduct voter registration list comparison with certain entities; requiring provision of notice of non-citizenship to certain voter; requiring furnishing of proof of citizenship to certain county election board; providing for cancellation of voter registration under certain circumstance; defining term; authorizing promulgation of rules for certain purposes; amending 26 O.S. 2021, Section 7-103.2, as last amended by Section 2, Chapter 264, O.S.L. 2023 (26 O.S. Supp. 2024, Section 7-103.2), which relates to voter registration list; specifying qualifications for access to certain list; requiring application for certain access; prohibiting access to voter registration list for certain purpose; prohibiting transmission of list to certain foreign entities; providing for codification; and providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 26 O.S. 2021, Section 4-120, as  
3 last amended by Section 2, Chapter 357, O.S.L. 2023 (26 O.S. Supp.  
4 2024, Section 4-120), is amended to read as follows:

5 Section 4-120. A. The registration of any registered voter  
6 shall be canceled only for one of the following reasons:

7 1. Written notice from the voter pursuant to Section 4-120.1 of  
8 this title;

9 2. Death;

10 3. Conviction of a felony;

11 4. Judicial determination of mental incapacitation under Title  
12 30 of the Oklahoma Statutes;

13 5. Registration in another county or state;

14 6. Failure to respond to a confirmation of address mailing and  
15 failure to vote as prescribed in Section 4-120.2 of this title;

16 7. The surrendering of the voter's Oklahoma driver license to  
17 Service Oklahoma upon being issued a driver license in another  
18 state; ~~or~~

19 8. Being excused from jury duty for not being a citizen of the  
20 United States; or

21 9. Determination that the voter is not a citizen of the United  
22 States.

23 B. For purposes of this section, paragraphs 5 and 7 of  
24 subsection A of this section shall constitute confirmation from the

1 voter to cancel his or her voter registration due to a change of  
2 residence.

3 C. A list of voter registrations that were canceled during the  
4 previous twenty-four (24) months, and the reason for the  
5 cancellation, shall be made available to the public.

6 SECTION 2. NEW LAW A new section of law to be codified  
7 in the Oklahoma Statutes as Section 4-122 of Title 26, unless there  
8 is created a duplication in numbering, reads as follows:

9 A. The Secretary of the State Election Board may compare the  
10 list of registered voters in this state with the database of any  
11 federal, state, or local agency, board, or commission that maintains  
12 information regarding the citizenship of persons residing in this  
13 state.

14 B. If a registered voter definitively matches a person who is  
15 recorded in a database described in subsection A of this section as  
16 not being a citizen of the United States, the Secretary or his or  
17 her designee shall send a notice of such finding to the voter. The  
18 voter shall, within thirty (30) days from the date the notice is  
19 sent to the voter, present proof of citizenship to the secretary of  
20 the county election board in the county where the voter is  
21 registered. Voters may present legible copies of qualifying  
22 documents in person or by mail, electronic mail, facsimile, or any  
23 other secure method approved by the Secretary.

1 C. If a voter fails to present proof of citizenship within the  
2 prescribed time to the county election board or otherwise provides  
3 notice that the voter is not a citizen, then the voter's  
4 registration shall be canceled, and the voter shall be reported to  
5 the appropriate district attorney and United States attorney.

6 D. For purposes of this section, "proof of citizenship" shall  
7 mean any citizenship-confirming document that meets the minimum  
8 standards of the REAL ID Act of 2005, Public Law No. 109-13, Section  
9 202(c).

10 E. The Secretary shall promulgate rules and procedures as  
11 necessary to effectuate the provisions of this section.

12 SECTION 3. AMENDATORY 26 O.S. 2021, Section 7-103.2, as  
13 last amended by Section 2, Chapter 264, O.S.L. 2023 (26 O.S. Supp.  
14 2024, Section 7-103.2), is amended to read as follows:

15 Section 7-103.2. A. 1. County election boards shall maintain  
16 a current list of all registered voters in each precinct, which will  
17 reflect the address and party affiliation of each voter. The list  
18 shall be public information.

19 2. The list shall only be shared with a court system if that  
20 court system agrees to regularly provide the names of persons  
21 convicted of a felony in that court system to the Secretary of the  
22 State Election Board and the appropriate secretary of a county  
23 election board, or if the court system is required by state law to  
24 provide such information.

1        3. The list shall note any voter for whom a first-class mailing  
2 from the county election board or the State Election Board was  
3 returned undeliverable.

4        B. 1. The Secretary of the State Election Board shall ensure  
5 that an electronic copy of the voter registration list described in  
6 subsection A of this section is made available ~~to the public,~~ free  
7 of charge, to the following:

8            a. bona fide residents of this state who are citizens of  
9            the United States,

10          b. official representatives of political parties  
11          recognized by the laws of this state,

12          c. candidates for office in this state and their official  
13          representatives, or

14          d. other persons authorized by state law.

15        2. Any person accessing the voter registration list shall be  
16 required to complete an application form approved by the Secretary  
17 that shall include:

18            a. the legal name, address of residence in this state,  
19            telephone number, and electronic mail address of the  
20            person,

21            b. an attestation under penalty of perjury that the  
22            person meets the legal requirements to access the  
23            list, and

1           c.   any additional information deemed necessary by the  
2           Secretary.

3       3.   It shall be unlawful for the recipient of a voter  
4 registration list to use such list for any commercial marketing or  
5 advertising purposes.   Provided, for the purposes of this section, a  
6 commercial purpose shall not include the use of the voter list by  
7 campaigns, political parties, government officials, or public  
8 opinion pollsters to contact or interact with voters.   Under no  
9 circumstances shall this list be made available anywhere on the  
10 Internet.

11       4.   It shall be unlawful for the recipient of a voter  
12 registration list to knowingly provide such list to a foreign  
13 national, foreign commercial interest, or foreign government entity.

14       SECTION 4.   This act shall become effective November 1, 2025.
