22	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:				
23	SECTION 1. AMENDATORY 70 O.S. 2021, Section 3-151.1, is				
24	amended to read as follows:				

1 Section 3-151.1. A. For purposes of establishing a uniform and accurate definition of high school graduation rate for school 2 districts and secondary schools in the this state, the State Board 3 of Education shall adopt and implement a four-year adjusted cohort 4 5 graduation rate and an extended-year adjusted cohort graduation The Board shall utilize and report the four-year adjusted 6 rate. cohort graduation rate and the extended-year adjusted cohort 7 graduation rate at the secondary school site, the school district, 8 9 and the state level, and the graduation rates shall be reported in 10 the aggregate as well as disaggregated by subgroups as required in the Elementary and Secondary Education Act of  $\frac{2001}{1965}$  (ESEA) $_{T}$  as 11 reauthorized by P.L. No. 107-110 114-95, also known as the No Child 12 Left Behind Act of 2001 Every Student Succeeds Act (ESSA). 13

The Board shall use the four-year adjusted cohort graduation Β. 14 rate for purposes of determining the high school graduation rate 15 indicator for the academic performance data calculation beginning 16 with state and district report cards providing results of 17 assessments administered in the 2011-2012 school year. The Board 18 shall use the four-year adjusted cohort graduation rate for 19 establishing the high school graduation rate for measuring alternate 20 year percentage growth targets as set forth in Section 3-151.2 of 21 this title beginning with the 2012-2013 school year. 22

C. The four-year adjusted cohort graduation rate shall bedefined as the number of students who graduate in four (4) years

1 with a standard high school diploma divided by the number of students who entered high school four (4) years earlier, adjusted 2 for transfers in and. Students who transfer out of the school  $\overline{r}$ 3 émigrés or emigrate to another country and deceased students shall 4 5 not be included in the adjusted cohort graduation rate. Twelfthgrade students who transfer into a school after October 1 of any 6 school year shall not be included in the adjusted cohort graduation 7 rate. Students who graduate in four (4) years shall include 8 9 students who earn a standard high school diploma at the end of their 10 fourth year, before the end of their fourth year, and during a summer session immediately following their fourth year. To remove a 11 12 student from a cohort, a school district shall confirm in writing or by electronic means that a student has transferred out of the school 13 site or school district, has emigrated to another country, or is 14 deceased. For a student who transfers out of a school site or 15 school district, the written or electronic confirmation shall be 16 official and document that the student has enrolled in another 17 school site or school district or in an educational program that 18 culminates in a high school diploma recognized by a state or private 19 higher educational institution accredited or recognized by the 20 Oklahoma State Regents for Higher Education for purposes of 21 admission to the institution. Students who are not enrolled in a 22 program which culminates in the award of a credential recognized by 23 a state or private higher educational institution for purposes of 24

admissions shall not be included in the graduation rate calculation as set forth in this subsection as a student who graduated in four (4) years with a standard high school diploma but shall be included in the number of students who entered high school four (4) years earlier.

The extended-year adjusted cohort graduation rate shall be 6 D. defined as the number of students who graduate in four (4) years or 7 five (5) years with a high school diploma divided by the number of 8 9 students who form the adjusted cohort for the four-year graduation rate as calculated as provided for in subsection C of this section $_{ au}$ 10 provided that the adjustments add to the cohort all students who 11 12 transfer into the cohort by the end of the year of graduation being considered and subtract students who transfer out, emigrate to 13 another country or are deceased by the end of that year. 14 The extended-year adjusted cohort graduation rate shall be reported 15 separately from the four-year adjusted cohort graduation rate. 16

17SECTION 2.AMENDATORY70 O.S. 2021, Section 1210.545, is18amended to read as follows:

Section 1210.545. A. Except as otherwise provided, as part of the accountability system developed as provided for in Section 1210.541 of this title, the State Board of Education shall prepare annual reports of the results of the Oklahoma School Testing Program which describe student achievement in the state, and each school site, pursuant to the Elementary and Secondary Education Act of 1965

1 (ESEA) as reauthorized by P.L. No. 114-95, also known as the Every Student Succeeds Act (ESSA), and any related federal regulations. 2 The annual report as required pursuant to subsection A of 3 Β. this section shall identify school sites as having one of the 4 5 following grades for each indicator, separately, and by a single overview grade of all indicators, defined according to rules of the 6 State Board of Education: 7 1. "A" means schools making excellent progress; 8 9 2. "B" means schools making above average progress; "C" means schools making satisfactory progress; 10 3. 4. "D" means schools making less than satisfactory progress; 11 12 and 5. "F" means schools failing to make adequate progress. 13 Each school that has students who are tested and included in С. 14 the school grading system as provided for in this section shall 15 receive a school grade, except as follows: 16 1. A school shall not receive a school grade if the number of 17 students tested and included in the school grading system is less 18 than the minimum sample size necessary for statistical reliability 19 and prevention of the unlawful release of personally identifiable 20 student data. The State Board of Education is directed to establish 21

the lowest minimum sample size necessary to meet the requirements of

2. The academic performance of students who are enrolled fulltime in an online program that is offered by a school district or charter school that is not the district of residence or is not located in the district of residence of the student shall be reported separately by the school district or charter school and shall not be included when determining the grade of the school site or charter school.

D. The State Board of Education may adopt alternate systems of
accountability for statewide virtual charter schools, alternative
education programs as defined in Section 1210.568 of this title, and
schools serving only grades prekindergarten or kindergarten through
two.

E. The grade of a school shall be based on a multimeasures approach to accountability in accordance with the Elementary and Secondary Education Act of 1965 (ESEA) as reauthorized by P.L. No. 14-95, also known as the Every Student Succeeds Act (ESSA) and any federal regulations that include, but are not limited to, the following indicators:

Statewide assessments, including the establishment of
 student performance bands;

21 2. Graduation rates for high schools;

3. Statewide academic measures for elementary and middleschools;

24 4. English language proficiency for English learners; and

5. At least one additional statewide measure of school quality
 or student success, including, but not limited to, school climate,
 school safety, student engagement, educator engagement, and/or
 advanced coursework and postsecondary readiness. <u>Chronic</u>
 <u>absenteeism shall not be included as a statewide measure of school</u>
 <u>quality or student success.</u>

F. Of the indicators included in subsection E of this section, not less than seventy percent (70%) of the overview grade <u>must shall</u> be given to indicators 1, 2, 3, and 4 and, in the aggregate, with not more than thirty percent (30%) of the grade given to indicator 5.

G. Further, the grade of an elementary or middle school site shall include, but not be limited to, a measure of status for English language arts (ELA), math, and science, growth in ELA and math, English Language Proficiency Assessment language proficiency assessment (ELPA) progress, and chronic absenteeism the retention rate of teachers over a two-year period, not including teachers who retired during the two-year period.

H. The grade of a high school site shall include, but not be limited to, a measure of status for English language arts (ELA), math and science status, English Language Proficiency Assessment language proficiency assessment (ELPA) progress, graduation rate, chronic absenteeism, and postsecondary opportunities, and the retention rate of teachers over a two-year period, not including

1	teachers who retired during the two-year period. For purposes of
2	this section, postsecondary opportunities shall include Advanced
3	Placement advanced placement, International Baccalaureate, dual and
4	concurrent enrollment, scoring Silver level or above on American
5	College Testing (ACT) WorkKeys, internships, mentorships and
6	apprenticeships, military readiness as evidenced by being accepted
7	for enlistment into any branch of the military within the first year
8	after high school graduation or earning a military readiness score
9	on the Armed Services Vocational Aptitude Battery (ASVAB), and
10	industry certifications. The Board shall adopt a time line timeline
11	for moving from completion of such opportunities to crediting
12	achievement of such opportunities.
13	I. Elementary, middle, and high school sites shall be eligible
14	for the following bonus point amounts to be used in the calculation
15	of the site's single overview grade:
16	1. Up to three bonus points if the school site provides in-
17	person classroom instruction in excess of one hundred seventy-three
18	(173) days and one thousand thirty-eight (1,038) hours, not
19	including in-person classroom instruction time used for professional
20	development or parent-teacher conferences; and
21	2. Up to two bonus points if the school site's chronic
22	absenteeism rate shows improvement.
23	J. The annual report shall identify the performance of each
24	school as having improved, remained the same, or declined. This

school improvement rating shall be based on a comparison of the
 student and school performance data of the current year to the
 previous year data.

J. K. The State Department of Education shall annually develop 4 5 a school site report card to be delivered to parents or legal quardians throughout each school district. The report card shall be 6 in accordance with the requirements of the Elementary and Secondary 7 Education Act of 1965 (ESEA) $_{\tau}$  as reauthorized and amended by P.L. 8 9 No. 114-95, also known as the Every Student Succeeds Act (ESSA) and 10 includes include the grade for the school, information regarding school improvement, an explanation of school performance, and 11 12 indicators of return on investment. The report card for each school 13 site shall be published annually by the Department on its website, and every school district shall provide the school site report card 14 to the parent or legal guardian of each student enrolled in the 15 school site. In order to provide information regarding school 16 17 performance for school report cards issued during the 2016-2017 and 2017-2018 school year years, the Department shall include an 18 explanation of the changes to the statewide system of student 19 assessments as required in Section 1210.508 of this title and how 20 the transition in assessments may impact school performance. The 21 Department shall issue school report cards using the 2016-2017 22 school year assessment data that is available. 23

2	in calculating any performance-based funding policy that is provided
3	to public school districts.
4	M. The State Board of Education shall amend the ESSA
5	Consolidated State Plan in accordance with the requirements of the
6	Every Student Succeeds Act (ESSA) to replace the measure of chronic
7	absenteeism to reflect the provisions of this section. The Board
8	shall submit the proposed amendment to the United States Department
9	of Education no later than August 1, 2025.
10	$\frac{1}{1}$ M. The State Board of Education shall promulgate rules to
11	implement the provisions of this section.
12	SECTION 3. This act shall become effective July 1, 2025.
13	SECTION 4. It being immediately necessary for the preservation
14	of the public peace, health, or safety, an emergency is hereby
15	declared to exist, by reason whereof this act shall take effect and
16	be in full force from and after its passage and approval.
