12	An Act relating to the Progressing Rural Economic Prosperity Fund; amending Section 1, Chapter 411,
13	O.S.L. 2022 (62 O.S. Supp. 2024, Section 256), which relates to the Progressing Rural Economic Prosperity
14	Fund; declaring the fund a continuing fund; determining source of funds; providing for
15	reappropriation of funds; and declaring an emergency.

19	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
20	SECTION 1. AMENDATORY Section 1, Chapter 411, O.S.L.
21	2022 (62 O.S. Supp. 2024, Section 256), is amended to read as
22	follows:
23	Section 256. <u>A.</u> There is hereby created in the State Treasury
24	a special fund to be designated the "Progressing Rural Economic

1	Prosperity Fund", also known as the "PREP Fund". The fund shall be
2	a continuing fund, not subject to fiscal year limitations, and shall
3	consist of all monies received by the Progressing Rural Economic
4	Prosperity Fund from appropriations. Said fund shall be subject to
5	legislative appropriation or transfer as provided by law and shall
6	consist of all such monies as the Legislature may direct to be
7	appropriated or transferred to said fund. Expenditures from said
8	fund pursuant to subsection B of this section shall be made upon
9	warrants issued by the State Treasurer against claims filed as
10	prescribed by law with the Director of the Office of Management and
11	Enterprise Services for approval and payment.
12	B. The following projects shall continue to receive the benefit
13	of funds originally appropriated in amounts from the Progressing
14	Rural Economic Prosperity Fund that may have lapsed, less any amount
15	that has been expended upon the effective date of this act:
16	1. Twenty-five Million Dollars (\$25,000,000.00) appropriated by
17	Section 1 of Enrolled House Bill No. 1019 of the 2nd Extraordinary
18	Session of the 58th Oklahoma Legislature;
