- 10 of Chiropractic Examiners filed on or before February 1, 2025, are
- 11 hereby approved, except for the proposed changes in OAC 140:15-5-5.

- 13 | Care Authority filed on or before February 1, 2025, are hereby
- 14 approved, except for the proposed changes in division (GG) of
- 15 | subparagraph (1) of paragraph (a) of OAC 317:30-5-2.
- SECTION 5. All proposed permanent rules of the Department of
- 17 | Mental Health and Substance Abuse Services filed on or before
- 18 | February 1, 2025, are hereby approved, except for: the proposed
- 19 | changes to the "diversion control plan" and "medical director"
- 20 definitions of OAC 450:70-1-2; the proposed changes to subparagraphs
- 21 (2), (4), (6), and (9) of paragraph (a) of OAC 450:70-4-8.3; the
- 22 proposed changes to subparagraph (3) of paragraph (c) of OAC 450:70-
- 23 6-10; and the proposed changes to paragraph (b) of OAC 450:70-6-
