12	2, Chapter 357, O.S.L. 2023 (26 O.S. Supp. 2024, Section 4-120), which relates to cancellation of
13	voter registrations; requiring cancellation of voter registration under certain circumstance; authorizing
14	the Secretary of the State Election Board to conduct voter registration list comparison with certain
15	entities; requiring provision of notice of non- citizenship to certain voter; requiring furnishing of
16	proof of citizenship to certain county election board; providing for cancellation of voter
17	registration under certain circumstance; defining term; authorizing promulgation of rules for certain
18	purposes; amending 26 O.S. 2021, Section 7-103.2, as last amended by Section 2, Chapter 264, O.S.L. 2023
19	(26 O.S. Supp. 2024, Section 7-103.2), which relates to voter registration list; specifying qualifications
20	for access to certain list; requiring application for certain access; prohibiting access to voter
21	registration list for certain purpose; prohibiting transmission of list to certain foreign entities;
22	providing for codification; and providing an effective date.

1 2 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: SECTION 1. AMENDATORY 26 O.S. 2021, Section 4-120, as 3 last amended by Section 2, Chapter 357, O.S.L. 2023 (26 O.S. Supp. 4 5 2024, Section 4-120), is amended to read as follows: Section 4-120. A. The registration of any registered voter 6 shall be canceled only for one of the following reasons: 7 1. Written notice from the voter pursuant to Section 4-120.1 of 8 9 this title; 2. Death; 10 3. Conviction of a felony; 11 Judicial determination of mental incapacitation under Title 12 4. 13 30 of the Oklahoma Statutes; Registration in another county or state; 5. 14 Failure to respond to a confirmation of address mailing and 15 6. failure to vote as prescribed in Section 4-120.2 of this title; 16 7. The surrendering of the voter's Oklahoma driver license to 17 Service Oklahoma upon being issued a driver license in another 18 state; or 19 8. Being excused from jury duty for not being a citizen of the 20 United States; or 21 9. Determination that the voter is not a citizen of the United 22 States. 23 24

B. For purposes of this section, paragraphs 5 and 7 of
 subsection A of this section shall constitute confirmation from the
 voter to cancel his or her voter registration due to a change of
 residence.

C. A list of voter registrations that were canceled during the
previous twenty-four (24) months, and the reason for the
cancellation, shall be made available to the public.

8 SECTION 2. NEW LAW A new section of law to be codified 9 in the Oklahoma Statutes as Section 4-122 of Title 26, unless there 10 is created a duplication in numbering, reads as follows:

A. The Secretary of the State Election Board may compare the list of registered voters in this state with the database of any federal, state, or local agency, board, or commission that maintains information regarding the citizenship of persons residing in this state.

If a registered voter definitively matches a person who is 16 Β. recorded in a database described in subsection A of this section as 17 not being a citizen of the United States, the Secretary or his or 18 her designee shall send a notice of such finding to the voter. 19 The voter shall, within thirty (30) days from the date the notice is 20 sent to the voter, present proof of citizenship to the secretary of 21 the county election board in the county where the voter is 22 registered. Voters may present legible copies of qualifying 23

documents in person or by mail, electronic mail, facsimile, or any
 other secure method approved by the Secretary.

C. If a voter fails to present proof of citizenship within the prescribed time to the county election board or otherwise provides notice that the voter is not a citizen, then the voter's registration shall be canceled, and the voter shall be reported to the appropriate district attorney and United States attorney.

D. For purposes of this section, "proof of citizenship" shall
mean any citizenship-confirming document that meets the minimum
standards of the REAL ID Act of 2005, Public Law No. 109-13, Section
202(c).

12 E. The Secretary shall promulgate rules and procedures as13 necessary to effectuate the provisions of this section.

17 Section 7-103.2. A. 1. County election boards shall maintain 18 a current list of all registered voters in each precinct, which will 19 reflect the address and party affiliation of each voter. The list 20 shall be public information.

2. The list shall only be shared with a court system if that

 22 court system agrees to regularly provide the names of persons
 23 convicted of a felony in that court system to the Secretary of the
 24 State Election Board and the appropriate secretary of a county

3 3. The list shall note any voter for whom a first-class mailing
4 from the county election board or the State Election Board was
5 returned undeliverable.

B. <u>1.</u> The Secretary of the State Election Board shall ensure
that an electronic copy of the voter registration list described in
subsection A of this section is made available to the public, free
of charge, to the following:

10a.bona fide residents of this state who are citizens of11the United States,

- 12 <u>b.</u> <u>official representatives of political parties</u>
 13 recognized by the laws of this state,
- 14 <u>c.</u> <u>candidates for office in this state and their official</u> 15 representatives, or
- 16 d. other persons authorized by state law.

17 <u>2. Any person accessing the voter registration list shall be</u> 18 <u>required to complete an application form approved by the Secretary</u> 19 <u>that shall include:</u>

- 20 <u>a.</u> the legal name, address of residence in this state,
 21 <u>telephone number, and electronic mail address of the</u>
 22 <u>person,</u>

1	b. an attestation under penalty of perjury that the
2	person meets the legal requirements to access the
3	list, and
4	c. any additional information deemed necessary by the
5	Secretary.
6	3. It shall be unlawful for the recipient of a voter
7	registration list to use such list for any commercial marketing or
8	advertising purposes. Provided, for the purposes of this section, a
9	commercial purpose shall not include the use of the voter list by
10	campaigns, political parties, government officials, or public
11	opinion pollsters to contact or interact with voters. Under no
12	circumstances shall this list be made available anywhere on the
13	Internet.
14	4. It shall be unlawful for the recipient of a voter
15	registration list to knowingly provide such list to a foreign
16	national, foreign commercial interest, or foreign government entity.
17	SECTION 4. This act shall become effective November 1, 2025.
