9	POLICY COMMITTEE RECOMMENDATION			
10	An Act relating to the Oklahoma Open Records Act; amending 51 O.S. 2021, Sections 24A.3, as last			
11	amended by Section 1, Chapter 358, O.S.L. 2024, and 24A.5, as last amended by Section 2, Chapter 116,			
12	O.S.L. 2024 (51 O.S. Supp. 2024, Sections 24A.3 and 24A.5), which relate to definitions and inspection			
13	and copying of records; modifying definition; authorizing public body to require advance payment			
14	for certain records requests; requiring return of portion of advance payment under certain			
15	circumstances; authorizing use of form for records requests; authorizing public body to request			
16	clarification for certain records requests; establishing requirements for specificity of records			
17	requests; allowing denial of records requests under certain circumstances; updating statutory references; updating statutory language; and providing an			
18	effective date.

21	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:			
22	SECTION 1. AMENDATORY 51 O.S. 2021, Section 24A.3, as			
23	last amended by Section 1, Chapter 358, O.S.L. 2024 (51 O.S. Supp			
24	2024, Section 24A.3), is amended to read as follows:			

Section 24A.3. As used in the Oklahoma Open Records Act: 1 "Record" means all documents including, but not limited to, 1. 2 any book, paper, photograph, microfilm, data files created by or 3 used with computer software, computer tape, disk, record, sound 4 recording, film recording, video record or other material regardless 5 of physical form or characteristic, created by, received by, under 6 the authority of, or coming into the custody, control or possession 7 of public officials, public bodies or their representatives in 8 connection with the transaction of public business, the expenditure 9 of public funds or the administering of public property. Record 10 shall also mean applications and other documents related to 11 12 licensure matters that are filed of record in a district court, including, but not limited to, marriage licenses, process server 13 licenses, closing out sale licenses, transient merchant licenses, 14 pool hall licenses, and bail bondsmen registration. Record does not 15 mean: 16

a. computer software, or

b. nongovernment personal effects;

2. "Public body" shall include, but not be limited to, any office, department, board, bureau, commission, agency, trusteeship, authority, council, committee, trust or any entity created by a trust, county, city, village, town, township, district, school district, fair board, court, executive office, advisory group, task force, study group or any subdivision thereof, supported in whole or

in part by public funds or entrusted with the expenditure of public 1 funds or administering or operating public property, and all 2 committees, or subcommittees thereof. Except for the records 3 required by Section 24A.4 of this title, public body does not mean 4 judges, justices, the Council on Judicial Complaints, the 5 Legislature or legislators. Public body shall not include an 6 organization that is exempt from federal income tax under Section 7 501(c)(3) of the Internal Revenue Code of 1986, as amended, and 8 whose sole beneficiary is a college or university, or an affiliated 9 entity of the college or university, that is a member of The 10 Oklahoma State System of Higher Education. Such organization shall 11 12 not receive direct appropriations from the Legislature. The following persons shall not be eligible to serve as a voting member 13 of the governing board of the organization: 14 a member, officer, or employee of the Oklahoma State a. 15 Regents for Higher Education, 16 b. a member of the board of regents or other governing 17

board of the college or university that is the sole beneficiary of the organization, or

c. an officer or employee of the college or university
 that is the sole beneficiary of the organization;
 3. "Public office" means the physical location where public
 bodies conduct business or keep records;

4. "Public official" means any official or employee of any
 public body as defined herein; and

5. "Law enforcement agency" means any public body charged with 3 enforcing state or local criminal laws and initiating criminal 4 prosecutions including, but not limited to<sub> $\tau$ </sub>: police departments<sub> $\tau$ </sub>; 5 state and local fire marshals when investigating potential 6 violations of federal, state, or local criminal laws or when acting 7 on behalf of a law enforcement agency; county sheriffs<sub> $\tau$ </sub>; the 8 Department of Public Safety $_{\tau}$ ; the Oklahoma State Bureau of Narcotics 9 and Dangerous Drugs Control,; the Alcoholic Beverage Laws 10 Enforcement Commission $_{\tau}$ ; and the Oklahoma State Bureau of 11 12 Investigation. SECTION 2. AMENDATORY 51 O.S. 2021, Section 24A.5, as 13 last amended by Section 2, Chapter 116, O.S.L. 2024 (51 O.S. Supp. 14 2024, Section 24A.5), is amended to read as follows: 15 Section 24A.5. All records of public bodies and public 16 officials shall be open to any person for inspection, copying, or 17 mechanical reproduction during regular business hours; provided: 18 The Oklahoma Open Records Act, Sections 24A.1 through 24A.30 1. 19 24A.34 of this title, does not apply to records specifically 20 required by law to be kept confidential including: 21 records protected by a state evidentiary privilege a. 22 such as the attorney-client privilege, the work 23 24

product immunity from discovery and the identity of informer privileges,

- b. records of what transpired during meetings of a public body lawfully closed to the public such as executive sessions authorized under the Oklahoma Open Meeting Act,
- c. personal information within driver records as defined by the Driver's Privacy Protection Act, 18 <del>United</del> <del>States Code</del> U.S.C., Sections 2721 through 2725,
- information in the files of the Board of Medicolegal d. 10 Investigations obtained pursuant to Sections 940 and 11 941 of Title 63 of the Oklahoma Statutes that may be 12 hearsay, preliminary unsubstantiated investigation-13 related findings, or confidential medical information, 14 any test forms, question banks and answer keys e. 15 developed for state licensure examinations, but 16
- 17 specifically excluding test preparation materials or 18 study guides,
- 19 f. last names, addresses, Social Security numbers or tax 20 identification numbers, and proof of identification 21 submitted to the Oklahoma Lottery Commission by 22 persons claiming a lottery prize,
- g. unless public disclosure is required by other laws or
   regulations, vehicle movement records of the Oklahoma

Transportation Authority obtained in connection with the Authority's electronic toll collection system, h. personal financial information, credit reports, or other financial data obtained by or submitted to a public body for the purpose of evaluating credit worthiness, obtaining a license, permit, or for the purpose of becoming qualified to contract with a public body,

- i. any digital audio/video recordings of the toll
   collection and safeguarding activities of the Oklahoma
   Transportation Authority,
- j. any personal information provided by a guest at any
   facility owned or operated by the Oklahoma Tourism and
   Recreation Department to obtain any service at the
   facility or by a purchaser of a product sold by or
   through the Oklahoma Tourism and Recreation
   Department,
- 18 k. a <u>United States</u> Department of Defense Form 214 (DD 19 Form 214) filed with a county clerk, including any DD 20 Form 214 filed before July 1, 2002,

## (1) any record in connection with a Motor Vehicle Report issued by the Department of Public Safety,

- (2) personal information within driver records, as defined by the Driver's Privacy Protection Act,
  18 U.S.C., Sections 2721 through 2725, which are stored and maintained by the Department of Public Safety,
- any portion of any document or information provided to m. an agency or entity of the state or a political subdivision to obtain licensure under the laws of this state or a political subdivision that contains an applicant's personal address, personal phone number, personal email address, any government-issued identification numbers, or other contact information; provided, however, lists of persons licensed, the existence of a license of a person, or a business or commercial address, or other business or commercial information disclosable under state law submitted with an application for licensure shall be public record, unless the business or commercial address is the same as the applicant's personal address, except when the applicant permits in writing the disclosure of the address,

- n. an investigative file obtained during an investigation
   conducted by the State Department of Health into
   violations of the Long-Term Care Administrator
   Licensing Act under Title 63 of the Oklahoma Statutes,
   or
- documents, evidence, materials, records, reports, ο. 6 complaints, or other information in the possession or 7 control of the Attorney General or Insurance 8 Department pertaining to an evaluation, examination, 9 investigation, or review made pursuant to the 10 provisions of the Patient's Right to Pharmacy Choice 11 12 Act, the Pharmacy Audit Integrity Act, or Sections 357 through 360 of Title 59 of the Oklahoma Statutes; 13

All Social Security numbers included in a record may be
confidential regardless of the person's status as a public employee
or private individual and may be redacted or deleted prior to
release of the record by the public body;

3. Any reasonably segregable portion of a record containing exempt material shall be provided after deletion of the exempt portions; provided, however, the Department of Public Safety shall not be required to assemble for the requesting person specific information, in any format, from driving records relating to any person whose name and date of birth or whose driver license number is not furnished by the requesting person.

The Oklahoma State Bureau of Investigation shall not be required to assemble for the requesting person any criminal history records relating to persons whose names, dates of birth, and other identifying information required by the Oklahoma State Bureau of Investigation pursuant to administrative rule are not furnished by the requesting person;

Any request for a record which contains individual records 4. 7 of persons, and the cost of copying, reproducing or certifying each 8 individual record is otherwise prescribed by state law, the cost may 9 be assessed for each individual record, or portion thereof requested 10 as prescribed by state law. Otherwise, a public body may charge a 11 12 fee only for recovery of the reasonable, direct costs of record copying, or mechanical reproduction. Notwithstanding any state or 13 local provision to the contrary, in no instance shall the record 14 copying fee exceed twenty-five cents (\$0.25) per page for records 15 having the dimensions of eight and one-half (8 1/2) by fourteen (14)16 inches or smaller, or a maximum of One Dollar (\$1.00) per copied 17 page for a certified copy. However, if the request: 18 is solely for commercial purpose, or a. 19

b. would clearly cause excessive disruption of the
essential functions of the public body,
then the public body may charge a reasonable fee to recover the
direct cost of record search and copying; however, publication in a
newspaper or broadcast by news media for news purposes shall not

constitute a resale or use of a record for trade or commercial 1 purpose and charges for providing copies of electronic data to the 2 news media for a news purpose shall not exceed the direct cost of 3 making the copy. The fee charged by the Department of Public Safety 4 for a copy in a computerized format of a record of the Department 5 shall not exceed the direct cost of making the copy unless the fee 6 for the record is otherwise set by law. A public body may require 7 advance payment of the estimated fees authorized under this section 8 when the estimated cost exceeds Seventy-five Dollars (\$75.00) or if 9 the requestor has outstanding fees from previous requests. Any 10 portion of an advance payment that exceeds the costs of responding 11 12 to the request shall be returned to the requestor.

Any public body establishing fees under this act the Oklahoma <u>Open Records Act</u> shall post a written schedule of the fees at its principal office and with the county clerk.

In no case shall a search fee be charged when the release of records is in the public interest, including, but not limited to, release to the news media, scholars, authors and taxpayers seeking to determine whether those entrusted with the affairs of the government are honestly, faithfully, and competently performing their duties as public servants.

The fees shall not be used for the purpose of discouraging requests for information or as obstacles to disclosure of requested information;

5. The land description tract index of all recorded instruments concerning real property required to be kept by the county clerk of any county shall be available for inspection or copying in accordance with the provisions of the Oklahoma Open Records Act; provided, however, the index shall not be copied or mechanically reproduced for the purpose of sale of the information;

A public body must provide prompt, reasonable access to its 6. 7 records but may establish reasonable procedures which protect the 8 integrity and organization of its records and to prevent excessive 9 disruptions of its essential functions. A delay in providing access 10 to records shall be limited solely to the time required for 11 preparing the requested documents and the avoidance of excessive 12 disruptions of the public body's essential functions. In no event 13 may production of a current request for records be unreasonably 14 delayed until after completion of a prior records request that will 1.5 take substantially longer than the current request. Any public body 16 which makes the requested records available on the Internet shall 17 meet the obligation of providing prompt, reasonable access to its 18 records as required by this paragraph; 19

20 7. A public body may require a requestor to complete a records
21 request form. If a records request does not describe the requested
22 records with reasonable specificity, a public body may ask the
23 requestor to clarify the request. To have reasonable specificity, a

2		requested records would have been created or	
3		transmitted,	
4	b.	seek identifiable records, rather than general	
5		information without any qualifiers or other	
6		specifications, and	
7	<u>C.</u>	include search terms that are sufficiently specific to	
8		assist the public body in identifying the requested	
9		records.	
10	<u>If a publ</u>	ic body has engaged with the requestor to seek the	
11	information n	eeded to fulfill the request and to identify the	
12	records sought by the requestor, including providing the requestor		
13	with general	topics or a specific list of records related to the	
14	request, the	request may be denied if it is still not reasonably	
15	<pre>specific; and</pre>		
16	<del>7.</del> <u>8.</u> A	public body shall designate certain persons who are	
17	authorized to	release records of the public body for inspection,	
18	copying, or m	echanical reproduction. At least one person shall be	
19	available at	all times to release records during the regular	
20	business hours of the public body.		
21	SECTION 3	. This act shall become effective November 1, 2025.
