11	An Act relating to the Uniform Commercial Code; amending 12A O.S. 2021, Sections 1-9-320.2, 1-9-
12	320.3, 1-9-320.4, 1-9-320.6, as amended by Section 1, Chapter 109, O.S.L. 2022, and 1-9-525 (12A O.S. Supp.
13	2024, Section 1-9-320.6), which relate to secured transactions; transferring certain authority from
14	Secretary of State to Oklahoma County Clerk; directing Oklahoma County Clerk to take certain
15	actions; modifying certain filing procedures; amending 28 O.S. 2021, Section 111, as amended by
16	Section 2, Chapter 109, O.S.L. 2022 (28 O.S. Supp. 2024, Section 111), which relates to fees to be
17	charged by Secretary of State; transferring certain fees from Secretary of State to Oklahoma County
18	Clerk; updating statutory language; and providing a conditional effective date.

21	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
22	SECTION 1. AMENDATORY 12A O.S. 2021, Section 1-9-320.2,

1	DEFINITIONS; REQUISITES OF AN
2	EFFECTIVE FINANCING STATEMENT
3	As used in this section and Sections 1-9-320.1 through 1-9-320.7
4	of this title:
5	(a) "Buyer in the ordinary course of business" means a
6	person who, in the ordinary course of business, buys
7	farm products from a person engaged in farming
8	operations who is in the business of selling farm
9	products.
10	(b) "Central filing system" means a system for filing
11	effective financing statements on a statewide basis
12	and which has been certified by the Secretary of the
13	United States Department of Agriculture.
14	(c) "Commission merchant" means any person engaged in the
15	business of receiving any farm product for sale, on
16	commission, or for or on behalf of another person.
17	(d) "Effective financing statement" means a statement
18	that:
19	(i) is an original or reproduced form consistent with
20	the provisions of this act and approved by the
21	Secretary of State Oklahoma County Clerk;
22	(ii) is signed and filed with the Secretary of State
23	Oklahoma County Clerk by the secured party;
24	(iii) is signed by the debtor;

1 contains: (iv) the name and address of the secured party, 2 (A) 3 the name and address of the person indebted (B) to the secured party, 4 5 (C) the social security number of the debtor or, in the case of a debtor doing business other 6 than as an individual, the Internal Revenue 7 Service taxpayer identification number of 8 9 such debtor, 10 (D) the farm product name, each county in this state where the farm 11 (E) 12 product is produced or to be produced or a 13 blanket code covering all 77 Oklahoma counties, 14 a description of the farm products subject 15 (F) to the security interest only if needed to 16 distinguish it from other such farm products 17 owned by the same person or persons but not 18 subject to the particular interest; and 19 the crop year, unless every crop of the farm 20 (G) product in question, for the duration of the 21 effective financing statement, is to be 22 subject to the particular security interest. 23 24

2	(3) months, similarly signed and filed, to

 5 years from the date of filing, subject to

- "Farm product" means an agricultural commodity such as 1 (e) wheat, corn, soybeans, or a species of livestock such 2 as cattle, hogs, sheep, horses, or poultry used or 3 produced in farming operations, or a product of such 4 5 crop or livestock in its unmanufactured state (such as ginned cotton, wool-clip, maple syrup, milk, and 6 eggs), that is in the possession of a person engaged 7 in farming operations. 8
- 9 (f) "Knows" or "knowledge" means actual knowledge.
- 10 (g) "Person" means any individual, partnership, 11 corporation, limited liability company, trust, or any 12 other business entity.
- (h) "Security interest" means an interest in farm products
 that secures payment or performance of an obligation.
- (i) "Selling agent" means any person, other than a
 commission merchant, who is engaged in the business of
 negotiating the sale and purchase of any farm product
 on behalf of a person engaged in farming operations.
- 19 (2) Unless otherwise provided for in this act, for purposes of 20 this section and Sections 4 and 6 of this act, receipt of notice 21 shall be presumed if notice is sent by first-class mail, postage 22 prepaid.

CENTRAL FILING SYSTEM RELATING TO FARM PRODUCTS 16 (1)The Secretary of State Oklahoma County Clerk shall be 17 responsible for developing and implementing maintaining the central 18 filing system. This responsibility shall include obtaining the 19 necessary certification for the system from the United States 20 Department of Agriculture ("USDA") (USDA). The effective date for 21 the implementation of the central filing system was October 24, 1988 22 shall be one hundred eighty (180) days from the certification of the 23 central filing system by the USDA. 24

4	record the date and, hour, minute, and second of the
5	filing of each effective financing statement;
6	(b) The Secretary of State Oklahoma County Clerk shall
7	compile all effective financing statements into a
8	master list:
9	(i) organized according to farm products;
10	(ii) arranged within each such product:
11	(A) in alphabetical order according to the last
12	name of the individual debtors or, in the
13	case of debtors doing business other than as
14	individuals, the first word in the name of
15	the debtors;
16	(B) in numerical order according to the Social
17	Security number of the individual debtors
18	or, in the case of debtors doing business
19	other than as individuals, the Internal
20	Revenue Service taxpayer identification
21	number of the debtors;
22	(C) geographically by county produced; and
23	(D) by crop year; and
24	

1	(iii) containing the information provided for in
2	subparagraph (iv) of paragraph (d) of Section 1-
3	9-320.2 of this title ;
4	(iv) portions of the master list shall be available in
5	hard copy, electronic formats, or via Internet
6	download, and may be organized by other sorting
7	methods in addition to the methods listed above.
8	(c) The Secretary of State Oklahoma County Clerk shall
9	maintain records of all buyers of farm products,
10	commission merchants, selling agents and others who
11	register with the Secretary of State Oklahoma County
12	<u>Clerk</u> , on a form containing:
13	(i) the name and address of each registrant;
14	(ii) the information on the farm product or products
15	that the registrant is requesting;
16	(iii) the name of each county where the product is
17	produced or to be produced, or a blanket code
18	covering all seventy-seven (77) counties of this
19	state; and
20	(iv) an authorized signature.
21	(d) (i) A copy of those portions of the master list
22	covering the information requested by a
23	registrant shall be distributed to such
24	registrants by the Secretary of State Oklahoma

1County Clerk on or before the last business day2of each month and shall be presumed to have been3received by the third business day of the4following month.

- 5 (ii) Registrants shall be deemed to be registered only 6 as to those portions of the master list for which 7 they register, and shall be deemed to have failed 8 to register and shall not be considered to be 9 registrants as to those portions for which they 10 do not register.
- (iii) Registrants are subject only to security interests shown on the portions of the master list which they receive as a consequence of registration with the Secretary of State Oklahoma County Clerk.
- 16 (iv) If a particular security interest is shown on the 17 master list, but was included since the last 18 regular distribution of portions of the master 19 list to registrants, registrants shall not be 20 subject to that security interest;
- (e) The duration of the registration with the Secretary of
 State Oklahoma County Clerk of a buyer of farm
 products, commission merchant, selling agent or other
 registrant shall be one (1) year from the effective

date of the registration with the Secretary of State Oklahoma County Clerk.

- (f) (i) Upon request, within twenty-four (24) hours of any inquiry, for information, the Secretary of State Oklahoma County Clerk shall provide verbal confirmation of the existence or nonexistence of any effective financing statement on file. By the close of the business day following the day on which the request was received, written confirmation of the existence of an effective financing statement will be provided to buyers of farm products, commission merchants, and selling agents who have not registered, and others who request it.
- The state or political subdivision shall not be (ii) 15 liable if a loss or claim results from any 16 confirmation of the existence or nonexistence of 17 any effective financing statement on file in the 18 Office of the Secretary of State Oklahoma County 19 Clerk's office made in good faith by an employee 20 of the Office of the Secretary of State Oklahoma 21 County Clerk's office as required by the 22 provisions of this section. 23

(5) (4) The filing in the office of the Secretary of State
 Oklahoma County Clerk under this section shall be in addition to the
 filing requirements provided for in this article.

(6) (5) A financing or continuation statement covering farm 4 5 products that has not lapsed and which was filed pursuant to this title between December 23, 1986, and October 24, 1988, inclusive, 6 and for which no written notice was furnished as provided in Section 7 1-9-320.7 of this title, shall become ineffective as to a buyer of 8 9 farm products, commission merchant or selling agent, unless the secured party files an effective financing statement in the office 10 of the Secretary of State Oklahoma County Clerk. 11

12 (7) (6) An effective financing statement shall not be deemed 13 filed in accordance with the provisions of this section until all 14 fees authorized by Section 111 of Title 28 of the Oklahoma Statutes 15 relating to the filing of the statement are tendered to the 16 Secretary of State Oklahoma County Clerk.

(8) (7) The secured party shall file a termination statement 17 within twenty (20) days after there is no outstanding secured 18 obligation or commitment to make advances, incur obligations or 19 otherwise give value. The termination statement shall refer to the 20 unique document ID number. The secured party shall not be required 21 to file a termination statement if the debtor, in writing, addressed 22 to the secured party, requests that a termination not be filed. The 23 request shall be signed by the debtor or an authorized 24

1 representative and the request may be made at any time prior to the expiration date of an effective financing statement set forth 2 herein. If the affected secured party fails to file a termination 3 statement as required by this subsection, the party shall be liable 4 5 to the Secretary of State Oklahoma County Clerk for Five Hundred Dollars (\$500.00). In addition the affected secured party shall be 6 liable to the debtor for any loss caused to the debtor by the 7 failure to terminate the effective financing statement. 8

9 (9) (8) The Attorney General Oklahoma County District Attorney 10 shall be responsible for enforcing the provisions of subsection (8) (7) of this section on behalf of the Secretary of State Oklahoma 11 12 County Clerk and is authorized to take appropriate actions to collect any penalties owed to the Secretary of State Oklahoma County 13 Clerk pursuant to subsection $\frac{(8)}{(7)}$ (7) of this section. When 14 collected, the Oklahoma County District Attorney General shall cause 15 the penalty to be deposited into the Central Filing System Revolving 16 Fund Oklahoma County Clerk's Uniform Commercial Code Central Filing 17 Fund created pursuant to Section 276.3 of Title 62 of the Oklahoma 18 Statutes Section 1-9-525.1 of Title 12A of the Oklahoma Statutes. 19 As the purpose of an effective financing statement filing 20 (9) is to ensure that a joint check is made payable to the debtor and 21 all applicable secured parties, there shall be no priority among 22 filings. Filings shall be processed according to the order in which 23 they were filed, as recorded in a timestamp within the filing. 24

1	(10) All active filings on the effective date of this act, as
2	provided in paragraph (1) of this section, shall be filed with the
3	Oklahoma County Clerk's office. Each active filing that is filed
4	pursuant to the requirements of this paragraph shall be accompanied
5	with a transition document that shall be provided by the Oklahoma
6	County Clerk's office. The Oklahoma County Clerk's office shall
7	charge no fee for active filings that are migrated to the system
8	maintained by the Oklahoma County Clerk.

21	electronic medium authorized by filing-office rule.
22	(b) The number of names required to be indexed does not affect
23	the amount of the fee in subsection (a) of this section.
24	

(c) The fee for responding to a request for information from
 the filing office in any medium designated by the filing office,
 including issuing a certificate showing whether there is on file any
 financing statement naming a particular debtor, is Ten Dollars
 (\$10.00) for each debtor.

6 (d) The fee for a copy of a record is One Dollar (\$1.00) per7 page regardless of the medium used.

This section does not require a fee with respect to a 8 (e) 9 record of a mortgage which is effective as a financing statement filed as a fixture filing or as a financing statement covering as-10 extracted collateral or timber to be cut under subsection (c) of 11 12 Section 1-9-502 of this title. However, the recording and 13 satisfaction fees that otherwise would be applicable to the record of the mortgage apply pursuant to paragraphs 1, 2, 4, 7, 11, 15 and 14 16 of subsection A of Section 32 of Title 28 of the Oklahoma 15 Statutes. 16

17 (f) The fee for providing certified copies shall be One Dollar
18 (\$1.00) per page regardless of medium.

(g) The fee for providing bulk data of indexed records as described in subsection (f) of Section 1-9-523 of this title is as follows:

(1) Five Hundred Dollars (\$500.00) for the initial database history.

24 (2) Fifty Dollars (\$50.00) for weekly updates to the database.

1	(3) Four cents (\$0.04) per page for images of filed records.
2	(h) The filing office may accept payment for fees by automated
3	clearing house or by a nationally recognized debit or credit card.
4	If payment is made by a credit or debit card, the filing office may
5	add an amount equal to the amount of the service charge incurred for
6	the acceptance of the payment. The filing office may enter into
7	contracts for credit card processing services according to
8	applicable county purchasing laws or may enter into agreements with
9	the State Treasurer to participate in any credit card processing
10	agreements entered into by the State Treasurer.

8	specified by this paragraph, the Oklahoma County Clerk
9	shall ensure the integrity of confidential information
10	through data security measures, internal controls, and
11	appropriate database management; and

13	nonexistence of active effective financing statements on file for a
14	debtor in the Oklahoma County Clerk's office, Six Dollars (\$6.00).
15	(j) All fees shall be properly accounted for and shall be paid
16	to the Oklahoma County Clerk monthly. The fees generated by
17	subsection (i) of this section shall be deposited to the credit of
