together with Engrossed House Amendments thereto, beg leave to report that we have had the same under consideration and herewith return the same with the following recommendations:


1. That the House recede from all Amendments.

10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 57 O.S. 2021, Section 38, is
12 amended to read as follows:

13 Section 38. The Department of Corrections shall reimburse any
14 county which is required to retain an inmate pursuant to subsection
15 B F of Section 37 of this title in an amount not to exceed ~~Twenty-~~
16 ~~seven Dollars (\$27.00)~~ Thirty-two Dollars (\$32.00) per day for each
17 inmate during such period of retention, unless the actual daily cost
18 ~~as determined by the Department of Corrections Daily Rate as defined~~
19 ~~in this section,~~ exceeds ~~Twenty-seven Dollars (\$27.00)~~ Thirty-two
20 Dollars (\$32.00). If the actual daily cost as determined by the
21 ~~Department of Corrections Daily Rate~~ county exceeds ~~Twenty-seven~~
22 ~~Dollars (\$27.00)~~ Thirty-two Dollars (\$32.00), the county shall
23 notify the Department of Corrections of the actual daily cost no
24 later than September 30. If the county's actual daily cost is

1 | accepted by the Department ~~that~~, such amount shall be the
2 | reimbursement rate for the county beginning the next fiscal year.
3 | If the Department rejects the county's actual daily cost
4 | application, ~~then~~ the actual daily cost reimbursement shall be
5 | determined by the State Auditor and Inspector and shall be imposed
6 | beginning the next fiscal year. The Department shall distribute the
7 | reimbursement on a monthly basis upon receipt and approval of a
8 | billing statement from the county. The county shall use the
9 | reimbursement to defray expenses of equipping and maintaining the
10 | jail and payment of personnel. ~~The provisions in this act shall be~~
11 | ~~implemented by the Department to allow sufficient time for~~
12 | ~~application to FY-2019.~~ The Department of Corrections shall
13 | reimburse the county for the emergency medical care for physical
14 | injury or illness of the inmate retained under this ~~act~~ section if
15 | the injury or illness is directly related to the incarceration and
16 | the county is required by law to provide such care for inmates in
17 | the jail. The Department shall not pay fees for medical care in
18 | excess of the rates established for Medicaid providers. The state
19 | shall not be liable for medical charges in excess of the Medicaid
20 | scheduled rate. The ~~Director~~ Department may accept any inmate
21 | required to have extended medical care upon application of the
22 | county.

23 | SECTION 2. This act shall become effective November 1, 2025.
