7 An Act relating to the Department of Human Services;  
8 requiring that certain funds be utilized for certain  
9 purpose; requiring certain funding be maintained at  
10 certain levels; requiring certain joint approval  
11 prior to certain actions; requiring certain transfers  
12 to certain funds; appropriating certain federal funds  
13 for certain program; authorizing early allocation of  
14 funds under certain conditions; authorizing certain  
15 transfers; requiring the maintenance of certain  
16 records; providing budgeting and expenditure  
17 limitations and procedures; requiring and prohibiting  
18 certain budget procedures; providing an effective  
19 date; and declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. From the funds appropriated to the Department of  
22 Human Services in Enrolled House Bill No. 2766 of the 1st Session of  
23 the 60th Oklahoma Legislature, the sum of Seven Million Seven  
24 Hundred Sixty-two Thousand Four Dollars (\$7,762,004.00) shall be  
used to replace funding no longer available due to the reduction of  
federal matching dollars.

SECTION 2. From the funds appropriated to the Department of  
Human Services in Enrolled House Bill No. 2766 of the 1st Session of  
the 60th Oklahoma Legislature, the Department shall maintain the

1 funding levels for senior nutrition programs from the fiscal year  
2 ending June 30, 2025. The Oklahoma Legislature requires joint  
3 approval from the President Pro Tempore of the Oklahoma State Senate  
4 and the Speaker of the Oklahoma House of Representatives before any  
5 senior nutrition sites may be closed due to declining attendance or  
6 increased operational costs during the fiscal year ending June 30,  
7 2026.

8 SECTION 3. In addition to the funding required in Section 2 of  
9 this act, from the funds appropriated to the Department of Human  
10 Services in Enrolled House Bill No. 2766 of the 1st Session of the  
11 60th Oklahoma Legislature, the sum of Two Million Five Hundred  
12 Thousand Dollars (\$2,500,000.00) shall be used to make permanent the  
13 second meal per day for the ADvantage Waiver Program.

14 SECTION 4. From the funds appropriated to the Department of  
15 Human Services in Enrolled House Bill No. 2766 of the 1st Session of  
16 the 60th Oklahoma Legislature, the Department shall maintain the  
17 funding levels for provider rates and service authorizations for the  
18 Community, Homeward Bound, In-Home Supports Waiver for Adults, In-  
19 Home Supports Waiver for Children, and ADvantage Waivers from the  
20 fiscal year ending June 30, 2025.

21 SECTION 5. From the funds appropriated to the Department of  
22 Human Services in Enrolled House Bill No. 2766 of the 1st Session of  
23 the 60th Oklahoma Legislature for the support of the Developmental  
24 Disability Services Division, in addition to services provided in

1 the fiscal year ending June 30, 2025, the agency may also budget for  
2 and expend funds for family and self-advocate onboarding meetings  
3 and services, professional development for case management,  
4 expansion of crisis services, and enhancements to intake processes  
5 for the purpose of ensuring a stronger, more responsive service  
6 delivery system for Oklahomans with developmental disabilities.

7 SECTION 6. From the funds appropriated to the Department of  
8 Human Services in Enrolled House Bill No. 2766 of the 1st Session of  
9 the 60th Oklahoma Legislature, the Department of Human Services  
10 shall transfer Five Million Six Hundred Thousand Dollars  
11 (\$5,600,000.00) to the credit of the Child Abuse Multidisciplinary  
12 Account established in Section 1-9-103 of Title 10A of the Oklahoma  
13 Statutes, which shall be distributed according to Section 1-9-104 of  
14 Title 10A of the Oklahoma Statutes.

15 SECTION 7. There is hereby appropriated to the Department of  
16 Human Services all federal monies received by the state during the  
17 fiscal year ending June 30, 2026, from the Temporary Assistance for  
18 Needy Families Block Grant and the Child Care and Development Block  
19 Grant to meet the provisions of federal law relating to such grants.

20 SECTION 8. The Director of Human Services may request through  
21 the Director of the Office of Management and Enterprise Services the  
22 early transfer by the Oklahoma Tax Commission of tax collections to  
23 the General Revenue Fund for the purpose of early allocation to the  
24 Department's disbursing funds to alleviate cash-flow problems.

1       SECTION 9.   A.   The Director of the Office of Management and  
2 Enterprise Services shall transfer monies appropriated from the  
3 General Revenue Fund to the Department of Human Services disbursing  
4 funds in the amounts and ratios requested by the agency except that  
5 the cumulative amount transferred shall not exceed the cumulative  
6 amount of equal monthly allotments of the appropriations from the  
7 General Revenue Fund.

8       B.   Monies appropriated or collected for the fiscal year ending  
9 June 30, 2026, may be transferred to these disbursing funds for the  
10 fiscal year ending June 30, 2025, to satisfy encumbrances and  
11 obligations of the fiscal year, provided that monies equal in amount  
12 are transferred from appropriations or collections for the fiscal  
13 year ending June 30, 2025, to the disbursing funds for the fiscal  
14 year ending June 30, 2026, to satisfy encumbrances and obligations  
15 of the fiscal year. All transfer requests shall be in writing to  
16 the Director of the Office of Management and Enterprise Services.

17       C.   The Department of Human Services shall maintain records of  
18 such inter-year transfers.

19       SECTION 10.   The Director of Human Services may request the  
20 Director of the Office of Management and Enterprise Services to  
21 transfer monies between the Department of Human Services Support  
22 Service Providers Grant Program Fund and the Human Services  
23 Disbursing Fund or the Human Services Medical and Assistance Fund,  
24 as needed for the expenditure of funds.

SECTION 11. This act shall become effective July 1, 2025.

SECTION 12. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
