11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
12	SECTION 1. From the funds appropriated to the Oklahoma
13	Department of Agriculture, Food, and Forestry in Enrolled House Bill
14	No. 2766 of the 1st Session of the 60th Oklahoma Legislature, the
15	sum of One Million Dollars (\$1,000,000.00) shall be used for the
16	Oklahoma State University Robert M. Kerr Food and Agricultural
17	Products Center for operational expenses.
18	SECTION 2. From the funds appropriated to the Oklahoma
19	Department of Agriculture, Food, and Forestry in Enrolled House Bill
20	No. 2766 of the 1st Session of the 60th Oklahoma Legislature, the
21	sum of Five Million Two Hundred Thousand Dollars (\$5,200,000.00)
22	shall be used for the extension offices that are affiliated with the
23	Oklahoma State University Cooperative Extension Service.
24	

SECTION 3. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled House Bill No. 2766 of the 1st Session of the 60th Oklahoma Legislature, the sum of One Million Three Hundred Thousand Dollars (\$1,300,000.00) shall be used for research centers that are affiliated with Oklahoma State University Agriculture Experiment Stations.

SECTION 4. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled House Bill No. 2766 of the 1st Session of the 60th Oklahoma Legislature, the sum of Five Million Five Hundred Thousand Dollars (\$5,500,000.00) shall be used for cooperative extension and agriculture research programs that are affiliated with Langston University.

SECTION 5. This act shall become effective July 1, 2025.
SECTION 6. It being immediately necessary for the preservation
of the public peace, health or safety, an emergency is hereby
declared to exist, by reason whereof this act shall take effect and
