17	SECTION 1. NEW LAW A new section of law to be codified
18	in the Oklahoma Statutes as Section 509A of Title 57, unless there
19	is created a duplication in numbering, reads as follows:
20	There is hereby created in the State Treasury a revolving fund
21	for the Department of Corrections to be designated the "Prison
22	Acquisition Revolving Fund". The fund shall be a continuing fund,
23	not subject to fiscal year limitations, and shall consist of all
24	monies designated for deposit by law. All monies accruing to the

1 credit of said fund are hereby appropriated and may be budgeted and expended by the Department for the purpose of, on behalf of the 2 state, completing a purchase of a prison including associated 3 property and equipment from a private prison contractor. 4 5 Expenditures from said fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with 6 7 the Director of the Office of Management and Enterprise Services for approval and payment. 8 9 SECTION 2. AMENDATORY 57 O.S. 2021, Section 509, as last amended by Section 1, Chapter 22, O.S.L. 2023 (57 O.S. Supp. 2024, 10 11 Section 509), is amended to read as follows: 12 Section 509. A.
