14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:										
15	SECTION 1. AMENDATORY Section 1, Chapter 411, O.S.L.										
16	2022 (62 O.S. Supp. 2024, Section 256), is amended to read as										
17	follows:										
18	Section 256. <u>A.</u> There is hereby created in the State Treasury										
19	a special fund to be designated the "Progressing Rural Economic										
20	Prosperity Fund", also known as the "PREP Fund". The fund shall be										
21	a continuing fund, not subject to fiscal year limitations, and shall										
22	consist of all monies received by the Progressing Rural Economic										
23	Prosperity Fund from appropriations. Said fund shall be subject to										
24	legislative appropriation or transfer as provided by law and shall										

1	consist of all such monies as the Legislature may direct to be
2	appropriated or transferred to said fund. <u>Expenditures from said</u>
3	fund pursuant to subsection B of this section shall be made upon
4	warrants issued by the State Treasurer against claims filed as
5	prescribed by law with the Director of the Office of Management and
6	Enterprise Services for approval and payment.
7	B. The following projects shall continue to receive the benefit
