13	SECTION 1. AMENDATORY 74 O.S. 2021, Section 4258.1, is

15	Section 4258.1. There is hereby created in the State Treasury a
16	revolving fund for the Ethics Commission to be designated the
17	"Political Subdivisions Enforcement Fund". The fund shall be a
18	continuing fund, not subject to fiscal year limitations, and shall
19	consist of all funds appropriated by the Legislature to the fund and
20	all late filing fees, fines from settlement agreements and fines
21	assessed by the District Court for violations of the County Campaign
22	Finance and Financial Disclosure Act, the Municipal Campaign Finance
23	and Financial Disclosure Act, and the Technology Center District and
24	Independent School District Campaign Finance and Financial

1 Disclosure Act. All monies accruing to the credit of the fund are 2 hereby appropriated and may be budgeted and expended by the Commission for any expenses incurred by the Political Subdivisions 3 4 Enforcement Division. Expenditures from the fund shall be made upon 5 warrants issued by the State Treasurer against claims filed as 6 prescribed by law with the Director of the Office of Management and 7 Enterprise Services for approval and payment. No later than January 31, 2016, and every year thereafter, the State Treasurer shall 8 9 transfer to the General Revenue Fund of the state any monies in the 10 fund in excess of One Hundred Fifty Thousand Dollars (\$150,000.00) 11 Four Hundred Fifty Thousand Dollars (\$450,000.00). If at any time 12 the amount of money in the fund is less than One Hundred Thousand 13 Dollars (\$100,000.00), the Executive Director of the Commission may 14 order that there be no further enforcement by the Political 15 Subdivisions Enforcement Division until the amount of money in the 16 fund is more than One Hundred Thousand Dollars (\$100,000.00). 17 SECTION 2. It being immediately necessary for the preservation 18 of the public peace, health or safety, an emergency is hereby 19 declared to exist, by reason whereof this act shall take effect and 20 be in full force from and after its passage and approval. 21 22 23 24
