8 permanent rules of certain judicial and public safety  
9 state agencies; disapproving certain proposed  
10 permanent rule filed by the Office of Juvenile  
11 Affairs; disapproving certain proposed permanent rule  
12 filed by the Department of Public Safety; and  
13 directing distribution.

14 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma  
15 Statutes, the Oklahoma State Legislature shall have a joint  
16 resolution prepared for consideration each session.

17 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
18 AND THE SENATE OF THE 1ST SESSION OF THE 60TH OKLAHOMA LEGISLATURE:

19 SECTION 1. The Legislature hereby approves all proposed  
20 permanent rules of the Board of Tests for Alcohol and Drug Influence  
21 filed on or before February 1, 2025.

22 SECTION 2. The Legislature hereby approves all proposed  
23 permanent rules of the Attorney General filed on or before February  
24 1, 2025.

1       SECTION 3. The Legislature hereby approves all proposed  
2 permanent rules of the Oklahoma Department of Emergency Management  
3 filed on or before February 1, 2025.

4       SECTION 4. The Legislature hereby approves all proposed  
5 permanent rules of the Office of Juvenile Affairs (OJA) filed on or  
6 before February 1, 2025, except for 377:1-3-26(c)(2) which is hereby  
7 disapproved.

8       SECTION 5. The Legislature hereby approves all proposed  
9 permanent rules of the Oklahoma State Bureau of Narcotics and  
10 Dangerous Drugs Control (OBNDD) filed on or before February 1, 2025.

11       SECTION 6. The Legislature hereby approves all proposed  
12 permanent rules of the Department of Public Safety filed on or  
13 before February 1, 2025, except for 595:25-5-15(e) which is hereby  
14 disapproved.

15       SECTION 7. The Legislature hereby approves all proposed  
16 permanent rules of the State Board of Licensed Social Workers filed  
17 on or before February 1, 2025.

18       SECTION 8. The Oklahoma Secretary of State is hereby directed  
19 to distribute copies of this resolution to the Governor and the  
20 editor of "The Oklahoma Register".
