SECTION 3. All proposed permanent rules of the Oklahoma Board of Chiropractic Examiners filed on or before February 1, 2025, are hereby approved, except for the proposed changes in OAC 140:15-5-5.

SECTION 4. All proposed permanent rules of the Oklahoma Health Care Authority filed on or before February 1, 2025, are hereby approved, except for the proposed changes in division (GG) of subparagraph (1) of paragraph (a) of OAC 317:30-5-2.

SECTION 5. All proposed permanent rules of the Department of Mental Health and Substance Abuse Services filed on or before February 1, 2025, are hereby approved, except for: the proposed changes to the "diversion control plan" and "medical director" definitions of OAC 450:70-1-2; the proposed changes to subparagraphs (2), (4), (6), and (9) of paragraph (a) of OAC 450:70-4-8.3; the proposed changes to subparagraph (3) of paragraph (c) of OAC 450:70-6-10; and the proposed changes to paragraph (b) of OAC 450:70-6-17.2.
