7 A Joint Resolution approving certain proposed
permanent rules of health-related state agencies;
8 disapproving certain proposed permanent rules of the
Oklahoma Funeral Board, Board of Chiropractic
9 Examiners, Health Care Authority, and Department of
Mental Health and Substance Abuse Services; and
10 directing distribution.

13 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma
14 Statutes, the Oklahoma State Legislature shall have a joint
15 resolution prepared for consideration each session.

16 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
17 AND THE SENATE OF THE 1ST SESSION OF THE 60TH OKLAHOMA LEGISLATURE:

18 SECTION 1. All proposed permanent rules of the Commission on
19 Children and Youth, the State Department of Health, the Department
20 of Human Services, State Board of Medical Licensure and Supervision,
21 the Board of Medicolegal Investigations, the State Board of
22 Osteopathic Examiners, State Board of Examiners of Perfusionists,
23 Health Care Workforce Training Commission, and the Oklahoma Workers'

1 Compensation Commission filed on or before February 1, 2025, are
2 hereby approved.

3 SECTION 2. All proposed permanent rules of the Oklahoma Funeral
4 Board filed on or before February 1, 2025, are hereby approved,
5 except for the proposed changes to paragraph (6) of OAC 235:10-3-2,
6 the proposed changes in the entirety of OAC 235:10-3-4, and the
7 proposed changes in paragraphs (c) and (e) of OAC 235:10-14-1.

8 SECTION 3. All proposed permanent rules of the Oklahoma Board
9 of Chiropractic Examiners filed on or before February 1, 2025, are
10 hereby approved, except for the proposed changes in OAC 140:15-5-5.

11 SECTION 4. All proposed permanent rules of the Oklahoma Health
12 Care Authority filed on or before February 1, 2025, are hereby
13 approved, except for the proposed changes in division (GG) of
14 subparagraph (1) of paragraph (a) of OAC 317:30-5-2.

15 SECTION 5. All proposed permanent rules of the Department of
16 Mental Health and Substance Abuse Services filed on or before
17 February 1, 2025, are hereby approved, except for: the proposed
18 changes to the "diversion control plan" and "medical director"
19 definitions of OAC 450:70-1-2; the proposed changes to subparagraphs
20 (2), (4), (6), and (9) of paragraph (a) of OAC 450:70-4-8.3; the
21 proposed changes to subparagraph (3) of paragraph (c) of OAC 450:70-
22 6-10; and the proposed changes to paragraph (b) of OAC 450:70-6-
23 17.2.

1 SECTION 6. The Oklahoma Secretary of State is hereby directed
2 to distribute copies of this resolution to the Governor and the
3 editor of "The Oklahoma Register".
