10	An Act relating to counties and county officers; amending 19 O.S. 2021, Section 510, which relates to
11	qualifications for county sheriff; permitting military police service to meet experience
12	requirement; requiring certain document be presented when filing; and providing an effective date.

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 19 O.S. 2021, Section 510, is
17	amended to read as follows:
18	Section 510. <u>A.</u> Any person, otherwise qualified, who has been
19	a resident of the State of Oklahoma for two (2) years, has been a
20	registered voter of the party whose nomination he or she seeks, or a
21	registered Independent, within the county from which such person
22	seeks election for the six (6) months next preceding the first day
23	of the filing period, is at least twenty-five (25) years of age next
24	preceding the date of filing for office, possesses at least a high

1 school education and has served as a duly certified peace officer, 2 in a full-time capacity, for a period of four (4) years or more prior to the date of filing for the office of county sheriff, shall 3 4 be eligible to hold the office of county sheriff or to file 5 therefor. Within twelve (12) months of taking office, all newly 6 elected or appointed sheriffs shall complete a sheriff's 7 administrative school which has been developed by the Oklahoma Sheriffs' Association and which has been approved by the Council on 8 9 Law Enforcement Education and Training (CLEET). Failure to complete 10 the sheriff's administrative school within the specified period 11 shall preclude the new sheriff from obtaining CLEET certification. 12 New sheriffs with prior CLEET certification, who fail to attend the 13 sheriff's administrative school, shall have their CLEET 14 certification revoked. Provided, however, the provisions of this 15 section relating to qualifications shall not apply to any person 16 serving as a county sheriff or to any person previously serving as 17 county sheriff prior to the adoption of this statute.

For purposes of this section, "peace officer" shall mean a fulltime duly appointed or elected officer who is paid for working more than twenty-five (25) hours per week and whose duties are to preserve the public peace, protect life and property, prevent crime, serve warrants, and enforce state, federal or military laws and local ordinances of this state or any political subdivision thereof.

1	B. Veterans who have served as military police may count four
2	(4) or more years of service as military police to meet the
3	experience requirement listed in subsection A of this section.
4	Veterans must present a Certificate of Release or Discharge from
5	Active Duty (DD Form 214) when filing as verification of military
6	police experience.
7	SECTION 2. This act shall become effective November 1, 2025.
