12 An Act relating to public finance; imposing duties
13 upon the Office of Management and Enterprise Services
14 with respect to budget procedures for the Oklahoma
15 Department of Mental Health and Substance Abuse
16 Services; specifying procedures; imposing certain
17 requirements related to allocation of funds;
18 providing for codification; and declaring an
19 emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 34.401 of Title 62, unless there
21 is created a duplication in numbering, reads as follows:

22 In addition to other duties imposed upon the Office of
23 Management and Enterprise Services (OMES) by law, the Director of
24 the Office of Management and Enterprise Services shall ensure that

1 the following procedures are strictly adhered to with respect to the
2 Oklahoma Department of Mental Health and Substance Abuse Services:

3 1. In accordance with paragraph 3 of subsection A of Section
4 34.6 of this title, prior to releasing the one-twelfth (1/12)
5 appropriations disbursement, OMES shall conduct a review of the
6 agency's budget to actuals to ensure the agency is staying within
7 budget constraints;

8 2. OMES shall provide a report to the Governor, the Speaker of
9 the Oklahoma House of Representatives, the President Pro Tempore of
10 the Oklahoma State Senate, and the chairs and vice-chairs of the
11 standing committees of the Oklahoma House of Representatives and the
12 Oklahoma State Senate having primary responsibility for the
13 consideration of agency appropriations concerning the status of
14 revenue and expenditures of the agency;

15 3. The Oklahoma Department of Mental Health and Substance Abuse
16 Services shall be prohibited from entering into contracts that do
17 not clearly state a maximum fiscal obligation;

18 4. OMES shall review encumbrances for any multi-year purchase
19 orders or contracts to ensure that only the anticipated amount of
20 funds for the current fiscal year are encumbered; and

21 5. OMES shall prohibit the processing of payments for non-
22 budgeted expenditures.

23 SECTION 2. It being immediately necessary for the preservation
24 of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
