12	An Act relating to the Progressing Rural Economic
13	Prosperity Fund; amending Section 1, Chapter 411, O.S.L. 2022 (62 O.S. Supp. 2024, Section 256), which
14	relates to the Progressing Rural Economic Prosperity Fund; declaring the fund a continuing fund;
15	determining source of funds; providing for reappropriation of funds; and declaring an emergency.

18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. AMENDATORY Section 1, Chapter 411, O.S.L.
20	2022 (62 O.S. Supp. 2024, Section 256), is amended to read as
21	follows:
22	Section 256. <u>A.</u> There is hereby created in the State Treasury
23	a special fund to be designated the "Progressing Rural Economic
24	Prosperity Fund", also known as the "PREP Fund". The fund shall be

1	a continuing fund, not subject to fiscal year limitations, and shall
2	consist of all monies received by the Progressing Rural Economic
3	Prosperity Fund from appropriations. Said fund shall be subject to
4	legislative appropriation or transfer as provided by law and shall
5	consist of all such monies as the Legislature may direct to be
6	appropriated or transferred to said fund. Expenditures from said
7	fund pursuant to subsection B of this section shall be made upon
8	warrants issued by the State Treasurer against claims filed as
9	prescribed by law with the Director of the Office of Management and
10	Enterprise Services for approval and payment.
11	B. The following projects shall continue to receive the benefit
12	of funds originally appropriated in amounts from the Progressing
13	Rural Economic Prosperity Fund that may have lapsed, less any amount
14	that has been expended upon the effective date of this act:
15	1. Twenty-five Million Dollars (\$25,000,000.00) appropriated by
16	Section 1 of Enrolled House Bill No. 1019 of the 2nd Extraordinary
17	Session of the 58th Oklahoma Legislature;
