9                               AS INTRODUCED

10           An Act relating to mental health; amending 43A O.S.  
11           2021, Section 3-318, which relates to rules and  
12           standards for certification of behavioral health case  
13           managers, application for certification, fee, titles,  
14           and compliance; providing uniformity in rules and  
15           standards for certification for behavioral health  
16           case managers; amending 43A O.S. 2021, Section 3-326,  
17           which relates to certification as peer recovery  
18           support specialist, rules, application, fees, titles,  
19           and penalties; providing uniformity in rules and  
20           standards for certification for peer recovery support  
21           specialist; and providing an effective date.

22   BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

23           SECTION 1.           AMENDATORY           43A O.S. 2021, Section 3-318, is  
24           amended to read as follows:

25           Section 3-318.   A.   The Board of Mental Health and Substance  
26           Abuse Services shall promulgate rules and standards for  
27           certification of behavioral health case managers who are:

1        1.    Employed by the state, a municipality, or county;

2        2.    Employed by behavioral services providers contracting with  
3 the state to provide behavioral health services;

4        3.    Employed by organizations certified by the Department of  
5 Mental Health and Substance Abuse Services;

6        4.    Employed by a tribe or tribal facility that provides  
7 behavioral health services; or

8        ~~4.~~ 5.    Employed by an Oklahoma Department of Veterans Affairs or  
9 a United States Department of Veterans Affairs facility.

10       B.    Such rules and standards shall address criteria for  
11 certification and renewal, including minimum education requirements,  
12 examination and supervision requirements, continuing education  
13 requirements, and rules of professional conduct.

14       C.    Application for certification as a behavioral health case  
15 manager shall be made to the Department of Mental Health and  
16 Substance Abuse Services on prescribed forms. The Board, or the  
17 Commissioner of Mental Health and Substance Abuse Services upon  
18 delegation by the Board, may certify the behavioral health case  
19 manager for a period of two (2) years subject to renewal as provided  
20 in the rules promulgated by the Board.

21       D.    The Board is authorized to establish an application and  
22 renewal fee of no more than One Hundred Dollars (\$100.00) to defray  
23 the costs incurred in the certification process.

1 E. Behavioral health case managers certified by the Board or  
2 the Commissioner shall only use the title "certified behavioral  
3 health case manager" if employed by the state, a municipality, or  
4 county, employed by behavioral services providers contracting with  
5 the state to provide behavioral health services, employed by  
6 organizations certified by the Department of Mental Health and  
7 Substance Abuse Services, employed by a tribe or tribal facility  
8 that provides behavioral health services or employed by an Oklahoma  
9 Department of Veterans Affairs or a United States Department of  
10 Veterans Affairs facility. This section shall not be construed to  
11 permit the certified behavioral health case manager to practice any  
12 of the following professions or use the following titles unless also  
13 licensed or accredited by the appropriate authority: physician,  
14 psychologist, clinical social worker, professional counselor,  
15 marital and family therapist, behavioral practitioner, or alcohol  
16 and drug counselor.

17 F. Failure to comply with rules and standards promulgated by  
18 the Board shall be grounds for revocation, suspension or nonrenewal  
19 of certification.

20 G. No behavioral health case manager shall operate or continue  
21 to operate as a behavioral health case manager unless the case  
22 manager complies with the rules promulgated by the Board and is  
23 certified as required by this section.

1       SECTION 2.       AMENDATORY       43A O.S. 2021, Section 3-326, is  
2 amended to read as follows:

3       Section 3-326. A. The Board of Mental Health and Substance  
4 Abuse Services shall promulgate rules for certification of peer  
5 recovery support specialists who are:

6       1. Employed by the state, a municipality, or county;

7       2. Employed by a behavioral services provider contracting with  
8 the state to provide behavioral health services;

9       3. Employed by a behavioral services provider certified by the  
10 Department of Mental Health and Substance Abuse Services. Provided,  
11 however, that certification as a peer recovery support specialist  
12 pursuant to this subsection shall be limited to providing services  
13 within the employer's area of certification;

14       4. Employed by a tribe or a tribal facility that provides  
15 behavioral health services; or

16       5. Employed by an Oklahoma Department of Veterans Affairs or a  
17 United States Department of Veterans Affairs facility.

18       B. Such rules shall address criteria for certification and  
19 renewal, including minimum education requirements, examination and  
20 supervision requirements, continuing education requirements, and  
21 rules of professional conduct.

22       C. Application for certification as a peer recovery support  
23 specialist shall be made to the Department of Mental Health and  
24 Substance Abuse Services on prescribed forms. The Board, or the

1 Commissioner of Mental Health and Substance Abuse Services upon  
2 delegation by the Board, may certify the peer recovery support  
3 specialist for a period of two (2) years subject to renewal as  
4 provided in the rules promulgated by the Board.

5 D. The Board is authorized to establish an application and  
6 renewal fee of no more than One Hundred Dollars (\$100.00) to defray  
7 the costs incurred in the certification process.

8 E. A peer recovery support specialist certified by the Board or  
9 the Commissioner shall only use the title "certified peer recovery  
10 support specialist" if employed by the state, a municipality, or  
11 county, employed by behavioral services providers contracting with  
12 or certified by the state to provide behavioral health services,  
13 employed by a tribe or tribal facility that provides behavioral  
14 health services or employed by an Oklahoma Department of Veterans  
15 Affairs or a United States Department of Veterans Affairs facility.  
16 This section shall not be construed to permit the certified peer  
17 recovery support specialist to practice any of the following  
18 professions or use the following titles unless also licensed or  
19 accredited by the appropriate authority:

- 20 1. Physician;
- 21 2. Psychologist;
- 22 3. Clinical social worker;
- 23 4. Professional counselor;
- 24 5. Marital and family therapist;

1       6. Behavioral practitioner; or

2       7. Alcohol and drug counselor.

3       F. No peer recovery support specialist shall operate or  
4 continue to operate as a peer recovery support specialist unless the  
5 peer recovery support specialist complies with the rules promulgated  
6 by the Board and is certified as required by this section.

7       G. Failure to comply with rules promulgated by the Board shall  
8 be grounds for revocation, suspension, or nonrenewal of  
9 certification.

10       SECTION 3. This act shall become effective November 1, 2026.
