19 SECTION 1. The Legislature hereby approves all proposed

21 Forestry filed on or before February 1, 2025.

22 SECTION 2. The Legislature hereby approves all proposed
23 permanent rules of the Oklahoma Conservation Commission filed on or
24 before February 1, 2025.

1 SECTION 3. The Legislature hereby approves all proposed
2 permanent rules of the Corporation Commission filed on or before
3 February 1, 2025.

4 SECTION 4. The Legislature hereby approves all proposed
5 permanent rules of the Department of Environmental Quality (DEQ)
6 filed on or before February 1, 2025.

7 SECTION 5. The Legislature hereby approves all proposed
8 permanent rules of the Oklahoma Liquefied Petroleum Gas Board filed
9 on or before February 1, 2025.

10 SECTION 6. The Legislature hereby approves all proposed
11 permanent rules of the Oklahoma Tourism and Recreation Department
12 filed on or before February 1, 2025.

13 SECTION 7. The Legislature hereby approves all proposed
14 permanent rules of the Oklahoma Water Resources Board (OWRB) filed
15 on or before February 1, 2025.

16 SECTION 8. The Legislature hereby approves all proposed
17 permanent rules of the Department of Wildlife Conservation filed on
18 or before February 1, 2025.

19 SECTION 9. The Oklahoma Secretary of State is hereby directed
20 to distribute copies of this resolution to the Governor and the
