10 AS INTRODUCED

11 A Joint Resolution approving certain proposed
12 permanent rules of certain judicial and public safety
13 state agencies; disapproving certain proposed
14 permanent rule filed by the Office of Juvenile
15 Affairs; disapproving certain proposed permanent rule
16 filed by the Department of Public Safety; and
17 directing distribution.

18 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma
19 Statutes, the Oklahoma State Legislature shall have a joint
20 resolution prepared for consideration each session.

21 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
22 AND THE SENATE OF THE 1ST SESSION OF THE 60TH OKLAHOMA LEGISLATURE:

1 SECTION 1. The Legislature hereby approves all proposed
2 permanent rules of the Board of Tests for Alcohol and Drug Influence
3 filed on or before February 1, 2025.

4 SECTION 2. The Legislature hereby approves all proposed
5 permanent rules of the Attorney General filed on or before February
6 1, 2025.

7 SECTION 3. The Legislature hereby approves all proposed
8 permanent rules of the Oklahoma Department of Emergency Management
9 filed on or before February 1, 2025.

10 SECTION 4. The Legislature hereby approves all proposed
11 permanent rules of the Office of Juvenile Affairs (OJA) filed on or
12 before February 1, 2025, except for 377:1-3-26(c)(2) which is hereby
13 disapproved.

14 SECTION 5. The Legislature hereby approves all proposed
15 permanent rules of the Oklahoma State Bureau of Narcotics and
16 Dangerous Drugs Control (OBND) filed on or before February 1, 2025.

17 SECTION 6. The Legislature hereby approves all proposed
18 permanent rules of the Department of Public Safety filed on or
19 before February 1, 2025, except for 595:25-5-15(e) which is hereby
20 disapproved.

21 SECTION 7. The Legislature hereby approves all proposed
22 permanent rules of the State Board of Licensed Social Workers filed
23 on or before February 1, 2025.

1 SECTION 8. The Oklahoma Secretary of State is hereby directed
2 to distribute copies of this resolution to the Governor and the
3 editor of "The Oklahoma Register".
