Compensation Commission filed on or before February 1, 2025, are
hereby approved.

SECTION 2. All proposed permanent rules of the Oklahoma Funeral Board filed on or before February 1, 2025, are hereby approved, except for the proposed changes to paragraph (6) of OAC 235:10-3-2, the proposed changes in the entirety of OAC 235:10-3-4, and the proposed changes in paragraphs (c) and (e) of OAC 235:10-14-1.

SECTION 3. All proposed permanent rules of the Oklahoma Board of Chiropractic Examiners filed on or before February 1, 2025, are hereby approved, except for the proposed changes in OAC 140:15-5-5. SECTION 4. All proposed permanent rules of the Oklahoma Health Care Authority filed on or before February 1, 2025, are hereby approved, except for the proposed changes in division (GG) of subparagraph (1) of paragraph (a) of OAC 317:30-5-2.

SECTION 5. All proposed permanent rules of the Department of Mental Health and Substance Abuse Services filed on or before February 1, 2025, are hereby approved, except for: the proposed changes to the "diversion control plan" and "medical director" definitions of OAC 450:70-1-2; the proposed changes to subparagraphs (2), (4), (6), and (9) of paragraph (a) of OAC 450:70-4-8.3; the
