12 A Joint Resolution approving certain proposed
13 permanent rules of health-related state agencies;
14 disapproving certain proposed permanent rules of the
15 Oklahoma Funeral Board, Board of Chiropractic
16 Examiners, Health Care Authority, and Department of
17 Mental Health and Substance Abuse Services; and
18 directing distribution.

19 WHEREAS, pursuant to Section 308.3 of Title 75 of the Oklahoma
20 Statutes, the Oklahoma State Legislature shall have a joint
21 resolution prepared for consideration each session.

22 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
23 AND THE SENATE OF THE 1ST SESSION OF THE 60TH OKLAHOMA LEGISLATURE:

24 SECTION 1. All proposed permanent rules of the Commission on
Children and Youth, the State Department of Health, the Department

1 of Human Services, State Board of Medical Licensure and Supervision,
2 the Board of Medicolegal Investigations, the State Board of
3 Osteopathic Examiners, State Board of Examiners of Perfusionists,
4 Health Care Workforce Training Commission, and the Oklahoma Workers'
5 Compensation Commission filed on or before February 1, 2025, are
6 hereby approved.

7 SECTION 2. All proposed permanent rules of the Oklahoma Funeral
8 Board filed on or before February 1, 2025, are hereby approved,
9 except for the proposed changes to paragraph (6) of OAC 235:10-3-2,
10 the proposed changes in the entirety of OAC 235:10-3-4, and the
11 proposed changes in paragraphs (c) and (e) of OAC 235:10-14-1.

12 SECTION 3. All proposed permanent rules of the Oklahoma Board
13 of Chiropractic Examiners filed on or before February 1, 2025, are
14 hereby approved, except for the proposed changes in OAC 140:15-5-5.

15 SECTION 4. All proposed permanent rules of the Oklahoma Health
16 Care Authority filed on or before February 1, 2025, are hereby
17 approved, except for the proposed changes in division (GG) of
18 subparagraph (1) of paragraph (a) of OAC 317:30-5-2.

19 SECTION 5. All proposed permanent rules of the Department of
20 Mental Health and Substance Abuse Services filed on or before
21 February 1, 2025, are hereby approved, except for: the proposed
22 changes to the "diversion control plan" and "medical director"
23 definitions of OAC 450:70-1-2; the proposed changes to subparagraphs
24 (2), (4), (6), and (9) of paragraph (a) of OAC 450:70-4-8.3; the

1 proposed changes to subparagraph (3) of paragraph (c) of OAC 450:70-
2 6-10; and the proposed changes to paragraph (b) of OAC 450:70-6-
3 17.2.

4 SECTION 6. The Oklahoma Secretary of State is hereby directed
5 to distribute copies of this resolution to the Governor and the
6 editor of "The Oklahoma Register".
