10 An Act relating to higher education; prohibiting
11 certain institutions of higher education from using
12 state funds, property, or resources to support or
13 require certain activities related to diversity,
14 equity, and inclusion; requiring certain institutions
15 of higher education to initiate certain review after
16 certain date; providing for restructuring or
17 elimination of certain unnecessary functions;
18 providing certain construction; requiring certain
19 institutions to submit certain annual certificate of
20 compliance by certain date; providing for
21 promulgation of rules; providing for codification;
22 providing an effective date; and declaring an
23 emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 3251 of Title 70, unless there
is created a duplication in numbering, reads as follows:

1 A. No institution of higher education within The Oklahoma State
2 System of Higher Education shall utilize state funds, property, or
3 resources to:

4 1. Grant or support diversity, equity, and inclusion positions,
5 departments, activities, procedures, or programs to the extent they
6 grant preferential treatment based on one person's particular race,
7 color, ethnicity, or national origin over another's;

8 2. Mandate any person to participate in, listen to, or receive
9 any education, training, activities, procedures, or programming to
10 the extent such education, training, activities, procedures, or
11 programming grants preferences based on one person's particular
12 race, color, sex, ethnicity, or national origin over another's;

13 3. Mandate any person swear, certify, or agree to any loyalty
14 oath that favors or prefers one particular race, color, sex,
15 ethnicity, or national origin over another's;

16 4. Mandate any person to certify or declare agreement with,
17 recognition of, or adherence to any particular political,
18 philosophical, religious, or other ideological viewpoint;

19 5. Mandate any applicant for employment provide a diversity,
20 equity, and inclusion statement or give any applicant for employment
21 preferential consideration based on the provision of such a
22 diversity, equity, and inclusion statement; or

23 6. Mandate any person to disclose his or her pronouns.

1 B. After the effective date of this act, institutions of higher
2 education within The Oklahoma State System of Higher Education shall
3 initiate a review of diversity, equity, and inclusion positions,
4 departments, activities, procedures, and programs and, if deemed
5 necessary, restructure or eliminate functions that are not necessary
6 for compliance, accreditation, or student or employee support
7 services intended to broadly support success.

8 C. Nothing in this section shall be construed to limit or
9 prohibit institutions of higher education within The Oklahoma State
10 System of Higher Education, including any agency of the executive
11 branch supporting those institutions' work, from applying for a
12 grant or complying with the accreditation requirements of an
13 accrediting or licensing agency including, but not limited to,
14 submitting to the grantor or accreditation agency a statement that:

15 1. Highlights the institution's or agency's work in supporting:

- 16 a. first-generation college students,
- 17 b. students from low-income families,
- 18 c. students with unique abilities, or
- 19 d. underserved student populations; or

20 2. Certifies compliance with applicable anti-discrimination
21 laws, rules, and regulations.

22 D. The provisions of this section shall not be construed to
23 apply to institutions of higher education within The Oklahoma State
24 System of Higher Education with respect to:

1 1. A policy, practice, procedure, program, class, or activity
2 required for compliance with state or federal laws, rules, or
3 regulations for obtaining or retaining institutional, academic, or
4 discipline-specific accreditation or licensure;

5 2. The academic freedom of any individual faculty member to
6 direct the instruction within his or her own course;

7 3. Scholarly research or creative work by an institution of
8 higher education's students, faculty, or other research personnel or
9 the dissemination of such research or work;

10 4. An activity of a student organization registered with or
11 recognized by an institution of higher education;

12 5. Guest speakers or performances on short-term engagements;

13 6. Academic support, tutoring, and career services and student
14 success centers, so long as the programming is designed and
15 implemented without regard to race, sex, color, national origin, or
16 ethnicity;

17 7. Data collection; or

18 8. Access programs for military, veterans, Pell Grant
19 recipients, first-generation college students, students from low-
20 income families, students with unique abilities, or underserved
21 student populations.

22 E. By July 1, 2026, and each July 1 thereafter, institutions of
23 higher education within The Oklahoma State System of Higher
24 Education shall electronically submit to the Governor, the President

1 Pro Tempore of the Senate, and the Speaker of the House of
2 Representatives a certificate of compliance with the provisions of
3 this section.

4 F. Nothing in this section shall be construed to prohibit the
5 promotion of civil discourse, debate, or speech that is protected by
6 the First Amendment to the United States Constitution.

7 G. The Oklahoma State Regents for Higher Education may
8 promulgate rules to implement the provisions of this section.

9 SECTION 2. This act shall become effective July 1, 2025.

10 SECTION 3. It being immediately necessary for the preservation
11 of the public peace, health, or safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
