BILL NO. 837 By: Jech, Hicks, Goodwin, and  
Nice of the Senate

An Act relating to special license plates; amending 47 O.S. 2021, Section 1135.5, as last amended by Section 1, Chapter 88, O.S.L. 2024 (47 O.S. Supp. 2024, Section 1135.5), which relates to the issuance of special license plates; updating statutory language; modifying certain special license plates; repealing 47 O.S. 2021, Section 1104.13, which relates to the Oklahoma Zoological Society Revolving Fund; and providing an effective date.

SECTION 1. AMENDATORY 47 O.S. 2021, Section 1135.5, as last amended by Section 1, Chapter 88, O.S.L. 2024 (47 O.S. Supp. 2024, Section 1135.5), is amended to read as follows:

Section 1135.5. A. Service Oklahoma is hereby authorized to design and issue appropriate official special license plates to persons wishing to demonstrate support and provide financial assistance as provided by this section.

1 Special license plates shall not be transferred to any other  
2 person but shall be removed from the vehicle upon transfer of  
3 ownership and retained. The special license plate may then be used  
4 on another vehicle but only after such other vehicle has been  
5 registered for the current year with a licensed operator.

6 Special license plates shall be renewed each year by Service  
7 Oklahoma or a licensed operator, unless authorized by Service  
8 Oklahoma to be renewed for a period greater than one (1) year.  
9 Service Oklahoma shall notify by mail all persons issued special  
10 license plates. The notice shall contain all necessary information  
11 and shall contain instructions for the renewal procedure upon  
12 presentation to a licensed operator or Service Oklahoma. The  
13 license plates shall be issued on a staggered system.

14 Service Oklahoma is hereby directed to develop and implement a  
15 system whereby licensed operators are permitted to accept  
16 applications for special license plates authorized under this  
17 section. The licensed operator shall confirm the applicant's  
18 eligibility, if applicable, collect and deposit any amount  
19 specifically authorized by law, accept and process the necessary  
20 information directly into such system and generate a receipt  
21 accordingly. For performance of these duties, licensed operators  
22 shall retain the fee provided in Section 1141.1 of this title for  
23 registration of a motor vehicle through June 30, 2025. Through June  
24 30, 2025, the licensed operator fees for acceptance of applications

1 and renewals shall be paid out of the Service Oklahoma Reimbursement  
2 Fund. Beginning July 1, 2023, fees shall be retained by the  
3 licensed operator pursuant to subsection E of Section 1141.1 of this  
4 title.

5 If fewer than one hundred of any type of special license plates  
6 authorized prior to January 1, 2004, are issued prior to January 1,  
7 2006, Service Oklahoma shall discontinue issuance and renewal of  
8 that type of special license plate. Any such authorized special  
9 license plate registrant shall be allowed to display the license  
10 plate upon the designated vehicle until the registration expiration  
11 date. After such time the expired special license plate shall be  
12 removed from the vehicle.

13 For special license plates authorized on or after July 1, 2004,  
14 no special license plates shall be developed or issued by Service  
15 Oklahoma until Service Oklahoma receives one hundred prepaid  
16 applications therefor. The prepaid applications must be received by  
17 Service Oklahoma within one hundred eighty (180) days of the  
18 effective date of the authorization or the authority to issue shall  
19 be null and void. In the event one hundred prepaid applications are  
20 not received by Service Oklahoma within such prescribed time period  
21 any payment so received shall be refunded accordingly.

22 B. The special license plates provided by this section are as  
23 follows:  
24

1        1. University or College Supporter License Plate - such plates  
2 shall be designed and issued to any person wishing to demonstrate  
3 support to any state-supported or private university or college. As  
4 provided in this section, an amount of the fee collected shall be  
5 apportioned as provided in Section 1104.1 of this title;

6        2. Environmental Awareness License Plate - such plates shall be  
7 designed, subject to the criteria to be presented to Service  
8 Oklahoma by the Department of Environmental Quality in consultation  
9 with the Oklahoma Arts Council, and issued to any person wishing to  
10 demonstrate support to implement the statewide general public  
11 Environmental Education Program created pursuant to the provisions  
12 of the Oklahoma Environmental Quality Code. Such plates shall be  
13 designed and issued to any person in any combination of numbers and  
14 letters from one to a maximum of seven, as for personalized license  
15 plates. A dealer's license plate issued pursuant to Section 1116.1  
16 or 1128 of this title may be designated an Environmental Awareness  
17 License Plate upon payment of the fee imposed by this section and  
18 any other registration fees required by the Oklahoma Vehicle License  
19 and Registration Act. As provided in this section, an amount of the  
20 fee collected shall be apportioned pursuant to Section 1104.2 of  
21 this title;

22        3. Firefighter License Plate - such plates shall be designed  
23 for any career or retired firefighter, volunteer or paid.  
24 Firefighters may apply for firefighter plates for up to four

1 vehicles with a rated capacity of one (1) ton or less or for a  
2 motorcycle upon proof of a fire department membership by either an  
3 identification card or letter from the chief of the fire department.  
4 Retirees who are eligible for such plates shall provide proof of  
5 eligibility upon initial application, but shall not be required to  
6 provide proof of eligibility annually. The surviving spouse of any  
7 deceased firefighter, if the spouse has not since remarried, may  
8 apply for a firefighter license plate for one vehicle with a rated  
9 carrying capacity of one (1) ton or less or for a motorcycle upon  
10 proof that the deceased firefighter was a member of a fire  
11 department by either an identification card or letter from the chief  
12 of the fire department. The license plate shall be designed in  
13 consultation with the Oklahoma State Firefighters Association.

14 As provided in this section, an amount of the fee collected  
15 shall be deposited to the Oklahoma State Firemen's Museum Building &  
16 Memorial Fund for support of the Oklahoma State Firefighters Museum  
17 and the Oklahoma Fallen and Living Firefighters Memorial;

18 4. Wildlife Conservation License Plate - such plates shall be  
19 designed, subject to the criteria to be presented to Service  
20 Oklahoma by the Department of Wildlife Conservation in consultation  
21 with the Oklahoma Arts Council, and issued to any person wishing to  
22 demonstrate support for wildlife conservation in this state through  
23 the Wildlife Diversity Fund, provided for in Section 3-310 of Title  
24

1 29 of the Oklahoma Statutes. Such plates may be designed and issued  
2 to any person as for personalized license plates.

3 As provided in this section, an amount of the fee collected  
4 shall be apportioned pursuant to subsection D of Section 3-310 of  
5 Title 29 of the Oklahoma Statutes;

6 5. Child Abuse Prevention License Plate - such plates shall be  
7 designed, subject to the criteria to be presented to Service  
8 Oklahoma by the Office of Child Abuse Prevention in the State  
9 Department of Health and the Child Abuse Prevention Action  
10 Committee, and issued to any person wishing to demonstrate support  
11 for the prevention of child abuse.

12 As provided in this section, an amount of the fee collected  
13 shall be deposited in the Child Abuse Prevention Fund;

14 6. United States Olympic and Paralympic Committee Supporter  
15 License Plate - such plates shall be designed and issued to any  
16 person wishing to demonstrate support for the United States Olympic  
17 and Paralympic Committee. The plates shall be issued to any person  
18 in any combination of numbers and letters from one to a maximum of  
19 seven, as for personalized license plates. The plate shall contain  
20 the official United States Olympic and Paralympic Committee logo.  
21 Service Oklahoma shall be authorized, if necessary, to enter into a  
22 licensing agreement with the United States Olympic and Paralympic  
23 Committee for any licensing fees which may be required in order to  
24 use the United States Olympic and Paralympic Committee logo or

1 design. The licensing agreement shall provide for a payment of not  
2 more than Twenty-five Dollars (\$25.00) for each license plate  
3 issued;

4 7. Oklahoma History License Plate - such plates shall be  
5 designed and issued to any person wishing to demonstrate interest in  
6 Oklahoma history. As provided in this section, an amount of the fee  
7 collected shall be deposited to the Oklahoma Historical Society  
8 Revolving Fund to be used for educational purposes;

9 8. Historic Route 66 License Plate - such:

- 10 a. vehicle plates shall be designed to honor historic  
11 Route 66, also known as the "Mother Road". As  
12 provided in this section, an amount of the fee  
13 collected for each vehicle license plate shall be  
14 apportioned to the Oklahoma Historical Society  
15 Revolving Fund to be distributed to the Oklahoma Route  
16 66 Museum located in Clinton, Oklahoma, and
- 17 b. motorcycle plates shall be designed in consultation  
18 with the Oklahoma Route 66 Association, Inc. Service  
19 Oklahoma shall be authorized to enter into a licensing  
20 agreement with the Oklahoma Route 66 Association,  
21 Inc., for any licensing fees which may be required in  
22 order to use the Oklahoma Route 66 Association, Inc.,  
23 logo or design. The licensing agreement shall provide  
24 for a payment to the Oklahoma Route 66 Association,

1 Inc., of not more than Twenty Dollars (\$20.00) for  
2 each motorcycle license plate issued;

3 9. Heart of the Heartland License Plate - such plates shall be  
4 designed and issued to any person wishing to honor the victims of  
5 the terrorist bombing attack on the Alfred P. Murrah Federal  
6 Building in downtown Oklahoma City on April 19, 1995. As provided  
7 in this section, an amount of the fee collected shall be deposited  
8 in the Heart of the Heartland Scholarship Fund, as established in  
9 Section 2282 of Title 70 of the Oklahoma Statutes;

10 10. Emergency Medical Technician License Plate - such plates  
11 shall be designed and issued to any person who is an emergency  
12 medical technician. Such persons may apply for an emergency medical  
13 technician license plate for each vehicle with a rated carrying  
14 capacity of one (1) ton or less upon proof of an emergency medical  
15 technician's license. The license plate shall be designed in  
16 consultation with the Oklahoma Emergency Medical Technicians  
17 Association. As provided in this section, an amount of the fee  
18 collected shall be apportioned to the Emergency Medical Personnel  
19 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63  
20 of the Oklahoma Statutes;

21 11. Fight Breast Cancer License Plate - such plates shall be  
22 designed to demonstrate support for the prevention and treatment of  
23 breast cancer in this state;



1        12. Crime Victims Awareness License Plate - such plates shall  
2 be designed and issued to any person wishing to demonstrate  
3 awareness of and support for victims of crimes. The license plates  
4 shall be designed in consultation with the Crime Victims  
5 Compensation Program. As provided in this section, an amount of the  
6 fee collected shall be apportioned to the Attorney General's  
7 Revolving Fund for the Office of the Attorney General, which is  
8 hereby directed to use such funds to contract with a statewide  
9 nonprofit organization to provide services to crime victims;

10       13. Safe Kids Oklahoma License Plate - such plates shall be  
11 designed and issued to any person wishing to demonstrate support and  
12 awareness of the Safe Kids Oklahoma. The license plate shall be  
13 designed in consultation with the Oklahoma Safe Kids Association.  
14 As provided in this section, an amount of the fee collected shall be  
15 deposited in the Children's Hospital - Oklahoma Safe Kids  
16 Association Revolving Fund to be distributed to the Safe Kids  
17 Oklahoma program;

18       14. Oklahoma Four-H Club License Plate - such plates shall be  
19 designed, subject to criteria to be presented to Service Oklahoma by  
20 the Four-H Foundation, and issued to any person wishing to  
21 demonstrate support of the Oklahoma Four-H Club. Such plates may be  
22 designed and issued to any person as for personalized license  
23 plates. As provided in this section, an amount of the fee collected  
24

1 shall be apportioned to the OSU Extension Service License Plate  
2 Revolving Fund created in Section 1104.4 of this title;

3 15. Agricultural Awareness License Plate - such plates shall be  
4 designed, subject to criteria to be presented to Service Oklahoma,  
5 by the Oklahoma Department of Agriculture, Food, and Forestry in  
6 consultation with the Oklahoma Arts Council, and issued to any  
7 person wishing to demonstrate support of the Department's Ag in the  
8 Classroom Education Program. As provided in this section, an amount  
9 of the fee collected shall be apportioned as provided in Section  
10 1104.3 of this title;

11 16. Oklahoma Statehood Centennial License Plate - such plates  
12 shall be designed and issued to any person wishing to commemorate  
13 the centennial of Oklahoma's admission to statehood in 1907. The  
14 license plates shall be designed in consultation with the Oklahoma  
15 Capitol Complex and Centennial Commemoration Commission. As  
16 provided in this section, an amount of the fee collected shall be  
17 deposited in the Oklahoma Department of Commerce Revolving Fund  
18 created in Section 5012 of Title 74 of the Oklahoma Statutes;

19 17. Support Education License Plate - such plates shall be  
20 designed, subject to criteria to be presented to Service Oklahoma by  
21 the State Department of Education in consultation with the Oklahoma  
22 Arts Council, and issued to any person wishing to demonstrate  
23 support for education in this state. All licensed operators shall  
24 display a sample of the Support Education License plate in the area

1 of the business accessed by the public. Twenty-three Dollars  
2 (\$23.00) of the fee collected shall be apportioned as follows:

- 3 a. five percent (5%) shall be deposited to the Education  
4 Reform Revolving Fund,
- 5 b. five percent (5%) shall be deposited to the Oklahoma  
6 State Regents for Higher Education Revolving Fund,
- 7 c. five percent (5%) shall be deposited to the State  
8 Career-Technology Fund, and
- 9 d. eighty-five percent (85%) shall be deposited to the  
10 Retirement Benefit Fund as set forth in Section 17-108  
11 of Title 70 of the Oklahoma Statutes.

12 However, when the Retirement Benefit Fund attains a seventy  
13 percent (70%) funded ratio based on an annual actuarial valuation as  
14 required by law, the amount of the fee shall be apportioned equally  
15 pursuant to subparagraphs a, b and c of this paragraph;

16 18. Retired Oklahoma Highway Patrol Officers License Plate -  
17 such plates shall be designed and issued to any retired officer of  
18 the Oklahoma Highway Patrol. The license plate shall have the  
19 legend "Oklahoma" and shall contain, in the center of the plate, the  
20 Highway Patrol Officers patch using the same colors and pattern as  
21 used in the patch. Centered on the bottom of the license plate  
22 shall be the word "Retired". The letters "TRP" shall be used in  
23 combination with three numbers on either side of the insignia or  
24 emblem. The color of the letters and numbers shall be brown.

1 Retirees who are eligible for such plates shall provide proof of  
2 eligibility upon initial application, but shall not be required to  
3 provide proof of eligibility annually. The surviving spouse of any  
4 deceased retired officer of the Oklahoma Highway Patrol, if the  
5 spouse has not since remarried, or if remarried, the remarriage is  
6 terminated by death, divorce, or annulment, may apply for a Retired  
7 Oklahoma Highway Patrol Officers license plate. As provided in this  
8 section, an amount of the fee collected shall be deposited into the  
9 Oklahoma Law Enforcement Retirement Fund;

10 19. Boy Scouts of America Supporter License Plate - such plates  
11 shall be designed and issued to any person wishing to demonstrate  
12 support for the Boy Scouts of America. The plates shall be issued  
13 to any person in any combination of numbers and letters from one to  
14 a maximum of seven, as for personalized license plates. The plate  
15 shall contain the official Boy Scouts of America logo. Service  
16 Oklahoma shall be authorized, if necessary, to enter into a  
17 licensing agreement with the Boy Scouts of America for any licensing  
18 fees which may be required in order to use the Boy Scouts of America  
19 logo or design. The licensing agreement shall provide for a payment  
20 to the Boy Scouts of America of not more than Twenty Dollars  
21 (\$20.00) for each license plate issued;

22 20. Urban Forestry and Beautification License Plate - such  
23 plates shall be designed, subject to criteria to be presented to  
24 Service Oklahoma, by the Oklahoma Department of Agriculture, Food,

1 and Forestry in consultation with nonprofit organizations in this  
2 state that develop and operate programs to encourage urban forestry  
3 and beautification, and issued to any person wishing to demonstrate  
4 support of such programs. As provided in this section, an amount of  
5 the fee collected shall be apportioned as provided in Section 1104.5  
6 of this title;

7 21. Oklahoma State Parks Supporter License Plate - such plates  
8 shall be designed, subject to criteria to be presented to ~~Serve~~  
9 Service Oklahoma by the Oklahoma Tourism and Recreation Department,  
10 and issued to any person wishing to demonstrate support for the  
11 Oklahoma state parks system. Twenty-three Dollars (\$23.00) of the  
12 fee collected shall be deposited in the Oklahoma Tourism and  
13 Recreation Department Revolving Fund. Such money shall be  
14 designated for and may only be expended for the support of Oklahoma  
15 state parks;

16 22. Adoption Creates Families License Plate - such plates shall  
17 be issued to any person wishing to demonstrate support of pregnant  
18 women who are committed to placing their children for adoption and  
19 wishing to provide assistance to guardians, adoptive parents and  
20 other created families to assist in the adoption and placement of  
21 children in permanent, safe homes. The license plates shall be  
22 designed and final terminology delivered in consultation with the  
23 Oklahoma Adoption Coalition and the Department of Human Services.  
24 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited

1 in a revolving fund established in the State Treasury for and to be  
2 used by the Department of Human Services for the implementation of  
3 the Investing in Stronger Oklahoma Families Act specifically for  
4 created families;

5 23. Choose Life License Plate - such plates shall be designed,  
6 subject to criteria presented to Service Oklahoma, by Choose Life  
7 America, Inc., and issued to any person who wishes to demonstrate  
8 support of organizations that encourage adoption as a positive  
9 choice for women with unplanned pregnancies. As provided in this  
10 section, an amount of the fee collected shall be deposited in the  
11 Choose Life Assistance Program Revolving Fund established in Section  
12 1104.6 of this title;

13 24. Future Farmers of America License Plate - such plates shall  
14 be designed and issued to persons wishing to demonstrate support for  
15 the Oklahoma FFA Association (formerly known as Future Farmers of  
16 America). The license plates shall be designed in consultation with  
17 the Oklahoma FFA Association Board of Directors. As provided in  
18 this section, an amount of the fee collected shall be apportioned as  
19 provided in Section 1104.7 of this title;

20 25. Lions Club License Plate - such plates shall be designed  
21 and issued to persons wishing to demonstrate support for the Lions  
22 Clubs of Oklahoma. The plates shall be issued to any person in any  
23 combination of numbers and letters from one to a maximum of seven,  
24 as for personalized license plates. The license plates shall be

1 designed in consultation with the Oklahoma Lions Service Foundation  
2 and shall contain the official logo of the International Association  
3 of Lions Clubs. Service Oklahoma shall be authorized to enter into  
4 a licensing agreement with the Oklahoma Lions Service Foundation.  
5 The licensing agreement shall provide for a payment to the Oklahoma  
6 Lions Service Foundation of not more than Ten Dollars (\$10.00) for  
7 each license plate issued;

8       26. Color Oklahoma License Plate - such plates shall be  
9 designed, subject to criteria to be presented to Service Oklahoma by  
10 the Oklahoma Native Plant Society, and issued to any person wishing  
11 to demonstrate support for preserving and planting wildflowers and  
12 native plants in this state and to promote Oklahoma's wildflower  
13 heritage through education. As provided in this section, an amount  
14 of the fee collected shall be apportioned as provided in Section  
15 1104.8 of this title;

16       27. Girl Scouts of the United States of America Supporter  
17 License Plate - such plates shall be designed and issued to any  
18 person wishing to demonstrate support for the Girl Scouts of the  
19 United States of America. The plates shall be issued to any person  
20 in any combination of numbers and letters from one to a maximum of  
21 seven, as for personalized license plates. The plate shall contain  
22 the official Girl Scouts of the United States of America logo.  
23 Service Oklahoma shall be authorized, if necessary, to enter into a  
24 licensing agreement with the Girl Scouts of the United States of

1 America for any licensing fees which may be required in order to use  
2 the Girl Scouts of the United States of America logo or design. The  
3 licensing agreement shall provide for a payment to the Magic Empire  
4 Council of Girl Scouts, acting on behalf of all Oklahoma Girl Scout  
5 councils, of not more than Twenty Dollars (\$20.00) for each license  
6 plate issued;

7 28. Oklahoma City Memorial Marathon License Plate - such plates  
8 shall be designed and issued to any person wishing to demonstrate  
9 support for the Oklahoma City Memorial Marathon. The plate shall be  
10 designed in consultation with the Oklahoma City Memorial Marathon.  
11 Service Oklahoma shall be authorized to enter into a licensing  
12 agreement with the Oklahoma City Memorial Marathon for any licensing  
13 fees which may be required in order to use the Oklahoma City  
14 Memorial Marathon logo or design. The licensing agreement shall  
15 provide for a payment to the Oklahoma City Memorial Marathon of not  
16 more than Twenty Dollars (\$20.00) for each license plate issued;

17 29. Oklahoma Scenic Rivers License Plate - such plates shall be  
18 designed to demonstrate support for the Grand River Dam Authority.  
19 The plates shall be designed in consultation with the Grand River  
20 Dam Authority. Twenty-five Dollars (\$25.00) of the fee shall be  
21 apportioned to the Grand River Dam Authority;

22 30. Fight Cancer License Plate - such plates shall be designed  
23 to demonstrate support for the Oklahoma Central Cancer Registry.  
24 The plate shall contain the American Cancer Society logo. The



1 American Cancer Society logo shall be used in accordance with the  
2 American Cancer Society's branding guidelines and shall only be  
3 utilized to support the Oklahoma Central Cancer Registry. Twenty  
4 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma  
5 Central Cancer Registry Revolving Fund;

6 31. Animal Friendly License Plate - such plates shall be  
7 designed and issued to any person wishing to demonstrate support for  
8 controlling the overpopulation of dogs and cats through educational  
9 and sterilization efforts. The plates shall be designed in  
10 consultation with the Veterinary Medical Association. Twenty  
11 Dollars (\$20.00) of the fee collected shall be designated by the  
12 purchaser of the plate to be deposited in the Oklahoma Pet  
13 Overpopulation Fund created in Section 2368.13 of Title 68 of the  
14 Oklahoma Statutes or the Animal Friendly Revolving Fund created in  
15 Section 1104.10 of this title;

16 32. Patriot License Plate - such plates shall be designed in  
17 consultation with the Military Department of the State of Oklahoma  
18 and issued to any person wishing to demonstrate support for Oklahoma  
19 residents who are members of the Oklahoma National Guard and  
20 deployed on active duty. The plates shall be issued to any person  
21 in any combination of numbers and letters from one to a maximum of  
22 seven, as for personalized license plates. As provided in this  
23 section, a portion of the fee collected shall be deposited in the  
24

1 Patriot License Plate Revolving Fund created in Section 1104.11 of  
2 this title;

3 33. Global War on Terrorism License Plate - such plate shall be  
4 designed in consultation with the Military Department of the State  
5 of Oklahoma and issued to any person wishing to demonstrate support  
6 for Oklahoma residents who are members of the Armed Forces of the  
7 United States or Oklahoma National Guard that have served in the  
8 Global War on Terrorism. The plate shall be issued to any person in  
9 any combination of numbers and letters from one to a maximum of six.  
10 As provided in this section, a portion of the fee collected shall be  
11 deposited in the Oklahoma National Guard Museum Fund created in  
12 Section 235.1 of Title 44 of the Oklahoma Statutes;

13 34. Boys and Girls Clubs of America Supporter License Plate -  
14 such plates shall be designed and issued to any person wishing to  
15 demonstrate support for the Boys and Girls Clubs of America. The  
16 plates shall be issued to any person in any combination of numbers  
17 and letters from one to a maximum of seven, as for personalized  
18 license plates. The plate shall contain the official Boys and Girls  
19 Clubs of America logo. Service Oklahoma, if necessary, may enter  
20 into a licensing agreement with the Boys and Girls Clubs of America  
21 for any licensing fees which may be required in order to use the  
22 Boys and Girls Clubs of America logo or design. The licensing  
23 agreement shall provide for a payment to the Boys and Girls Clubs of  
24

1 America of not more than Twenty Dollars (\$20.00) for each license  
2 plate issued;

3 35. Oklahoma Quarter Horse License Plate - such plates shall be  
4 designed and issued to any person wishing to demonstrate support for  
5 the American Quarter Horse in this state. The plate shall be  
6 designed in consultation with the Oklahoma Quarter Horse  
7 Association. As provided in this section, a portion of the fee  
8 collected shall be deposited in the Oklahoma Quarter Horse Revolving  
9 Fund created in Section 1104.12 of this title;

10 36. Oklahoma Association for the Deaf License Plate - such  
11 plates shall be designed in consultation with the Oklahoma

20 Dollars (\$20.00) for each license plate issued.

21        C. The fee for such plates shall be Thirty-five Dollars  
22 (\$35.00) per year of renewal and shall be in addition to all other  
23 registration fees provided by the Oklahoma Vehicle License and

1 Registration Act. The fee shall be apportioned as follows through  
2 June 30, 2023:

3 1. Twenty Dollars (\$20.00) per year of renewal or any other  
4 amount as provided in this title of the fee shall be apportioned as  
5 provided or deposited in a fund as specified within the paragraph  
6 authorizing the special license plate;

7 2. Eight Dollars (\$8.00) per year of renewal of the fee shall  
8 be deposited in the Tax Commission Reimbursement Fund to be used for  
9 the administration of the Oklahoma Vehicle License and Registration  
10 Act. Beginning January 1, 2023, Eight Dollars (\$8.00) per year of  
11 renewal of the fee shall be deposited in the Service Oklahoma  
12 Reimbursement Fund to be used for the administration of the Oklahoma  
13 Vehicle License and Registration Act; and

14 3. Any remaining amounts of the fee shall be apportioned as  
15 provided in Section 1104 of this title.
