11	which relates to penalties for human trafficking; updating statutory citation; modifying scope of
12	certain defined terms; adding definition; modifying penalties; requiring registration with the Sex
13	Offenders Registration Act; directing the Department of Corrections to submit information to the Federal
14	Bureau of Investigation; providing for noncodification; and providing an effective date.

10	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. NEW LAW A new section of law not to be
19	codified in the Oklahoma Statutes reads as follows:
20	This act shall be known and may be cited as the "Oklahoma Human
21	Trafficking Law".
22	SECTION 2. AMENDATORY 21 O.S. 2021, Section 748, as
23	amended by Section 1, Chapter 20, O.S.L. 2022 (21 O.S. Supp. 2024,
24	Section 748), is amended to read as follows:

2. "Commercial sex" means any form of commercial sexual
 activity such as sexually explicit performances, prostitution,
 participation in the production of pornography, performance in a
 strip club, or exotic dancing or display;

3. "Debt bondage" means the status or condition of a debtorarising from a pledge by the debtor of his or her personal services

14 8. "Minor" means an individual under eighteen (18) years of 15 age; and

9. <u>"Pimping" means a person who procures a prostitute for a</u> customer and receives the earnings from the services provided by the prostitute; and

19 <u>10.</u> "Victim" means a person against whom a violation of any 20 provision of this section has been committed.

B. It shall be unlawful to knowingly engage in humantrafficking.

C. Any person violating the provisions of this section shall,upon conviction, be guilty of a felony punishable by imprisonment in

1 the custody of the Department of Corrections for a term of not less 2 than five (5) years or for life and not exceeding life imprisonment, or by a fine of not more than One Hundred Thousand Dollars 3 (\$100,000.00), or by both such fine and imprisonment. Any person 4 5 violating the provisions of this section where the victim of the offense is under eighteen (18) years of age at the time of the 6 offense shall, upon conviction, be guilty of a felony punishable by 7 imprisonment in the custody of the Department of Corrections for a 8 9 term of not less than fifteen (15) years or for life and not 10 exceeding ninety-nine (99) years, or by a fine of not more than Two Hundred Fifty Thousand Dollars (\$250,000.00), or by both such fine 11 12 and imprisonment. The court shall also order the defendant to pay restitution to the victim as provided in Section 991f of Title 22 of 13 the Oklahoma Statutes. If the person is convicted of human 14 trafficking, the person shall serve eighty-five percent (85%) of the 15 sentence before being eligible for parole consideration or any 16 earned credits. The terms of imprisonment specified in this 17 subsection shall not be subject to statutory provisions for 18 suspension, deferral or probation, or state correctional institution 19 earned credits accruing from and after November 1, 1989, except for 20 the achievement earned credits authorized by subsection H of Section 21 138 of Title 57 of the Oklahoma Statutes. To qualify for such 22 achievement earned credits, such inmates must also be in compliance 23

subsection D of Section 138 of Title 57 of the Oklahoma Statutes. 2 D. 1. Any person convicted of human trafficking for commercial 3 sex shall be required to register as a sex offender pursuant to the 4 5 provisions of the Sex Offenders Registration Act. 2. The Department of Corrections shall forward the name and 6 conviction information of any person convicted of human trafficking 7 to the Human Trafficking-Uniform Crime Reporting Program of the 8 9 Federal Bureau of Investigation. 10 E. It is an affirmative defense to prosecution for a criminal, youthful offender, or delinquent offense that, during the time of 11 12 the alleged commission of the offense, the defendant or alleged youthful offender or delinquent was a victim of human trafficking. 13 E. F. The consent of a victim to the activity prohibited by 14 this section shall not constitute a defense. 15 F. G. Lack of knowledge of the age of the victim shall not 16 constitute a defense to the activity prohibited by this section with 17 respect to human trafficking of a minor. 18 SECTION 3. This act shall become effective November 1, 2025. 19
