14	SECTION 1. AMENDATORY Section 1, Chapter 425, O.S.L.
15	2024 (74 O.S. Supp. 2024, Section 2294.1), is amended to read as
16	follows:
17	Section 2294.1. There is hereby created in the State Treasury a
18	revolving fund for the Oklahoma Historical Society, to be designated
19	the "Oklahoma Museum of Popular Culture Supplemental Revolving
20	Fund". The fund shall be a continuing fund, not subject to fiscal
21	year limitations, and shall consist of all monies received by the
22	Oklahoma Historical Society from appropriations of the Legislature
23	designated for deposit in this fund. All monies accruing to the
24	credit of the fund are hereby appropriated and shall be budgeted and

1 expended to provide funding for repairs, planning, staging, 2 refurbishments, and improvements to real and personal property, and funding for construction of the Oklahoma Museum of Popular Culture. 3 No expenditures shall be made from the fund until the State 4 5 Treasurer determines that funds provided by local and county governments, the federal government, or through monetary donations 6 or enforceable pledges for monetary donations in the amount of 7 Eighteen Million Dollars (\$18,000,000.00) are made for repairs, 8 9 planning, staging, refurbishments, and improvements to real and 10 personal property, and funding for construction of the Oklahoma Museum of Popular Culture; provided, no funds collected or received 11 prior to May 25, 2023 May 25, 2021, shall be counted toward the 12 amount. Expenditures from the fund shall be made upon warrants 13 issued by the State Treasurer against claims filed as prescribed by 14 law with the Director of the Office of Management and Enterprise 15 Services for approval and payment.
