SENATE BILL NO. 1441

An Act relating to critical infrastructure; amending
3 O.S. 2021, Section 322, which relates to prohibited
unmanned aircraft; imposing criminal liability for
violations; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 3 O.S. 2021, Section 322, is
amended to read as follows:

Section 322. A. As used in this section:

1. "Critical infrastructure facility" means:

- a. one of the following, if completely enclosed by a
fence or other physical barrier that is obviously
designed to exclude intruders, or if clearly marked
with a sign or signs that are posted on the property,
are reasonably likely to come to the attention of
intruders, and indicate that entry is forbidden or
flight of unmanned aircraft without site authorization
is forbidden:

- (1) a petroleum or alumina refinery,
- (2) an electrical power generating facility,
substation, switching station or electrical
control center,
- (3) a chemical, polymer or rubber manufacturing
facility,
- (4) a water intake structure, water treatment
facility, wastewater treatment plant or pump
station,
- (5) a natural gas compressor station,
- (6) a liquid natural gas terminal or storage
facility,
- (7) a telecommunications central switching office,
- (8) wireless telecommunications infrastructure,
including cell towers,
- (9) a port, railroad switching yard, trucking
terminal or other freight transportation
facility,
- (10) a gas processing plant, including a plant used in
the processing, treatment or fractionation of
natural gas or natural gas liquids,
- (11) a transmission facility used by a federally
licensed radio or television station,

1 (12) a steelmaking facility that uses an electric arc
2 furnace to make steel,

3 (13) a facility identified and regulated by the United
4 States Department of Homeland Security Chemical
5 Facility Anti-Terrorism Standards (CFATS)
6 program,

7 (14) a dam that is regulated by the state or federal
8 government, or

9 (15) a natural gas distribution utility facility,
10 including, but not limited to, pipeline
11 interconnections, a city gate or town border
12 station, metering station, aboveground piping, a
13 regulator station and a natural gas storage
14 facility, or

15 b. any aboveground portion of an oil, gas, hazardous
16 liquid or chemical pipeline that is enclosed by a
17 fence or other physical barrier that is obviously
18 designed to exclude intruders;

19 2. "Dam" means any barrier, including any appurtenant
20 structures, that is constructed for the purpose of permanently or
21 temporarily impounding water; and

22 3. "Unmanned aircraft" means an aircraft without occupants that
23 is flown by a pilot via a ground control system or autonomously
24 through use of an onboard computer and other additional equipment

1 necessary to operate the aircraft and includes unmanned aircraft
2 commonly called drones.

3 B. Except as provided in subsection C of this section, a person
4 shall not intentionally or knowingly:

5 1. Operate an unmanned aircraft over a critical infrastructure
6 facility if the unmanned aircraft is less than four hundred (400)
7 feet above ground level;

8 2. Allow an unmanned aircraft to make contact with a critical
9 infrastructure facility, including any person or object on the
10 premises of or within the facility; or

11 3. Allow an unmanned aircraft to come within a distance of a
12 critical infrastructure facility that is close enough to interfere
13 with the operations of or cause a disturbance to the facility.

14 C. This section shall not apply to conduct committed by:

15 1. The federal government, the state or a political subdivision
16 of the state;

17 2. A person under contract with or otherwise acting under the
18 direction or on behalf of the federal government, the state or a
19 political subdivision of the state;

20 3. A law enforcement agency;

21 4. A person under contract with or otherwise acting under the
22 direction or on behalf of a law enforcement agency;

23 5. An owner or operator of the critical infrastructure
24 facility;

1 6. A person under contract with or otherwise acting under the
2 direction or on behalf of an owner or operator of the critical
3 infrastructure facility;

4 7. A person who has the prior written consent of the owner or
5 operator of the critical infrastructure facility;

6 8. The owner or occupant of the property on which the critical
7 infrastructure facility is located or a person who has the prior
8 written consent of the owner or occupant of that property; or

9 9. An operator of an unmanned aircraft that is being used for a
10 commercial purpose, if the operator is authorized by the Federal
11 Aviation Administration to conduct operations over that airspace.

12 D. Any person in violation of this section shall be subject to
13 the provisions of Section 1792 of Title 21 of the Oklahoma Statutes
14 and may be civilly liable for damages to the critical infrastructure
15 facility to include, but not be limited to, damage to property, the
16 environment or human health.

17 SECTION 2. This act shall become effective November 1, 2026.
