An Act relating to fireworks; amending 68 O.S. 2021, Section 1623, which relates to conditions for storage, transportation, sale, and use; updating statutory language; removing certain requirements to sell fireworks within certain time frame; prohibiting counties from restricting certain firework display under certain circumstances; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 68 O.S. 2021, Section 1623, is amended to read as follows:

Section 1623. A. Consumer ~~Fireworks~~ fireworks may be legally stored, transported, sold, and used in this state with the exceptions and conditions specified under the provisions of Section 1621 et seq. of this title and consistent with Section 22-110 of Title 11 of the Oklahoma Statutes. Novelties may be legally stored, transported, sold, and used in this state.

B. All fireworks storage and sales areas shall be conspicuously posted with signs reading "FIREWORKS-NO SMOKING".

C. Fireworks offered for retail sale ~~must~~ shall be sold according to the National Fire Protection Association (NFPA) 1124

1 Chapter 7, 2006 Edition. Any facility licensed to sell consumer
2 fireworks prior to November 15, 2009, shall be exempt from the NFPA
3 regulations listed in this subsection but shall remain under the
4 regulation of the date of licensure. Mail-order sales to consumers
5 are prohibited through any medium of either interstate or intrastate
6 commerce. Sales of fireworks ~~may only~~ shall be made at properly
7 licensed retail locations within ~~the State of Oklahoma~~ this state.
8 A sales clerk ~~must~~ shall be on duty to serve the consumer at the
9 time of purchase.

10 D. An enclosed building used for sale of fireworks to the
11 public shall be built according to the International Building Code
12 (IBC) 2006 Edition ~~and/or~~ or the codes and standards adopted by the
13 Oklahoma Uniform Building Code Commission.

14 E. The retail license holder shall be responsible for the safe
15 operation of retail sales to the public. The retail license holder
16 shall be at least sixteen (16) years of age.

17 F. Fireworks may be sold by licensed manufacturers,
18 distributors, or wholesalers at wholesale or retail and by retailers
19 to residents and nonresidents of the state ~~from January 1 until~~
20 ~~December 31 of each calendar year. Fireworks may only be sold by~~
21 ~~licensed retailers from June 15 until July 6 or the first Sunday~~
22 ~~after July 4th, whichever is later, and from December 15 until~~
23 ~~January 2 to residents and nonresidents of the state each calendar~~
24 ~~year.~~

1 G. Nothing in Section 1621 et seq. of this title shall be
2 construed to require the State Fire Marshal to inspect or cause to
3 be inspected portable retail fireworks stands, tents, or other
4 nonrigid shelters prior to opening; provided, the provisions of this
5 subsection shall not prohibit the local governing authority of the
6 location of the portable retail fireworks stand, tent, or other
7 nonrigid shelter from inspecting such stands, tents, or other
8 nonrigid shelters prior to opening.

9 H. No county shall prohibit a private outdoor firework display
10 for a noncommercial purpose, provided that:

11 1. Such display is located on private property; and

12 2. No county burn ban is in effect as provided for in Section
13 16-26 of Title 2 of the Oklahoma Statutes.

14 SECTION 2. This act shall become effective November 1, 2026.
