"Community eligibility provision" means the federal provision created pursuant to 42 U.S.C., Section 1759a that allows school districts to choose to receive federal special assistance

- 2. "Identified student percentage" means the percentage of a school district's enrollment that is certified eligible for free meals based on a documentation of benefit of receipt or categorical eligibility as provided for in 7 C.F.R., Section 245.6.
- C. Beginning with the 2027-2028 school year, school districts with an identified student percentage of forty percent (40%) or higher that opt in to the community eligibility provision of the National School Lunch Program and demonstrate financial need shall be eligible to receive state child nutrition funds for:
- 1. One hundred percent (100%) reimbursement per meal served in a school district with an enrollment of two thousand (2,000) or fewer students;
- 2. Ninety percent (90%) reimbursement per meal served in a school district with an enrollment of more than two thousand (2,000) students but fewer than ten thousand (10,000) students; and
- 3. Eighty percent (80%) reimbursement per meal served in a school district with an enrollment of ten thousand (10,000) or more students.
- D. By July 1, 2028, and by July 1 every three (3) years thereafter, the State Department of Education, in collaboration with an institution of higher education within The Oklahoma State System
