AS INTRODUCED

An Act relating to crimes and punishments; amending Section 10, Chapter 366, O.S.L. 2024, as amended by Section 4, Chapter 187, O.S.L. 2025 (21 O.S. Supp. 2025, Section 20J), which relates to Class B5 offenses; adding certain offenses; amending Section 14, Chapter 366, O.S.L. 2024 (21 O.S. Supp. 2025, Section 20N), which relates to Class D1 offenses; removing certain offense; amending 21 O.S. 2021, Section 1171, as amended by Section 403, Chapter 486, O.S.L. 2025 (21 O.S. Supp. 2025, Section 1171), which relates to peeping toms; creating felony offenses for certain second or subsequent offenses; reclassifying certain felony offense; amending 57 O.S. 2021, Section 582, as amended by Section 14, Chapter 151, O.S.L. 2024 (57 O.S. Supp. 2025, Section 582), which relates to the Sex Offenders Registration Act; adding offenses for which certain registration applies; conforming language; updating statutory language and references; repealing 57 O.S. 2021, Section 582, as amended by Section 41, Chapter 59, O.S.L. 2024 (57 O.S. Supp. 2025, Section 582), which relates to the Sex Offenders Registration Act; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

4 Statutes. The provisions of the Sex Offenders Registration Act
5 shall not apply to any such person while the person is incarcerated
6 in a maximum or medium correctional institution of the Department of
7 Corrections.
